Here is our response:

- Below is a summary of capital invested in Juan de Fuca Provincial Park from fiscal year 10/11 to March 31, 2019.
- A total of \$1.350 million was invested over the last nine years primarily for trail upgrades.
- Approximately 80% of the total was allocated to higher use trails/areas in the park such as Mystic, Sombrio and Botanical Beaches.
- Some money was also spent on required water system upgrades at China Beach campground.
- In addition to the capital investments shown below, BC Parks also invests operating dollars each year to conduct routine maintenance work and trail repairs.
