Here is our response:

- Koppers Ashcroft Inc. holds an *Environmental Management* Act permit that was issued
 February 16, 1987, authorizing air discharges from a creosote wood treatment facility
 located close to 1425 Evans Road, Ashcroft, BC.
- The permit has been amended over the years and most recently, in April 2017 the ministry issued a minor permit amendment to authorize the addition of natural gas heaters on 2 existing creosote tanks. A copy of the most current permit is available online at: https://www2.gov.bc.ca/gov/content/environment/waste-management/waste-discharge-authorization/search-status-and-documents (search for authorization # 7248).
- The most recent ministry site inspection occurred on June 27, 2017 where additional works were found onsite that were not included in the permit. An advisory letter was issued and the permittee was directed to submit an application for a further amendment to address the changes.
- An application to amend the permit was submitted October 4, 2017 and the file is currently under review by Ministry staff on the South Authorizations Team in the Regional Operations Branch.
- Of note regarding the permit:
 - o Any cutting and trimming is limited to untreated wood so that emissions from the cyclone will not include treated wood.
 - o There are no authorized discharges in the permit for liquid waste/effluent. If someone observes an effluent discharge from the site, or has other specific concerns which they believe to be violations of the permit, these can be reported to the ministry by email to: EnvironmentalCompliance@gov.bc.ca. This mailbox is reviewed regularly by ministry Compliance Staff.

Here's our response to your below email:

- BC Parks encourages families living with accessibility challenges to experience BC Parks.
- A frontcountry camping fee exemption is available to adults receiving Person with Disabilities benefits and children on the 'At Home' program. This initiative removes some financial barriers families living with disabilities face and creates variety of opportunities, while not unlimited, across the province.
- BC Parks is working with a variety of accessibility foundations to create inclusive designs for new campsites planned in a number of high use areas throughout the province. Completion of these new facilities is expected over the next four years.
- The maximum 14 day camping restriction is established in regulation and applies to every camper.
- While some regulations allow employees and Park Operators of BC Parks' to make exceptions —
 it would be for truly exceptional circumstances only. Unfortunately the circumstances
 described would not be considered exceptional and we are unable to exempt them from the
 long stay requirements.
- Having a maximum stay policy is necessary to manage usage and to ensure that all residents get fair and equal opportunity to experience BC Parks. Were it not in place, some campers would occupy more popular campsites for the entire summer, or indefinitely.
- As a public resource, BC Parks works to ensure a greater number of campers have access to our campsites in many locations.

We have been fortunate that Camping fees have been taken care of for many years, but this year it became a bit of a bother.

There is a limit of 14 days per park per year!.

Which i get....BUT, due to my daughters diversabilties, we can not access ALL parks! and are (not limited to) but more like restricted to ceratain parks because of certain accessibilty issues!.

We love to enjoy the water, that's why places like Kokanne Creek, McDonald creek are such excellent choices for us. Here Our daughter can enjoy the water and beach along side us, with not much stress on s 22 and myself.

Places like Blanket Creek and Lost Ledges(although very beautiful....and Blanket being one of favorite) she cannot access the water front or beach because of NON access to the lake front.

Blanket has a beautiful lagoon for swimming, but it is not the place to throw your kayak in the water...same for the sites on the north end of Kootenay Lake and we want our daughter to enjoy the freedom of gliding along the water right along side us, not sitting at the campsiteby herself...because she cannot access the water.

This leads to us having to spend more days at places like Kokanee creek...but being limited to this place is very unfair.!

This day limit roadblock came to the forefront this summer.

We booked at Kokanee creek, like usual. Received reservation confirmation, BUT upon arrival were told that we had hit the 14 day limit, but the reservation made no such reference.

Management at Kokanee was very helpful in allowing us to stay, but this was after much debate. Making me / us feel a bit criminal.

We were able to stay past the 14 day limit....as long as we paid? which I did!

My issue is not with having to pay (which I don't think I should have had to.....we have had disability access for many many years) **MY issue is that the 14 day limit does not FIT certain disabilities!** Any help or info you could provide would be very helpful.

We typically camp upwards to 30-40 days per summer, and hope to increase that as we find MORE parks that fit.

Thanks so much for your inquiry and here's our response:

- Issues around shooting ranges is an active topic looked at by the Ministry.
- The RCMP Chief Firearms Officer issues approvals to firearms shooting ranges under the Shooting Club and Shooting Ranges Regulation (which is under the Federal Firearms Act); shooting ranges are subject to requirements in the regulation and approvals.
 - o The regulation and approvals impose requirements for public safety
 - o There are a few exceptions where firearms shooting ranges are not subject to the regulation and approvals, such as training facilities that are not used by members of the public.
- The Province does not issue permits for shooting ranges to impose public safety requirements (this is handled by the Federal Government).
- Municipal by-laws would apply including those regarding land use and noise.
- The Ministry of Environment and Climate Change Strategy becomes involved in overseeing measures to address contamination from an operating firearms shooting range when there is evidence that contamination is migrating off of the range property, and/or high risk environmental conditions exist on the site.
- For closed firearms shooting ranges, where there is a proposed change in land use, the
 Ministry would be involved in the review and sign off of applications for Certificates of
 Compliance or other legal instruments sought under the Contaminated Sites Regulation to
 allow the new land use to occur.
- The Ministry has no evidence or data to suggest that pollution is occurring.
- The Ministry would be very interested in any specific samples. If you have data to show pollution is occurring, such as water samples analysed from an accredited lab, ministry technical staff would be happy to look at it. Dear Lisa Beare MLA,

I am contacting you at the suggestion of the Pitt Meadows Councillors. We have an urgent land use and environmental issue before council regarding our local Pitt Meadows Gun Club. After 20 years of co-existing amicably, the relationship with the neighbourhood had deteriorated due to changes in operations at the gun club. After being a private members club for 76 years, shooting twice a week, Sunday afternoons and Wednesday evenings for limited hours, the club decided to open to the public and extend shooting to include every day in addition to inviting movie shooting etc. This has greatly interrupted the peaceful existence of the neighbourhood and has led to further action from the neighbours. Upon investigation by the neighbours, it was brought to light that this club has been operating without a municipal or federal permit for 76 years. Upon further investigation this club has contaminated two large parcels of farmland using lead shot without any remediation to date. The local BMX Track/Cottonwood Park/Our Outdoor School at Barnes Rds 22

was previously a 30 year gun club before being moved to the next property over where they have been for 46 years. Both parcels of land that the gun club has and is using is surrounded on all four sides with our active waterways used to irrigated local farms and leads out to fish bearing rivers. In addition to the 300,000 lbs. of lead on this land leaching into the land and water, the club cannot comply with the local noise by law or the safe shooting distances in the discharge of a firearms by law.

My husban(\$.22 and I are lifetime residents of the Ridge Meadows area and have been farming in Pitt Meadows since 1987. We grow cut flowers a \$.22

s.22 . Other neighbours in the area offer eco-tourism as well. s.22 s.22 . These farms

are using the water from the surrounding waterways. We need to have some regulations surrounding this gun club and the remediation of the lead as it is a known health hazard and falls into our hazardous waste classification. Lead cannot be transported in greater than 5 kg. amounts without a permit. With 300,000 lbs. of it that close by, and two parcels of land contaminated, we need the province to get involved and ensure public safety. We have had an unusual amount of sickness in the neighbourhood and are asking for the province to aid in a safe solution for this area. This matter has been before council on many occasions regarding by laws and the our local council is working with us to reach a safe solution that will aid all parties involved. The club is currently shut down pending safety compliance. (Please view The City of Pitt Meadows Meeting December 5, 2017 Video for Questions and Comments at the opening of the meeting and Agenda Item L 2.3 for an update and current status of the Pitt Meadows Gun Club) The City of Pitt Meadows are not environmental stewards and will require your help at the provincial level regarding the lead

management. One of the mentioned sites above is being used as a local park, BMX Track and Outdoor School for SD 42 and has had no lead remediation to date after 30 years as a shooting range. I question the safety of this park and the children living and playing on the site. We are aware of the Burnaby Gun Club's clean up requirements and fear this could be worse as it has been in use longer and is surrounded by water and is in a flood plain below sea level. (I have attached the provinces newsletter on the Burnaby site above for your information.) Our concern as residents in the area is the safety of our families, our land and the farming proceeds we are sending out into the community. We need to know our fruit and vegetables are safe for consumption and the long term effects of this lead being on this land and leaching into the water without remediation. I do not think this site is suitable for a shooting range and if a permit was being applied for presently it would not be considered as a possibility. Shooting with lead has been banned for migratory birds in the wild since 1999 and we need to make out range shooters responsible for lead management as well. Please respond to our concerns and help us with direction to address this environmental issue. We need to know how to proceed and who we can contact at the provincial level to open an enquiry and ensure a responsible plan is put in place for lead management in this fragile eco system. Once again thanks so much for your email. Here is the response from our Ministry:

- In response to public complaints of odour and pollution, ministry compliance staff conducted three inspections of the facility in 2017, all of which found the company non-compliant with requirements under the Environmental Management Act (EMA) and the Organic Matter Recycling Regulation (OMRR).
- The company was issued two warning letters but failed to come into compliance.
- Following the latest inspection in December, the matter was turned over to the Conservation Officer Service and remains under investigation.

Dear Greg and Reamick,

I am addressing this to both of you as I am unsure of who might be able to assist. I am not certain which Ministry has a role here given the range of issues and will appreciate your guidance.

I have been hearing from residents of the Summerfield area in my riding \$.22

which is just down the street from the Border Feedlot. There have been ongoing complaints about foul odours, alleged illegal dumping, and water contamination.

The odour issues are reportedly so strong that individuals have reported symptoms of burning eyes, nausea, hives, infections and congestion.

There have now been repeated report from residents about possible illegal dumping, as trucks frequent the lot between the hours of 11:30pm and 5:30am.

There are additional concerns of water contamination/quality in the nearby creek.

I have spoken with the City of Surrey, who maintain that the Border Feedlot is a normal farming operation.

What I am hoping is that either of the Ministry of Environment or the Ministry of Agriculture or both, might be able to provide some background on the issue. I would assume that one or both Ministries have had correspondence regarding this issue and will have conducted any necessary site visits or tests to ensure both that the Border Feedlot is operating within its approved purposes and that no

environmental/public health issues are present.

I look forward to your assistance in providing assurances to my constituents that their concerns have been properly investigated by the appropriate authority.

Dear Andrew,

Thanks so much for your email. Here is the messaging you can use in response to your constituent:

- There are no current plans to further restrict Roundup (glyphosate) use.
- In general, glyphosate use for landscaping purposes is minimal and is limited to maintenance of hard surfaces and crack and crevice treatment.
- In 2017, Health Canada's Pest Management Regulatory Agency (PMRA) reconfirmed registration for pesticides containing glyphosate and stated "products containing glyphosate do not present risks of concern to human health or the environment when used according to the revised label directions."
- In 2011, a Special Committee on Cosmetic Pesticides was formed to conduct broad consultation on the issue of cosmetic pesticide use. The recommendations of the Committee included restrictions on the use of cosmetic pesticides, but not an outright ban.
- In 2015, government amended the Integrated Pest Management Regulation to address cosmetic use concerns, which took into account the Special Committee recommendations and extensive public consultation.
- The amendments restricted the use of pesticides on landscaped areas of private land so that in general, everyone who applies pesticides for these uses must be certified or complete specific training. Commercial class pesticides are restricted to licensees, and a pesticide licence is required for commercial properties and service providers. A Residential Applicator Certificate is required for residents to apply domestic pesticides to their own property.
- The amendments improved public interaction with pesticide vendors at the point of sale by
 requiring that most pesticides be displayed in a manner that restricts customer access. Prior
 to purchase, a certified dispenser must discuss the intended use of the pesticide with the
 customer to confirm it is appropriate.
- Cosmetic pesticide restrictions apply only to uses on outdoor landscaped areas (such as lawns, ornamental flowers and trees, and pathways). This does not include food gardens, hobby farms, structural pests, forests, or agriculture.
- Municipal pesticide bylaws still apply, and may be more restrictive than provincial regulations.
- At present, ministry staff are fully engaged with completing implementation of the amendments to restrict cosmetic use of pesticides in landscapes, with continued communication and education for interested stakeholders, and updating of guidance documents and training materials to reflect the new regulations.
