**Request**

We heard that Garibaldi at Squamish (GAS) is asking for a timeline extension to meet certain conditions of the EAO certificate.

1. You noted the EAO hasn't made a decision yet. When will a decision be expected to come down?

There are no legislated timelines for Environmental Assessment Certificate (EAC) amendment considerations. Garibaldi at Squamish, Inc.'s certificate, EAC TD#16-01, requires the company to meet the intent of the time bound conditions within 3 years of the date that the EAC was issued, which was on January 26, 2016. The EAO's intention is to have a decision made prior to January 26, 2019.

2. If the EAO doesn't grant the timeline extension requested — and if GAS fails to meet the conditions by the deadline indicated — will that nullify the EAO certificate?

If that were to occur, the EAC is not nullified; however Garibaldi at Squamish, Inc. would be out of compliance with the requirements of its EAC. The EAO's Compliance and Enforcement team would then step in and consider next steps for an appropriate course of action.

3. Will that mean they will have to reapply for another EAO certificate?

No.

4. We heard the SLRD has provided feedback to the EAO, saying they don't approve of extending the deadlines. How much weight does that have in the decision?

The EAO requested comments on the extension to the time bound conditions from a number of key organizations with an interest in the project, and our office will consider all responses that we receive.

I'm doing a follow-up story to the recent dog ban in Grouse Mountain in Vancouver for CBC Radio and looking at the general trends to ban dogs from parks across B.C. - like Joffre Lakes earlier this year, for example.

I'm hoping to talk to some from the province about how dogs, and other pets, can impact B.C.'s parks and the reasons behind not letting dogs in certain areas.

I'd also ask about what trails and parks are good dog-friendly alternatives, and how pet owners can better look after their dogs on the trails.

<!--[if !supportLists]-->• <!--[endif]-->Joffre lakes Provincial Park has seen a huge increase in visitor use in recent years. We have also seen a proportional increase in dog visits.

<!--[if !supportLists]-->• <!--[endif]-->With increased dog use, there is increased dog waste. Unfortunately some park users do not clean up after their dogs and this waste ends up in the water system. Some dog owners allow their dogs to swim in the lakes, when this happens it becomes a health issue as the lakes are used as the drinking water source for area campers.

<!--[if !supportLists]-->• <!--[endif]-->Additionally, dogs on and off leash have an impact on surrounding wildlife. For instance, dogs can adversely affect bird nesting and can be disruptive to local Pikas (small mammal) forcing them to change their behaviour and seek a different habitat.

<!--[if !supportLists]-->• <!--[endif]-->The policy related to domestic pets not being allowed in Joffre Lakes is being finalized, with a plan to implement ahead of the busy summer season.

year round. The public will be advised of the effective date of this policy through the BC Parks, Joffre Lakes Provincial Park page, and through social media.

**Request**

We are researching a possible story about the incorrect location in apps and digital maps for certain mountain trails and locations on the North Shore...and how this can present a hazard for the public.

We'd like to speak with a ranger to find out what their experience with this has been?

**Recommendation**

- Public safety within park boundaries is paramount to BC Parks.
- Those wishing to explore back country areas within BC Parks should be fully prepared and familiar with this type of activity, and stay within the limits of their skill level.
- It is recommended that anyone visiting back country areas have knowledge related to avoiding interaction with wildlife, overnight preparedness, and experience with navigation including familiarizing with, or printing, park maps. For more on visitor safety, please visit our website @ <http://www.env.gov.bc.ca/bcparks/explore/safety/>
- BC Parks recommends that visitors use park maps available for download (found on all specific park web pages) when exploring our parks.
- Park users may be using 3<sup>rd</sup> party maps via web and mobile applications within the parks however it is not recommended due to lack of connectivity in many front and back country parks and incorrect location and identification information found within the applications themselves.
- After Action Reviews are undertaken between SAR and BC Parks staff at the conclusion of search and rescues within BC Parks boundaries.
