In the past week the bear we moved out of Canmore at the end of July has made a loop around Mt. Pauline in BC (~50km north of McBride), then traveled north along the AB/BC border back to the area she was released at and at 15:00. was **s.16,s.18** in the Wilmore.

She has traveled about 150km since last Saturday and has not gotten any closer to human habitation than when she was ~50 km north of McBride, BC.

I'll keep you posted on where she is and if she is heading towards any settlements. Because of the bear's level of habituation and our concern for public safety, our plan in Alberta was to lethally remove her if she came within 20 k of a settlement. We will be supportive if BC followed that same direction, and will be supportive of whatever course you all decide to take (except move her back ☺). Hopefully she'll sort it out.

Hi Paul,

I understand 148 is fitted with a collar. Is it possible for us to be put on the email distribution list with the updates on where 148 is travelling to/from. When working in the Hinton District a few years ago, we arranged with Nathan Webb to do this for a few bears that were translocated into the area and it really helped us properly manage our park resources, and to see when certain bears were moving to areas of higher human use and we could at least get out and do some proactive education with park users on keeping clean sites etc. to minimize further conflicts with these bears that had a history of comfort around humans. Doing so would allow us to keep BC in the loop as well with her movements so they could do the same.

Hi Shelley,

As of this morning the collar on Bear 4688 appears to be located s.22 NE of McBride. It has been here since 4 pm yesterday. At this point I think it is safe to assume that Bear 4688 is no longer alive, but will leave it with you whether you would like to investigate further. However, based the collar's current location and the large distance that it travelled in a relatively short period of time, my thoughts are that Bear 4688 was shot some time yesterday morning north of the Fraser River and west of West Twin Protected Area, and that the carcass was then transported by vehicle to its current location.

Guide and hunter knew that the bear was collared prior to harvest.

Guide has been in contact with Alberta F&W regarding the collars return (info on collar) The COS retrieved the collar and the collar information has been passed onto Alberta F&W to confirm that collar frequency is for Grizzly Bear 148. Alberta F&W biologist Brett Boukall confirmed that this is the same bear.

Boukall has passed this information up through his channels to the Premier's office in Alberta with all of the background and tracking of this bear.

Alberta would like to bring this to the attention of the Alberta media prior to BC releasing anything, said Boukall.
