I believe Kenn McLaren has spoken to Lisa about the importance of rescheduling a meeting with Ministers Donaldson and Heyman that was first scheduled for March 14 then cancelled, then rescheduled for April 18 and again cancelled.

Both times Stó:lo Chief Angie Bailey, St'át'imc Chief Michelle Edwards, and Okanagan Nation Alliance Chief Chad Eneas were set to be at this meeting with a specially made gift to present to each minister. The meeting cancellations have created an awkward and unfortunate situation. Like my colleagues and I at the Coast to Cascades Grizzly Bear Initiative, our First Nations allies are very keen to see this meeting finally go ahead.

We are in discussions with Tom Ethier and Jennifer Psyllakis regarding simple but urgent measures required to ensure that two critically endangered grizzly bear populations do not decline further while the province undertakes the broader grizzly bear management plan.

We would like to have a similar opportunity to brief Minister Donaldson and point out the positive opportunities around this work. As we wrote the Minister this week, we think the recent successful Upper Lillooet Access Management process that he signed off on is a great example of the kinds of collaborative measures government can undertake with ENGO and First Nations partners.

The first three weeks of October would be good timing for Coast to Cascades and our First Nations Partners and I believe that largely coincides with the legislature being in session. We recognize that this file sits primarily with Minister Donaldson, but Ideally the meeting could still be scheduled so both he and Minister Heyman can attend as that was the intent the first two attempts.

I will be way until August 12 and I look forward to your response when I return.
