On January 10, 2019, BC Parks is announcing the initiation of a management planning process for Windermere Lake Provincial Park, which is located south of Invermere, in your

constituency. The management plan that is developed will replace the Windermere Lake Purpose Statement and Zoning Plan, approved in March 2003. There will be a 30-day public input and comment period to inform the development of the draft plan.

For this management planning project, BC Parks will be engaging with Shuswap Indian Band and the Ktunaxa Nation Council to ensure the local First Nations communities have opportunities to bring forward their interests and concerns to help inform Windermere Lake Park's strategic direction. Additionally, the Niskonlith Indian Band will be contacted to determine the Nation's desired level of engagement in the management planning process. BC Parks will develop a draft management plan for public review and comment. The draft management plan will then be revised as needed, prior to releasing the final approved management plan.

This management planning process is a part of regular BC Parks business. Management planning projects are currently in progress for over 50 protected areas throughout the province. Management plans are the key tool used to guide decisions on appropriate recreational activities, facility development and the conservation of natural and cultural resources in protected areas. This includes applying management zones to outline appropriate activities and facilities. Management plans are always developed with the involvement of First Nations, local governments, the public and other interest groups.
