Venables Lake is a much needed water source for the Venables Valley community, it is necessary for their farming irrigation as well as fire safety. It is the main component of their Wildfire Protection Plan as it is the only mayor body of water in the area.

In 2018 the Venables Lake dam required restoration as it was no longer in compliance with government regulations. There was no funding available from FLNRO or the Ministry of Environment to assist the residents with the cost of these improvements and so families within the community incurred the substantial cost themselves. Being a spiritual/religious organization the community does not have saved funds.

We have been advised that the Ministry of Environment is requesting a geotechnical survey of the dam to determine its safety and suitability prior to the full pool storage of water. Would you kindly confirm that this information is correct? Dear Linda and Colleen.

Firstly thank you Colleen for your time a few weeks ago when I dropped in to the Constituency office to discuss this issue.

I write to ask whether your office is able to assist with controlling the damage being done in the Willowbrook area at the above address.

The new owner, Mr. Doug Cotter, took possession of the property in the Fall of 2017. He is the owner of a hazardous waste disposal and demolition company in Penticton \$.22 s.22

s.22

I have approached the BC Conservation Officer Service on a number of occasions through the RAPP line and provided photos of the dumping activities.

I have also discussed this with the RDOS who have redirected me back to the RAPP line. Despite many calls and discussions with the RDOS and the Conservation officers by a number of people in the area, Mr. Cotter has continued to truck in large quantities of demolition waste

material as per the attached photos. There have been up to 3 truckloads per day on occasions. The waste material is being dumped and buried in multiple areas where fill is clearly not required and construction is highly unlikely to occur subsequently. The waste has included non-inert materials such as painted wood, Gyproc, sawdust and grape pressings. The majority of the concrete and steel waste has been dumped into a gully which is a waterway in the spring for about 4 to 5 months each year. Further down the waterway in an area where there are wetlands he has now excavated 2 large ponds (as per the attached photos). I was informed by one of the visiting conservation officers that he required permission to do this and that it had not been obtained.

Mr. Cotter also raised the earth wall of a small illegal dam on the property and due to concerns that this would potentially breach and add to the flooding in Sportsman's Bowl he was ordered by Mr. Mike Noseworthy to place pipes in the wall and lower the level of the water. I understand that Mr. Cotter is expected to have the Dam compliant by the end of this year.

I am aware that M. Cotter may import inert material to use as fill. However the multiple dumps on the property and their locations make it clear that he is simply using the property to dump significant volumes of waste that should otherwise have been taken to a designated dumping area.

As all of the interventions to date do not seem to have stopped Mr. Cotter's dumping I would appreciate the assistance of your office in trying to achieve a reasonable outcome in this case. Thank you,

- Staff participated in a Cobble Hill Aquifer Interagency Task Group meeting, January 29, 2019
  (CVRD staff, ENV, FLNR and HLTH representatives present). ENV regional staff had some
  additional updates with respect to Fisher Road Recycling compliance related correspondence
  and actions.
- The two most recent compliance Inspection Reports for Central Landscape Supplies Ltd at 1345 Fisher Road resulted in:
  - IR99424 Order recommended; Oct 02, 2018
  - IR53083 Warning Letter issued; June 28, 2017
- A Pollution Prevention Order (PPO) was issued to Central Landscape Supplies Ltd on Nov 15, 2018. The company retained Madrone Environmental as their Qualified Professional to assess current impermeable surface condition in advance of the required February 2, 2019 deadline.
   An inspection will occur in early February at this site on compliance with both the PPO and with their registration under the Organic Matter Recycling Regulation (OMRR). In that same timeframe, ENV staff will inspect Fisher Road Recycling for compliance with their OMRR registration.
- Central Landscape Supplies Ltd.'s OMRR registration requires they put in place a leachate management plan. The draft plan they submitted to ENV was deemed insufficient so staff is working with them to advise on what is required.
- Central Landscape Supplies Ltd has greatly reduced production as a result of losing a big contract
- Central Landscape Supplies Ltd has moved all compost onto the impermeable surface
- Storage, receiving areas continue to be not impermeable (Work to be completed by July 2, 2019)
- The Cowichan Valley Regional District continues to be involved and is working with compliance staff. FLNR continues to participate with the Task Group, and support actions to reduce potential groundwater quality impacts from land activities in the Fisher Road area.

- The BC Government is aware of the potential health effects of wood smoke. For that reason the government is working on ways to reduce exposure to wood smoke through regulation, replacement of old high polluting stoves, and education on better burning practices.
- The provincial woodstove exchange program provides a cash incentive for area residents to change out their old inefficient woodstoves for new cleaner burning 'emissions certified' stoves, or for alternative forms of heating. It also contains an educational component to help area residents learn how to operate their wood-burning appliances cleaner (see: <a href="https://www2.gov.bc.ca/gov/content/environment/air-land-water/air/air-pollution/smoke-burning/exchange">https://www2.gov.bc.ca/gov/content/environment/air-land-water/air/air-pollution/smoke-burning/exchange</a>).
- The BC regulation pertaining to wood heating appliances is the Solid Fuel Burning
  Domestic Appliance Regulation. This regulation limits the sale of wood appliances in
  BC to cleaner, lower emitting models. However, this regulation does not regulate how
  a wood stove is operated by individual stove owners.
- Local governments have the power to establish bylaws within their boundaries that are more restrictive than provincial regulations. A growing number of municipalities and regional districts in BC have passed their own bylaws to improve air quality by: regulating which types of wood burning appliances may be installed, banning the installation of new wood-burning appliances in new construction, restricting the use of wood-burning appliances, regulating the creation of thick smoke, and restricting the fuels that are burnt in wood-burning appliances. A Ministry report "2015 Inventory of Air Quality Bylaws in British Columbia"

Here's our response:

- Over the past two decades, most parks and protected areas involving Crown lands have been established as a result of land use planning processes. In addition, some high priority private lands have been acquired for inclusion in parks by the Ministry of Environment and Climate Change Strategy, primarily through collaborative efforts with partners such as the Nature Conservancy of Canada and the Nature Trust of British Columbia.
- In 2018, the B.C. government committed \$16 million over three years to work collaboratively with First Nations to modernize land use planning, with stakeholder and public input. Modernized land use planning is intended to advance reconciliation efforts, promote economic opportunities through increased certainty for land management, respond to changing social and environmental conditions, and increase public trust and confidence in the stewardship of B.C.'s natural resources. New land use plans will be initiated in selected areas of the province.
