Dear Minister Donaldson, Minister Heyman and Minister Simons
(cc Premier Horgan)

We have an issue here on the lower Sunshine Coast that needs your immediate attention.

The Ministry of Forests says: "Resource management and use are expected to continue during modernized land use planning, including forest development ..."

'Forest development' means LOGGING. Several blocks targeted for upcoming logging on the lower Sunshine Coast contain sections of old growth forests. At this time in our lives we should be protecting these forests for our children and future generations so that they can enjoy the sheer majesty of 1000+ years of growing a tree can create. We should also be protecting other species at risk within these forests and valuable wildlife habitat.

Here on the lower Sunshine Coast, development, usually preceded by logging is rampant, with total disregard for the impacts on the environment including old growth forests, watersheds and other environmental impacts.

We must now be cognizant of what our logged trees are used for and if logging is necessary. For example see:

as easily be used to create the same product i.e. toilet paper. It is time to stop the mass destruction of Canadian forests in the name of “economic growth” and preserve what we have for the health and well-being of our children, our province and our planet. It is time to reboot and consider other easily renewable resources instead of using the few remaining sections of old growth or extremely old trees for the fulfilling human's insatiable desire for everything from toilet paper to McMansions.

The province has agreed to undertake an Elphinstone Land Use Plan with the shíshálh Nation and the SCRD. This could take years during which time logging should not be proceeding. The contentious forest blocks here on the Sunshine Coast are the very ones that the province, through BC Timber Sales, are targeting for logging before planning has even begun!

The SCRD (our local governing body) supports protection of these 3 blocks, here's why you should as well:

Clack Creek Gallery Forest (A93884)

- Provides critical connectivity for an expanded Mt. Elphinstone Park
- Mature, natural forest providing same functions as pure old-growth
- Contains largest patch in BC of the blue-listed, endangered native plant *Rubus Nivalis* (snow raspberry)

Reed Rd Forest Reserve (DL 1313, A91376)

- Nearest walkable natural forest to Gibsons
- Protection of downslope properties from soil erosion and washouts
- Rare forest type that could transition to highly endangered Coastal Douglas-Fir ecosystem due to warming climate

Dakota Bowl Bear Sanctuary (A87126)

- Contains some of Canada's oldest trees – 1,000 to 1,800 years old
- Registered Heritage Sites containing culturally modified trees
- Likely the last forest containing a high number of black bear den sites on the Sunshine Coast

Additionally, in 2018 the Forest Practices Board made recommendations concerning better management of At-risk plant communities on the Sunshine Coast for government and BC Timber Sales to consider. Government responded by accepting all of the recommendations. This will lead to wider protection of endangered red and blue listed plant communities that are found in all three blocks. By accepting the Board's recommendations, government will be proceeding to make them legal

objectives. **The rush to approve these blocks for logging is therefore premature** and compromises an ethical stance Professional Registered Foresters are bound to uphold.

Please assure me that you'll do everything in your powers to make sure that these blocks do not get listed for sale and the above processes are respected. Consider the long term impacts not the immediate money in someone's pocket.
