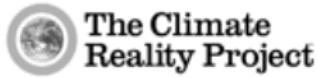

I have a small group of knowledgeable individuals who would like to meet with Minister Heyman to discuss how we may satisfactorily resolve the Tetrahedron Provincial Park issue triggered by a request from the Sunshine Coast Regional District to amend the park boundary or change the park's Class A status. We believe there are other ways to address this apparent conundrum.

We would like to meet with the minister **in his Vancouver constituency office** sometime *between the last week of August and the end of the first week of September*.

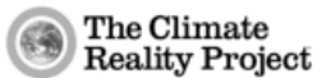
