

Questions regarding benchmarking and emissions allocation:

Thanks for reaching out to us and for explaining your products. Based on the complexity of allocating emissions to different product streams as you have described, we can consider having raw cane sugar as the product to be benchmarked against. Benchmarks, as well as emission factors, are still in development.

We would like to extend an invitation to attend an online presentation of CleanBC and the Industrial Incentive Program. Please let us know if you would be interested to hear more about the program and we can arrange a time that works for all of us.

# Question regarding heat and steam:

Yes, it does include all steam produced (high, med, low pressure). Yes, we are using it interchangeably and have noted this discrepancy for CIIP's application process for next year.

## Question about the Statement of certification tab:

Yes, the transition year is the 2018 reporting year, 2019 program year. Because the application is being received in 2019, that is the default year for each application received.




