I enclose for your consideration draft 6 (penultimate) of our proposed presentation for the P & A on Feb 13th, in relation to finalizing LNG Canada arrangements.

This has been a joint undertaking among staff of the Ministries of Finance; Energy, Mines and Petroleum Resources (EMPR); and Environment & Climate Change Strategy, with ongoing advice of Ministry of Attorney General counsel.

Yesterday, our multi-agency team briefed the Minister of Finance, and this draft reflects feedback we received.

We have undertaken with Cabinet Operations, to try to have the Ministers of Environment and EMPR at the P and A meeting.

These ministers, along with the Minister of Finance, are intended to be signatories to the Operating Performance Payments Agreement with LNG Canada, owing to their

individual statutory and program responsibilities covered in the Agreement. We anticipate (and are planning) that the Operating Performance Payments Agreement will be executed by the Province and LNG Canada before Budget day, so as to be ready for release in support of tabling necessary legislative changes in this coming session. s.12;s.13

Our plan is to receive input from deputies today and then to submit to Cabinet Operations by close of business today, in order to meet the agenda for the Feb 13^{th} P & A meeting.
