See below response with respect to professional reliance:

- Based upon the information provided about the nature of the development it appears to fall
 within local government or possibly provincial government decision-making frameworks. Each
 decision-making framework may rely upon information provided by suitably qualified
 professionals.
- Under the current statutes governing Biologists, there are expectations that qualified professionals operate within their specific areas of expertise.
- In the instance of Biology, there is currently no requirement that all biological expertise/advice
 provided to a development must be from a registered professional biologist. However, a member
 of the College of Applied Biology (designated R.P.Bio.) should conduct themselves in accordance
 with the College's code of ethics and is required to fulfill ongoing professional development in
 their area of expertise.
- Some inconsistencies were identified in the Independent Professional Reliance Review Report (released in May 2018) related to professionals practicing in the natural resources sector. For example, how the professions are governed, conduct and discipline procedures, and defined areas of practice for the various professions.
- The community group is encouraged to request information about the qualifications of the professionals providing advice to the local government or developer. Should there be a question

- of the professional operating outside their defined area of practice, the community group could contact the appropriate professional regulatory body (i.e. if a biologist contact the College of Applied Biology).
- In the future, the *Professional Governance Act* will address inconsistencies amongst professions and provide improved standards to ensure professionals in BC are operating in the public interest.
- It is unclear if the author of the preliminary environmental assessment report for the land development proposal in question is registered with a professional association. If environmental impact assessment practices are included in a defined scope of practice that receives practice rights, then professionals carrying out those activities would be required to be registered with a regulatory body and be subject to the competency and quality standards of that regulatory body, including codes of ethics that incorporate ethical principles prescribed in the *Professional Governance Act*.

The following are details about the Professional Governance Act:

- The *Professional Governance Act* (PGA) received Royal Assent on November 27, 2018 and will come into force through regulations over the coming years. Several provisions in the PGA (once in force) could potentially influence professional reliance for environmental impact assessments, including:
 - The granting of practice rights to the College of Applied Biology, BC Institute of Agrologists, and Applied Science Technicians and Technologists of BC.
 - Requirements for registered professionals to declare competency and any conflicts of interest for work undertaken, subject to PGA regulations.
 - The ability for ministers responsible for a relevant enactment (e.g. could include *Riparian Areas Regulation Act*) to require professionals undertaking work to be part of a roster, which could ensure independence between the professional and the developer.
 - Enabling regulatory bodies to regulate firms which could include holding firms accountable to quality management standards and codes of ethics. Firms could include consulting companies and municipalities that employ professionals (exemptions to a broad definition of firms can be made through regulation).
 - A duty for all professionals, and in some cases other persons, such as employers of
 professionals, to report on any professional governed under the PGA when they have
 reasonable and probable grounds to believe that significant harm to the environment
 or public could occur. Protections for those who report are provided in the PGA with
 the whistleblower provisions.

Dear Tristan and Reamick,

Our constituency office has been contacted by a community group (BNA) that has raised concerns that are relevant to both your ministries, and we would appreciate your advice in how to proceed with this matter. It relates to a concern regarding environmentally sensitive land, and a developer's proposal to develop that land (22 acres). 4 acres of the land is owned by the City as park/open space and the other 18 acres is privately owned, and the developer is asking for a landswap with the City to make it workable. However, up til now, both pieces of this land parcel have been considered inappropriate for development because of a great number of factors. Some of these relate to water and salmon/trout bearing streams, some relate to agricultural/urban interface, some relate to the fact the land is on a flood plain, contains a swamp and peat bog, is a wildlife and bird corridor, and is low-lying requiring 6 – 8 feet of fill to mitigate the flood risk, and so on.

The community members have come to us with concerns about the normal process, in which the developer is responsible to get the necessary environmental assessments, which is an inherent conflict due to their business interest in wanting to develop the land. According to the group, the assessments currently available through FOI seem to be less than robust.

We are trying to determine a process by which the Ministry could send someone out to have a look at this parcel of land. Can a biologist employed by the Ministry come and look at this land? Is there a mechanism for independent review that is outside of the inherent conflict of interest faced by developers? Is this a service you provide? (We understand this would need to happen in the late spring, summer or early fall, not now)

While we recognize the need for communities to address housing supply, this creates a vulnerability that a pro-development municipality might make some irreversible mistakes if projects are approved that really don't meet appropriate environmental standards. Any advice you can supply would be greatly appreciated.

Background:

- On August 23rd, the BC Supreme Court ruled against a petition from the Tsilhqot'in National Government to stop exploratory drilling authorized by a July 2017 permit from the BC Government.
- On September 4th, a statutory decision maker in FLNRO issued an Occupant Licence to Cut to Taseko, as legally required under the Mineral Tenures Act.
- Taseko has commenced assessment, survey and layout work to prepare for exploratory drilling, but no work yet involving mechanical disturbances.
- Tsilhqot'in National Government has sought leave to appeal the BC Supreme Court ruling and will be seeking an injunction. They have also established a gathering and harvesting camp in the path of proposed clearing work and reiterated calls to establish Dasiqox Tribal Park to protect the area.
- In a Sept. 6, 2018 letter to government, TNG requested B.C. use a power under s. 17 of the *Mineral Tenure Act* to protect and preserve Teztan Biny (Fish Lake), Yanah Biny (Little Fish Lake) and Nabas (the surrounding area).
- The Federal Government has twice rejected mine proposals from Taseko for the site. Taseko lost an attempt to overturn the second rejection in the Federal Court of Appeal.

The Peninsula News Review published an article on March 29 about the BC Home Renovation Rebate and Efficiency BC Program. The program provides incentives for installing: insulation, heat pumps, water heaters, natural gas furnaces or boilers, and windows. However to qualify for the rebates, all renovations must be conducted by a licensed contractor with a valid BC business license. While I can understand the need to have a licensed contractor perform some of these installations (e.g. natural gas furnaces, heat pumps) I do not understand why homeowners cannot be allowed to install their own insulation or windows to qualify for the rebates.

If the rebate program is really designed to encourage energy reduction then I think it is unfair that homeowners are prohibited from doing their own installations. Who is to say that a licenced contractor can perform the work any better than a particular homeowner? We all have examples of licensed contractors who have performed very shoddy work. That is not to say that all contractors fall into this category, but by the same token, some homeowners are more than qualified to do their own upgrades. Is this program really about energy reduction or is it designed to stimulate work by private contractors?

Eligibility to qualify for rebates under the BC Home Renovation Rebate and Efficiency BC Program should be increased.

Background to Elkford Slash burning

- -Slash piles were in a Category B area. The piles were lit on January 4th. On January 4th 2019 the venting index was Good and Good for the following day. On January 5th the index was Poor and Poor for the next day. The venting index remained unfavourable (Poor/Fair) for the remaining 96hrs from January 5th to January 9th.
- The last complaint the COS received was filed to RAPP on January 8th 2019, this supports the less than 96 hour burn period. At this time we are unable to determine the exact duration of the burns or if they did surpass the 96 hour period or if the smoke released was from more than 5% of the debris that was initially ignited.
- NRO Mike TYLER inspected the site on January 12th 2019, 8 days after the ignition date and found the burn piles to be out and cold. NRO TYLER observed the piles to be under snow and not fully burnt and may have smoldered rather then burnt hot. The piles consisted of woody debris only.
- The contractor (Tangle Foot Contracting) in charge of burning the piles stated to NRO

TYLER that no debris was added to the piles.

Response to specific questions:

What happens to the complaints that were made to the RAPP line (online and telephone)? If they are related to Conservation Officer Service (COS) mandate they are referred to the appropriate COS office for action if not related to our mandate they are referred to the FLNRO Natural Resource Officers (NRO) for their actioning.

The Regional Director, COS Okanagan spoke with the RAPP line and is aware that numerous complaints had been received from Elkford residents. A Facebook post was made encouraging all residents to call the RAPP line.

Who investigates the RAPP line complaints?

Depending on whose mandate it is it could be COS or NROs from FLNRO

Who did the burning?

A logging company

What was the consequence to the company that did the burning?

No consequences as they started the burning when they were authorized to do so

What happens if they burn again?

Depends when and where they are burning and whose mandate it is to ensure compliance

Did the company have to put the fire out?

Not sure, as it was referred to the NRO's of FLNRO

The smoke suggests it was left smoldering:

Best to ask NRO's of FLNRO as to outcome

Does any public notice need to be given to the residents prior to burning?

Not legally, but most tell nearby residents do out of courtesy.

Sorry this has taken so long, but here is the response from staff.

It was an NRO that responded to the complaint, not a CO. COS was not involved. The NRO inspected, did not find any non-compliance. no further action is planned.

"NRO VATERS did do an inspection (100006) dated Sep 1, 2018. NRO VATERS informed me he spoke to the individual who indicated he got the firewood from private land (there was large area of private land in the area being harvested). NRO VATERS educated him about the process to sell fire wood from Crown land (ie a FLTC). It seems the complainant is largely concerned about the individual having a firewood business in the neighbourhood. I think that could be a municipal zoning issue. At any rate, Kevin did inspect and did not find any urgent non-compliance at the time."



In light of the forest fire that occurred next to the property a few weeks ago, our concerns over the fire hazards presented by placing an industry of this scale in our tinder dry rural community are an additional issue that we would like to raise with the relevant decision makers. - COS received a letter from District of Port Edward (February 15, 2019) related to an incident of a pet being killed by a predator, they responded on March 18th, 2019.
- The COS letter provided clarification of officer response to particular occurrence and addressed the ongoing issue of predator presence within Prince Rupert and Port Edward. See attachment PDF for your MLA's reference.
- When COS attended Prince Rupert and Port Edward they noted a large feral cat presence, unsecured attractants such as garbage, fish offal, and unsecured pet food; all of which contribute to predator presence.
- Individual who has made current complaint has feral cat presence in area that is likely contributing to wolf/predator presence
- Of note there have been no reports of wolf sightings in the area to RAPP line in over one month

Action to be taken:

- COS will provide District of Port Edward response letter to MLA for reference and provide further clarification on the ongoing issue
- COS has extended invitation to meet with officials to discuss ongoing issues.

The Regional District of Nanaimo (RDN) and City of Nanaimo (CON) are best placed to respond to this issue as:

- The Ministry of Environment and Climate Change Strategy (ENV) has received no complaints regarding odours from this site
- This type of industrial activity does not normally result in waste discharges to the environment thus does not require a specific authorization from ENV
- Land use (zoning) and unsightliness are bylaw issues and the responsibility of the CON
- The operators hold a Waste Stream Management License issued by the RDN; the RDN has advised that they are amending the license to strengthen the regulatory provisions directed at improving site operations
- The operator is working cooperatively with both the CON and RDN to improve operations
- Because this is a commercial/industrial activity grandfathered in a residential neighborhood, the RDN reports that there is a high likelihood of ongoing land use conflict and complaints
- Should activities have the potential for offsite impact (e.g. contaminated water runoff), the Ministry of Environment and Climate Change Strategy will assist the local government agencies

As you are aware, Emterra is authorized to process recyclable material at this location. Operation of these types of facilities is not typical of what is expected in a residential neighborhood and, commonly, these types of facilities are located in commercial or industrial areas. Although we are in the process of strengthening our Waste Stream License requirements around materials storage, it is unlikely that we can achieve your desired outcome of having all material stored inside or offsite.

Still, based on recent inspections, we have seen a concerted effort by Emterra to clean up the site. Our plan is to carry out another inspection next week and I do appreciate you sharing your most recent observations. In this regard, do you have an idea of the length of time the bales in your picture have been stockpiled in the yard?

As I advised previously, once we have established the Waste Stream License requirements, I would be pleased to share those with you.

BC Marine Trails (BCMT), an umbrella association representing 12 paddling clubs, and hundreds of individual, family and business members, would like to begin a dialogue with all coastal MLAs including yourself to gain support for the Inside

Passage Marine Trail (IPMT), a paddling route that would link the BC coast and its coastal communities as part of a world-class ecotourism initiative. It is remarkable that, historically, paddling is the oldest form of coastal travel, and yet to date no official route nor designation of necessary safe havens has taken place.

BCMT believes the trail will benefit your constituents in the following ways:

- It will ensure safety and continuity of marine trail systems for coastal paddlers and other small boat users, thereby reducing risks and saving lives.
- It will help resolve recreational use of unceded Indigenous traditional lands by establishing amicable protocols with coastal First Nations.
- It will help preserve Indigenous and cultural heritage sites that might otherwise be
 used recreationally by undertaking site assessments and ensuring only appropriate
 sites are included within the marine trail system.
- It will provide an avenue for remote coastal communities to realize economic benefits through service provisions and incorporation of existing or planned cultural tourism and ecotourism programs.
- It will provide a mechanism for site assessment, design and management to ensure environmental suitability and sustainability of coastal recreation.

Other benefits and action plans are itemized in the draft discussion paper.

To proceed, BCMT is asking for the following:

- High-level provincial approval of the Inside Passage Marine Trail concept to ensure regional arms of involved ministries recognize and are working towards the IPMT mandate.
- Incorporation of the BCMT Marine Trail Safety Mandate (attached) and the IPMT concept as integral to the BC Parks' forthcoming marine strategy.
- Funding to address the need for First Nations engagement and the necessary archaeological studies to meet a mandate for reconciliation.
- Funding for the BCMT to undertake the necessary site assessments and community/stakeholder consultations as well as to cover the general administration costs to see this project through to completion.

It is worth noting that despite these costs, this trail could likely be created for less than the cost of a kilometre of British Columbia highway.

Please let us know at your earliest convenience if you require more information, a presentation or any form of get-together so we can begin working on a cooperative strategy to see this ambitious project completed.

Here's our response:

- The Province, in collaboration with the Vancouver Fraser Port Authority (VFPA) and TransLink have launched the Clean Trucking pilot to make alternative fuel drayage trucks available to companies and drivers operating at the Port of Vancouver.
- The Clean Trucking pilot supports strategies set out in the CleanBC Strategy released in December 2018, by providing the latest in clean trucks and fuels for truck drivers to trial.
- When the pilot program begins in 2019, the Clean Trucking Initiative will make commercially-viable trucks and low emission fuels available for short-term trials.

Overview of pilot project:

Due to increasing cargo volumes year after year, the VFPA, terminal operators, rail lines and other supply chain participants/players are continuously working to improve the efficiency and operation of container shipping in the Vancouver Gateway.

As such, the VFPA is proposing a new initiative to explore advances in alternative energy source trucks and technology with the participation of container trucking community and the terminals, giving companies and drivers an opportunity to trial commercially-ready vehicle options. The VFPA is proactively exploring these new technologies and the associated infrastructure needs, to support the evolution of the industry and the future of the gateway.

To promote proactive thinking about alternative energy truck use, the adoption of sustainable energy sources, the future infrastructure requirements needed for the industry's continued growth and the increasing efficiency of operations, the VFPA in collaboration with the Province and TransLink will be conducting pilot projects beginning in 2019.

This will provide real world opportunities for drivers and companies to trial alternative energy trucks, without financial risk, and experience the direct operational and financial benefits first hand.

During the pilot, drivers will have the opportunity to trial Class-8 on-road trucks and yard trucks which run on lower-emission energy sources/drivetrains, and to provide feedback on their experiences. This feedback will be used to further educate the market and guide further initiatives around what new fueling/charging infrastructure is needed to support the evolution of the container trucking industry.

Part of the reason this is so complicated is, from what we understand, the owner holds around 18 separate properties under 18 different numbered companies (all conjoined into a large section of land). From what we understand a company named Tiara is the actual holder of all properties.

Also because the majority of parcels are land, there might not be official addresses for the properties, everything that we have received has noted parcel or lot numbers. I have attached a document below that was worked on extensively by local residents, pages 14, 19, 38-40 contain photos of the land division and lot/parcel numbers of the area. The issue spans multiple properties as there are issues with the owner blocking pubic access to trails and water access (both of which span across multiple lots/properties) Pages 1-2 outline the basic concerns, page 14-15 contains both a map with notes on which roads/trails are being blocked and what the concerns are listing specific Lot #'s. Pages 56-57 under section 12 lists "Environmentally Destructive Activity by Landowner" and there is mention of a specific incident that was apparently reported to the Ministry of Environment

I hope this is helpful, we recognize that this is a complicated case and we appreciate your help!

I am reaching out regarding a meeting that MLA Doug Routley and myself had with a group of citizens pertaining to concerns in the Boat Harbour area (located near Nanaimo). The concerns are rather extensive, appear to cross multiple ministries, and there is a long history of conflict in the area between the landowner/Developer and the local residents which has recently been escalating.

In the meeting we were presented with a over 200 pages of documents, many pertaining to the history of the public access trails and water access in the area (that can be dated back into the early 1900's) which the landowner has now blocked with cement barricades, fencing, guard dogs, in person guards and extensive camera surveillance. In one area there appears to be fencing entering in a riparian protected pond- pictures can be found here \$.22 \$.22

We had asked the group to condense the information into a summary, which you will see attached to this email. Because the issues are wide ranging the first step we are taking is to contact some of the Ministries to see if they have had any contact with the residents/landowner and if there are previous or current open files or investigations in that area pertaining to any of the concerns outlined in the attached document. Please advise if there is anything that our office should know as we proceed to assist the residents address the concerns.

I attach a further summary requested by MLA Routley – please advise of any requested changes/actions.

The environmental and by-law violations discussed 15 March haven't stopped despite complaints to the Area A Regional Director and RDN.

Following is a view on landowner acquisition and development strategy (not in summary attached) – how landowner defeats RDN /provincial review or control.

- Tiara and related companies/ its principals and predominantly foreign investors (<u>landowner</u>) continue prime waterfront land acquisitions including those containing the SE Roads [defined in summary].
- The end-goal is likely a complete-controlled private gated community of 350 + acreas including historic and public roads and waterfront. Landowner enjoys huge profit with full land and water control.
- Landowner cuts through protected forest and environments that it plans to acquire, or has acquiried by transfers are pending – with no Forestry, Lands, Rural Development, Transportation Ministries or RDN enforcement consequence.
- Landowner files a consolidated New Reference plan survey (such as EPP9986)
 obfuscation of lands that have just been developed or cut through with (next stage)
 title transfer of adjacent upland lots such as recently acquired Parcel A (critical to
 Marina access). The transfer of (eq) parcel E is likely pending registration.
- While the land title office has all registrations in pending mode for 6 weeks, property ownership transfers aren't visible. <u>Landowner orders construction activity to happen</u> <u>quickly regardless of OCP Designation and Zoning bylaw infractions.</u>
- Concurrently landowner road-cuts through and fences to the 'Next- Up' parcel acquisition which is currently on land title documents still titled as Townline's, waterfront East Flewett Point Lot A (parcel 024-830-186). (Prime waterfront adjacent to Boat Harbour lands.) This is where last week's 'latest road- cut extension' joins through to the historic Pylades Dr old straight through flat wide trail/road to the Harbour disregarding public highways per Green Mines Map in summary.
- Landowner erects temporary fence on Parcel E from upland eastern end of Hewstone

Rd down the steep embankment blocking access to the SE corner of new Plan EPP9986, disregarding pond setback regulations. It turns the fence sharply angled northward at the pond along the Eastern edge of Plan EPP9986 towards the harbour. That fence apparently follows recently acquired property along the Range 5 to 6 boundary.

- Landowner owns it all, has no permits, but does all quickly before getting a mini slap on the wrist when all is constructed. "Too late to do anything about" is likely the local enforcement response probably. Landowner knows it.
- So landowner illegally clear-cuts road late 2018 southeast onto property it didn't own up to the Range 5-6 boundary of former owner lands beyond which, it will acquire in December 2018. While new Parcel acquisitions are executed and in a pending registration state by the land title office, landowner clear-cuts the remaining desired road extension on a weekend early March before the nesting season, from the north-south EPP9986 Plan Range 5-6 boundary into the property 'Next -Up' to buy from Townline, ie Flewett Point East (Lot A Parcel 024-830-186). That lot 3 of the prior (3-lot Townline Subdivision) adjoins Pylades Drive to the south. It throws a fence blockade across the new acquisition (Parcel E). Landowner quickly completes clearing the 'Next-Up' roadway extension shown below boundary fenceline (per photos), carved into the next parcel acquisition.
- The roadworks quickly constructed are not on any official plan, just on a nonregistered private landowner (Tiara) survey.
- The landowner might offer the RDN cash in lieu of public access to Roads and
 waterfront. Acceptance by the RDN/province would be intolerable for several
 reasons, including that it would solidify landowner's total control and public exclusion
 from critical historic Roads, waterfront and ocewan of extreme detriment to the
 community, other users and tourism. No compensation would be adequate.

We speculate that Tiara has one more Townline lot to acquire (Lot 2 Parcel 027-534-294) to control all properties surrounding Boat Harbour. Tiara /landowner would then ultimately own nearly 350 acres from Hemer Park through to Boat Harbour and adjoining waterfront to Pylades Drive. It would then consolidate all 22 numbered company parcels into one giant plan and apply for an OCP Designation 'Amendment' to give those properties Comprehensive Development (CD) status. All existing OCP Designations and Zoning By-Laws (WA, RE RU) that it is already flouting would become non-relevant. That single consolidated owner could then develop anything within that CD designation.

We look forward to next actions. s 22

Subject: Upland landfill

Hi Mary,

The Upland landfill is currently recognized in the approved Comox Strathcona Solid Waste Management Plan (SMWP) and authorized to operate under a permit that was issued in 1992. A pre-application to update the landfill was submitted by Upland on February 5, 2015 for a new Operational Certificate (OC) that would upgrade the landfill in order to satisfy current Ministry of Environment standards.

Upland's application proposes to upgrade their facility to an engineered, (double) lined landfill with leachate collection and treatment, leak detection systems, a monitoring program and provision of financial security.

For the past two and a half years Upland has been working with its Qualified Professionals (QPs) to conduct the necessary assessments and complete stakeholder consultations to provide information for the OC application. A final application package has been received by the Ministry of Environment and a review phase of the application process is underway. The package has been reviewed by a number of qualified professionals from within and outside of government, including those hired by Upland, the Campbell River Environment Committee, the City of Campbell River, and ministry staff.

Decisions on OCs are made by Ministry of Environment staff designated as Statutory Decision Makers (SDMs). Any new OC would only be issued once and if sufficient technical assessments are completed to confirm that the proposed activities do not pose a risk of pollution to the surrounding environment or downstream water users, and following stakeholder input.

Ministry of Environment has recently provided notice under the Public Notification Regulation of a pending decision, and a draft Operational Certificate has been shared for public input

Hi Adam and Elizabeth,

As of this week it will officially be 2 years since our daughter woke to inform us that our water tasted and smelled like the glue the dentist uses on her braces. It has been since then that we have had no access to healthy water for our household due to hydrocarbon contamination in our well. Two years of hauling water from off site or simply seeking services elsewhere in order to flush our toilet, take a shower, do the dishes or wash our clothes. Simple things but not so simple. Needless to say we are truly reaching the end of our rope. This experience is physically, emotionally and financially exhausting. Once again we are asking for your help in seeing our situation move toward a fair resolution with the involved regulatory bodies.

Since we last spoke at the Town Hall Meeting there have been some new developments we would like to update you on. Please see the attachments provided from our lawyer and qualified environmental expert (QEP) addressed to the MOE. These give additional scientific evidence and context to the MOE's contention that the contamination is more "reasonably" the result of a single point local impact in the immediate vicinity of our drilled well rather than an off site source.

- On October 23rd, 2018 Peter Reid of Hemmera Envirochem Inc invited all bureaucracies involved (MOE,CRD, VIHA, Islands
 Trust and FLNR) to shadow test the surface soils and surface groundwater around our drilled wells. Soil samples were taken
 from both inside the well head and from an excavated test pit adjacent to the well head. Water samples were also taken from
 the shallow wells close to our drilled well. In all samples no hydrocarbons were found. These findings are contrary to the
 MOE's theory.
- The MOE assertion further states that the movement of LANPL through bedrock would have seen our test results showing
 weathered vs undegraded gasoline if from an off site source. But this is untrue as can be found contained within BC's
 Fractured Bedrock Guide. The author of the MOE expert report, James Plett, is recently from California where LANPL moves
 through the bedrock differently from BC.

It is still the conclusion of our Environmental Expert that we are off site affected parties and that there are many reasons to believe there have been releases from **\$.22** affecting our water. Other than the above stated, Peter Reid points to:

- the dip and strike of the land which gives geological evidence that the bedrock fractures would allow for the contaminants to migrate from across the road to our drilled wells
- on our affected properties there exists no pathway/access for the contamination to reach the DEEP bedrock but the existence of an old mining tunnel at **s.22** where the protective overburden has been removed, provides a delivery system for the contaminants to migrate
- at **s.22** there are multiple instances of full and empty hydrocarbon containers along with free product on the ground documented by the 2012 BC Hazmat Report, the CRD has a photo of a jerry can floating in the collapsed mine tunnel from one of it's site visits, there are even more photos of crushed jerry cans and sheening of surface water after a recent surface clean up at **s.22** orchestrated by the CRD

Given the science and observations of our situation I do not understand why the MOE has not followed through with it's 2 written requests of the owner at **s.22** to undergo a site investigation by a QEP? The owner's non-compliance and the MOE's reluctance to give an Order or declare the property an Orphan Site have tied our hands in what is truly an untenable situation. We have undertaken everything within our means, at our own expense, to assess the situation on our properties but cannot do so across the road. At this point only the owner or MOE can do that. Without their cooperation we have really come to a point where we cannot move forward to resolve our contamination situation and set out a plan for securing safe water to our properties. This event 2 years ago has significantly changed the landscape of our lives and we are trying desperately to mitigate the odds that it will impact us forever. Can we ever drill another well? Will rainwater be enough given projected climate change? These are questions we cannot contemplate while still hydraulically connected to the property across the road without proper investigation.

Adam, we have not yet heard back from the Ministry regarding our attached rebuttal and request to address the site across the road. We understand our issue is complicated due to the multiple agencies involved and cost considerations. However, this is a public health and safety issue with environmental impact for not just ourselves but other neighbouring properties on North Pender's aquifer 711. We all rely on access to safe and healthy well water, unlike the owner of \$.22 who does not even reside in Canada. We would really appreciate if you could once again contact the MOE on our behalf to see what plans, if any, they are considering regarding our contamination given our recent rebuttal and scientific findings.

Elizabeth, we acknowledge water is a provincial issue but any advice or influence you can impart would be much appreciated.

Please give me a call if you have any questions or require further clarification on points made. It is hard to compress 1,500 + pages of FOI documents, scientific findings and history of events all in one short constructive email.

Not sure if too many people are misidentifying white tail does as mule deer or the wolf population has terminated many of the does, however the population is in dire shape. End of all female ungulate seasons (the kootenay white tails are imperil also) is of the utmost importance. Perhaps a bounty for wolfs also.

- Priority objectives for EU waste policy:
 - o To reduce the amount of waste generated;
 - To maximise recycling and re-use;
 - To limit incineration to non-recyclable materials;
 - o To phase out landfilling to non-recyclable and non-recoverable waste.
- Adoption of new laws (2018) to prevent waste and boost recycling including:
 - European leaders have approved higher recycling targets and new measures to reduce waste across Europe.
 - EU countries will now be required to recycle at least 55% of their municipal waste by 2025, 60% by 2030 and 65% by 2035.
 - Current waste generation rate is 587 kg/person/year in the EU
 - Mandatory separate collection of organic waste
 - Stricter schemes to make producers pay for the collection of key recyclables

Good Evening, Reamick.

On Tues, April 23 MLA Stone attended a meeting of 60-70 residents of Turtle Valley who expressed a number of concerns they had about the application of biosolids originating from the City of Kamloops sewage treatment facility to the Turtle Valley Bison Ranch. As a result of this meeting, our office committed to submitting the following questions to you on behalf of the residents of Turtle Valley. The Land Application Plan is attached for your reference.

- 1) Residents felt they were not adequately consulted with what were the consultation requirements and were they followed?
- 2) Residents feel they are not being given proper access to information and that some information is being withheld from them. Specific information they would like to receive includes:
- Full agrologist report (the residents would like to review it)
- Engineering reports or other assessments undertaken by Arrow
- Is Arrow responsible for posting a bond, in the event the work is not properly and water/land are found to contaminated later?
- What are the levels of accountability and scrutiny over biosolid projects, and this application in particular?
- If there is a 7 year stock pile of biosolids in Kamloops, why are they being spread in Turtle Valley now? Where will the rest be spread/applied?
- 3) Residents are upset that Arrow hires their own agrologist to conduct the assessment, and they feel it should be done by an independent party Is there any agrology/agriculturalist/biologist assessment done by a Ministry of Environment staff, or does Arrow truly provide the only assessment of how/where the biosolids can be spread on the specific piece of land?
- 4) Residents want to know who will be responsible for monitoring and fixing any issues that might occur after Arrow is done applying the biosolids. They want to know who is responsible for continual testing, monitoring, etc. Does Ministry of Environment test the land and water in the area before/during/after? Who monitors? Who is responsible for repairing a situation should the water/ground become contaminated?
- 5) Residents expressed they wanted an avenue to appeal the decision made by the Ministry of Environment to approve the project, and they wanted to know how they could get the current permit revoked. Is there an avenue for appeal aside from the court system?

We look forward to hearing back from you soon. As the trucking of biosolids to the Turtle Valley Bison Ranch has commenced, the residents are pushing to receive information in a timely manner.



Hey Sheldon,

Reamick is also going to look into this. But in terms of additional information that may help.

- B.C.'s carbon tax provides a signal across the economy to reduce emissions while encouraging sustainable economic activity and investment in low carbon innovation.
- As announced in the *Budget 2017 Update*, the BC carbon tax rate will increase annually by \$5 per tonne of CO2 equivalent emissions until rates are equal to \$50 per tonne in 2021.
- These increases are part of the strategy to bring our province back on track to achieve our climate goals.
- On April 1, 2018, B.C.'s carbon tax rate rose from \$30 to \$35 per tonne of carbon dioxide equivalent emissions (tCO₂e).
