Re: Advisory of Non-Compliance with the Integrated Pest Management Act & Regulation

This letter is written in follow-up to the inspection conducted August 23, 2016. This letter serves as a report of my findings and an advisory of non-compliance with the Integrated Pest Management Act & Regulation.

Background

On August 23, 2016, Senior Pesticide Management Officer Manuel Mariotto conducted an inspection of treatment performed on CP GOV Blk 217. Upon entering the block the officer noticed that there were no signs posted to indicate that treatment had been performed. The officer noticed the only sign posted was located approximately 1.5 kilometers from the start of the block.

Violation

Based on the officer's inspection and observations, Canadian Forest Products Ltd (Canfor) has been found to be in violation of the following section of the Integrated Pest Management Regulation;

Section 64(2)(b)(i) Public notification requirement-form and content

Regional Operations

Northern Region

- (b) if in relation to public land, be posted
- (i) so that it is clearly visible and legible from each approach used by the public to access the treatment area.

Conclusion

This advisory letter, the violation, and the circumstances to which it refers will form part of the compliance history of Canfor and will be taken into account in the event of future violations.

It is the Ministry of Environments expectation that this and any other actions required to prevent further violations under the *Integrated Pest Management Act and Regulation* will be undertaken. Further, I request that Canfor notify this office in writing by e mail or letter within 30 days of this letter, advising what corrective measures have been taken, and what else is being done to prevent similar non-compliances in the future.

RE: FLNRORD Draft Invasive Plant Pest Management Plan for Provincial Crown Lands in the Southern Interior Region of British Columbia to replace the existing Pest Management Plan expiring in 2019

Dear: s.22

Thank you for your email - letter dated February 13, 2019 to the Minister. In your letter there seems to be a miss understanding that this Pest Management Plan is for silviculture purposes rather than invasive alien plant management. The draft Pest Management Plan as well as the existing Pest Management Plan that the draft PMP is meant to replace can be viewed and down loaded at: https://www.for.gov.bc.ca/hra/plants/pmp.htm. You have to scroll down to locate the NEW - Draft Pest Management Plan (FLNRORD PMP Southern Interior 2019/2024). If you get a chance to review the plan you will note that the use of herbicides is limited, integrated with other treatment methods and any spraying is selective spot treatment of targeted invasive alien plants only. Also, you may not be aware of Health Canada's April 27, 2017 Re-evaluation Decision RVD2017-01, Glyphosate. The re-evaluation confirmed the 2015 evaluation that: "An evaluation of available scientific information found that products containing glyphosate do not present risks of concern to human health or the environment when used according to the revised label directions"1.

Herbicides may only be used in Canada if they have been evaluated and registered by the Pest Management Regulatory Agency of Health Canada. The Pest Management Regulatory Agency's mandate is to prevent unacceptable risk to people and the environment from the use of pesticides by establishing conditions and limitations for their use. The Pest Management Regulatory Agency only allows registration of products for which there is rigorous data demonstrating safety. British Columbia relies on this agency to evaluate the safety and efficacy of herbicides.

In British Columbia, the Ministry of Environment regulates the use and sale of pesticides under the Integrated Pest Management Act. Under this Act, all herbicide use on public land must be conducted using Integrated Pest Management. Integrated Pest Management is a decision-making process that includes pest prevention, consideration of all methods of pest control, education, and the use of pesticides when necessary.

Under the *Integrated Pest Management Act*, a Pest Management Plan that describes how Integrated Pest Management will be used must be prepared by agencies proposing to use herbicides to control invasive plants on provincial Crown land. The Act also stipulates that measures must be incorporated to ensure that herbicides are applied only to target invasive plants.

The draft Pest Management Plan is meant to describe and provide guidance for an Integrated Pest Management approach to the management of invasive plants on Crown land. As stated on page 11, the draft Pest Management Plan "aims to achieve effective long-term invasive plant control and management that is compatible with legislation, societal values, and environmental resources." There are many methods of invasive plant treatment, including herbicides that may be employed either on their own or together in a successful Integrated Pest Management Program; examples include manual/mechanical, cultural, and biological controls. As stated on page 26 of the draft Pest Management Plan, the selective and spot application of herbicides to target plants is used "when no other method of control is practical or effective".

Where appropriate, government ministries work collaboratively with regional invasive species committees or other partnering agencies to design operational treatment plans within the Pest Management Plan area. I encourage you to become involved with invasive plant management by visiting your Regional Invasive Species Society web page. Links to the various Regional Invasive Species Societies can be found on the Invasive Species of BC web page at: https://bcinvasives.ca/about/partners/bc-stakeholders/regional-committee-map.

Thank you again for communicating your concern. Ministry staff will continue to promote the use of Integrated Pest Management to manage invasive plants and will ensure that when herbicides are used on crown land, it is done safely and only when necessary.

Rationale:

On August 29, 2017 I contacted Jocelin Teron of Island Timberlands (who is listed as the contact on the herbicide notification sign provided).

Section 9 of the Integrated Pest Management Regulation (IPMR) requires:

A licensee must conduct public consultations in the manner and to the extent set out in section 62 [written notifications that must be completed by licensees in respect of forest land] if the licensee intends to use a pesticide for a use described in section 5 (1) (g) [pesticide uses for forest pests on private land used for timber production requiring a licence] on more than 20 ha a year managed by a single entity.

Section 62 of the IPMR, in turn, states,:

- 62 (1) For the purposes of section 9 [see above], at least 14 days before the pesticide use, the licensee must give written notice to the owner of any property within 150 m of the treatment area.
- (2) A notice for the purposes of subsection (1) must contain all the following:
- (a) description of the treatment area;

(b) reason for the pesticide use;

€ pesticide to be used, its registration number under the federal Act and its active ingredients;

(d) the earliest date that the pesticide will be used;

€ the width of the no-treatment zone that will be maintained from a water supply intake or well used for domestic or agricultural purposes, including water for livestock or for irrigation of crops;

- (f) a request that the recipient
- (i) supply the licensee with the location of water supply intakes or wells described in paragraph €, and
- (ii) advise the licensee of other land uses that may be adversely affected by the use;
- (g) a phone number at which the licensee or an employee can be reached for more information about the proposed pesticide use.

Ms. Teron provided documentation demonstrating compliance with Sections 9 and 62 of the IPMR.

Officer Notes:

Island Timberlands Gp Ltd. holds pesticide service licence 13122 (expiring Apr 1, 2018).

Section 10(11) of the Integrated Pest Management Regulation

http://www.bclaws.ca/EPLibraries/bclaws_new/document/ID/freeside/604_2004#section10 requires that, before using a pesticide for (amongst other things) the management of forest pests on private land used for timber production, a licensee must post, immediately before the use, a notice so that it is clearly visible and legible from each approach maintained by the owner or manager of the land for use by the public to access the treatment area.

Aug 28, 2017 emailed complainant to inquire if concern related to an area (such as a private recreational area) that is maintained for use by the public & to provide me the name of Island Timberlands staff with whom he communicated.

Here are some bullets as requested. I'm a bit unclear from the email train which aspects of the letter need a response from us, however as it seems that FLNRO is leading the response, I will keep these in bullet form and they can be incorporated into the response however the lead sees fit. However, I am happy to provide further information or a look at the final response for accuracy if needed.

- In British Columbia, pesticide sales and use are regulated under the Integrated Pest Management (IPM) Act and Regulation. Glyphosate use in forestry in BC is generally conducted under a Confirmation of a Pesticide Use Notice, which requires companies to develop a comprehensive Pest Management Plan (PMP) that outlines the specific elements of their Integrated Pest Management approach to controlling vegetation. As part of the development of this PMP, a public consultation process must be conducted according to the Regulation. Once a Confirmation is received that authorizes the use of the pesticide, companies must submit to the Ministry of Environment & Climate Change Strategy an annual Notice of Intent to Treat, which indicates the planned chemical treatments for the year, and an Annual Use Summary at the end of the year, which summaries total amount of pesticides used, and the total hectares treated using both chemical and non-chemical methods. Ministry inspectors conduct both field and office review inspections to verify compliance with the regulations, and have a range of enforcement tools available to address any instances of non-compliance.
- The IPM Regulation requires pesticide use in forestry to be done according to the principles of Integrated Pest Management, which seeks to use a wide range of tools, both chemical and non-chemical, to control pests. These include prevention of pest problems, proper identification of pests, use of monitoring and thresholds, appropriate treatment choices, and an evaluation of efficacy. A primary goal of IPM is to minimize the amount of pesticide used to control a pest. In addition, the required elements of the Pest Management Plan must also include a description of the environmental protection strategies and procedures that the authorization holder will follow, including strategies to protect fish and wildlife, riparian areas, and wildlife habitat from adverse effects of pesticide use. These requirements provide confidence that the judicious use of glyphosate in forestry is not having any adverse effects on forest health.
- Pesticides used in Canada are evaluated and registered by Health Canada's Pest Management Regulatory Agency, and registered active ingredients undergo periodic re-evaluations to determine if they are safe for human health and the environment. In 2015, Health Canada released the results from a comprehensive re-evaluation of glyphosate, in which they concluded that when used according to revised label directions, glyphosate use is not expected to pose risks of concern to the environment. These uses include the use of glyphosate in forestry. More information on the glyphosate re-evaluation decision is available on Health Canada's website at: http://www.hc-sc.gc.ca/cps-spc/pubs/pest/ decisions/rvd2017-01/index-eng.php
- All pesticides must be used according to label directions. In addition to label directions that

establish buffers around sensitive aquatic or environmental features, provincial regulations require that for forestry uses, a 10 meter Pesticide Free Zone be established around or along all bodies of water, dry streams, and classified wetlands, providing further protection to the environment from any possible impacts from glyphosate use.

Hopefully that's a decent start. Please let me know if more is needed on this.

Honourable Mr. Donaldson, Mr. Sheldan, Mr. Weaver, Mr. Kahlon, Ms Popham,

I start this letter by congratulating in being able to jointly form a government replacing the last Liberal Government. I hope this partnership survives full term and produces tangible results towards long term betterment of the province.

I write this letter out of serious concern regarding the future of BC forests, as well as survivability of our biodiversity as well as general health.

I know currently we are having a serious wildfire across much of the state and the cumulative dust particles in the air is making the sun a hazy orange blob in late evening sky. But my concern goes further than the immediate fire.

I draw you attention to the fact that effect of aerial spray of glyphosate (Roundup Herbicide) over our forests, which is approved by the provincial government and usually administered by private logging corporations for many years going into decades. Further, I draw your attention to the fact that there is absence of evidence that sufficient research has been done and observed by the BC Government on any long term effect of it on our environment, forest health, biodiversity, or trickle down effect on human health.

I have in the past tried to get information from the BC ministry any proof that it has seen evidence that glyphosate has no adverse effect on forests before approving its use. Sadly, I have not been shown any evidence of it by the previous BC ministry. I have reason to believe the BC Government has never seen any proof that glyphosate spraying on our forest is at all safe, and yet has been approving it out of a continued bad habit, year upon year.

Further, I have, through freedom of information act of the BC government, requested for data on the actual quantity of glyphosate used over BC forests, year upon year, from the first year of application to date. Regretfully, I have not gotten what I asked for, but got only a very small part of the answer comprising of a few localized hand application of glyphosate over small bushes. The reason I did not get the larger use data of aerial application is, I was told, the BC government does not know how much has been used, and may need to contact logging corporations to find the answer, hoping they keep the record.

I was asked if I would be willing to cough up a thousand odd dollars to pay for the man hour costs of the previous BC Government that would be needed to try to collect the information from the private corporations. I declined to pay that money and have been thoroughly disappointed in the shabby manner in which our ministry takes care of forest health.

I believe it is quite possible that forests that are weakened by excess use of herbicides can get vulnerable to not just to fire damage, but also many other maladies leading to continuous decline. I believe we may be converting our diverse forests into mono-culture plantation for the purpose of profit making by selling wood, rather than ensuring that a healthy forest remains to support a healthy environment and what biodiversity still remains in Canada.

I believe the government may need to seriously start looking into long term health of the entire British Columbian eco-system, and separate that from short term money making schemes and false projection of economic boom or job creation that seems to concentrate on simply exploiting natural resources till what is left is neither natural nor resourceful.

I also draw your attention to the fact that Canada has overtaken Brazil as the fastest destroyer of forests and eliminator of the earth's carbon sink on this planet. I have a serious question for all of you - what are you prepared to do about it?

I am copying Mr. Weaver since I expect the green party to be more aware on environment protection and hope to hear his views on this.

I am copying this also to Mr. Kahlon, my constitutional representative, since I have had a preelection talk with him on glyphosate and its excessive presence in our food system, which makes Canadian food to be about the most toxic on earth, as explained in the e-book \$.22 \$.22

I am copying this also to Ms Lana Popham, minister of Agriculture, who I have met long ago when she was an opposition MLA, because she is currently the minister of Agriculture, and I intend to send her a note about the need to focus on the most prevalent biocide in our food (glyphosate), the fact that Canadian food is the most toxic on earth, and the need to reverse the total silence this issue gets from all levels of Government in our country.

Apart from being the author of the book already mentioned, I am am an activist that tries to raise awareness, I have multiple levels of more or contact and communication, appeal, petition, and other efforts ongoing with different levels of our government, and will likely use this letter too, to influence and encourage others to join hands at a grassroots level to apply pressure to our newly formed government everywhere in Canada and North America, to pay more attention to saving our forests, environment and food system, rather than focus on how fast to exploit and degrade it.

I am curious why the Deputy Minister of Forest Management, Mr. Tim Sheldan, is also a chair of Forestry Innovation Investment group with apparent partnership with China and India, and if that is geared to find ways to attract foreign funds to help destroy our forests even faster and sell what is left to those countries, or if there is another reason for his involvement in that organization.

In summary, I ask the following

- 1. Show the people what evidence the government has, that application of glyphosate is not harmful to the total forest eco-system.
- 2. If the Government has not seen any such evidence, then immediately restrict the use of glyphosate, or any other kind of biocide, till a complete, and thorough investigation can be undertaken by entities that cannot be influenced by either politicians, governments or industry and will be unbiased and neutral. Share all information with the public.
- 3. Canada overtaking Brazil as the worlds worst de-forester what are you prepared to do about it?
- 4. Explain why the Deputy Minster of Forest is the chair of Forestry Innovation Investment and what is the purpose of this groups existence and what involvement China or India has in it.

Please take this letter as a public interest issue that will be shared with the public, including any response I get, or do not get, from our new BC Government.

I have another, less serious request to the government - that we stop the practice of addressing elected government officials as "honourable". It gives the impression that if one is not elected or not in politics, one is not honourable enough.

In my book, elected officials are public servants, not overlords. Therefore, elected officials should represent humility, not arrogance of power. Anyhow, this is a minor observation, not related to the main issue of glyphosate over forests and our real plan for preservation of forest eco-system.

Should you require, I shall be more than pleased to see any of you face to face about this.

Thanks, Graham, on August 29, 2017 I contacted Jocelin Teron of Island Timberlands (who is listed as the contact on the herbicide notification sign you provided).

Section 9 of the Integrated Pest Management Regulation (IPMR) requires:

A licensee must conduct public consultations in the manner and to the extent set out in section 62 [written notifications that must be completed by licensees in respect of forest land] if the licensee intends to use a pesticide for a use described in section 5 (1) (g) [pesticide uses for forest pests on private land used for timber production requiring a licence] on more than 20 ha a year managed by a single entity.

Section 62 of the IPMR, in turn, states,:

- **62** (1) For the purposes of section 9 [see above], at least 14 days before the pesticide use, the licensee must give written notice to the owner of any property within 150 m of the treatment area.
 - (2) A notice for the purposes of subsection (1) must contain all the following:
 - (a) description of the treatment area;
 - (b) reason for the pesticide use;
 - € pesticide to be used, its registration number under the federal Act and its active ingredients;
 - (d) the earliest date that the pesticide will be used;
 - € the width of the no-treatment zone that will be maintained from a water supply intake or well used for domestic or agricultural purposes, including water for livestock or for irrigation of crops;
 - (f) a request that the recipient
 - (i) supply the licensee with the location of water supply intakes or wells described in paragraph €, and
 - (ii) advise the licensee of other land uses that may be adversely affected by the use;
 - (g) a phone number at which the licensee or an employee can be reached for more information about the proposed pesticide use.

Ms. Teron provided documentation demonstrating compliance with Sections 9 and 62 of the IPMR.

Regarding your wider concerns about the use of pesticides (including the herbicide glyphosate): Health Canada's Pest Management Regulatory Agency is responsible for the regulation of pest control products in Canada under the authority of the *Pest Control Products Act* (PCPA).

The primary objective under the act is to prevent unacceptable risks to people and the environment from the use of pest control products. In addition, the PCPA ensures that pest control products have acceptable value, supports sustainable pest management, and encourages public awareness of pest control products.

We are writing this letter to you in regards to our strong position against the Pest Management Plan commencing May 1,2019. We realize that there is a pest problem in the forests but there are more environmentally friendly/humane ways to deal with this issue. We do not want these harmful chemicals spread everywhere! After all, we do live in beautiful British Columbia and we desire to keep it this way. These chemicals, such as glyphosate, have been proven to be cacogenic and have many negative repercussions.

Many species of plants and trees would be killed which would have harmful consequences to the animals that depend on them. There is no way that we would want to hunt and eat an animal that has been consuming poison either, would you? We depend on the forest for so many things! If you want to correctly deal with these pests, wouldn't it be better to do controlled fires in the spring and fall? Would it not be better to diversify the forests so we didn't have a particular dominant species of tree (which from my understanding contributes largely to the massive spread of such insects such as the pine beetle?) Sure it benefits logging companies but it also causes fires and puts thousands of homes and lives at risk! Thank you for your email of May 13, 2019, addressed to the Honourable George Heyman, Minister of Environment and Climate Change Strategy, regarding pesticide spray in North Surrey to combat gypsy moths. Minister Heyman has asked that I respond on his behalf.

The spray you are refereeing to in your email was authorized by a Pesticide Use Permit issued under the *Integrated Pest Management Act*. This permit allowed for the use of the product Foray 48B (active ingredient Btk), to control an outbreak of the invasive gypsy moth. Prior to issuing a permit, a thorough technical assessment is conducted by ministry staff to ensure that the proposed application will not result in any unreasonable adverse effects on human health or the environment. When issuing a permit, conditions are included to further minimize any potential adverse effects, and to take into consideration any feedback received during the required public consultation. The ministry also conducts compliance inspections to ensure that permittees are adhering to the conditions of their permit.

During the technical assessment, no species of concern were identified by the Provincial Invertebrate Specialist for the treatment area. Any non-target butterfly or moth populations that may be affected by the treatment are expected to recover rapidly, as the treatment area is small and can be repopulated by the adjacent untreated areas. This has been shown to occur in a previous study (Boulton, Timothy J. Victoria, BC: Ministry of Forests, 2003).

With respect to human health concerns, studies following aerial spray programs of Btk have not attributed any short or long-term health effects to exposure to Btk. Btk is a non-toxic, naturally-occurring pesticide, and it is worth noting that Foray 48B recently received organic status through OMRI Canada (Organic Materials Review Institute). In some studies, exposure to Foray 48B has been shown to produce slight to moderate skin and eye irritation. Therefore, permit conditions were included to ensure appropriate notification of residents, so that any concerned person could take precautions to avoid exposure during aerial applications. A copy of the permit itself can be viewed at https://www2.gov.bc.ca/assets/gov/farming-natural-resources-and-industry/forestry/forest-health-docs/gypsy-moth-docs/pesticide_use_permit_738-0029-19-19_-flnr_gypsy_moth.pdf

On May 13th of this year, I conducted an inspection during the first spray event, which took place between 5:40am and 6:45am. As required by the permit, wind was monitored at regular intervals before and during the spray using a wind meter. Wind was low (maximum speed of 2.5 km/hr), and primarily from the east. As required by the permit, the permittee also placed cards to monitor the uniformity of coverage of the application and the extent of spray drift. The cards show that the spray deposition was restricted to the treatment area, with no spray being found on cards placed in the buffer zone or outside of the buffer zone. The posted notices required under the permit were found to be in place and contained the required cautionary statements. Ministry staff will continue to monitor the work being conducted under this permit to ensure that no adverse effects are observed, and to respond to any concerns that are raised.
