We are writing to inform you that the [What We Heard report](#), following public engagement on the CleanBC Plastics Action Plan, has now been released. Formal submissions received from organizations, including yours, have been published alongside the report and can be viewed here - cleanbc.gov.bc.ca/plastics-formal-submissions.

In total, over 35,000 responses were received from British Columbians in response to the public engagement. Since then, the Ministry has been actively working on policy measures related to the Plastics Action Plan, this includes measures to support increased waste reduction, recycling and single-use plastics initiatives.
