2020-07-06 18:00 Attended COM's house. Chickens were secured in chicken house when predation occurred.s.22
 s.22 Back window of coupe breeched (boarded up at time of inspection). Chicken wire fence bent down slightly into outside enclosure where window that was accessed is. Enclosure gate damaged/torn off and no longer useable. Insufficient securement of window, and doors into coupe. Chicken feed stored in coupe in plastic/rubber tote, not secured. Construction of chicken house other than the windows/doors sufficient to keep bears out. Fencing/gate into chicken enclosure not sufficient to keep bears out.

COM immediately secure chicken feed and compose and chicken carcass bits as directed by DWPO. s.22
 s.22 Chicken free ranging during day. Provided safety advise.

2020-07-07 15:10 CO responded to Human Wildlife Conflict Report 20-9499 of grizzly bear and two cubs caught on camera breaking into chicken coupe around midnight. CO reviewed footage. Grizzly sow and 2 coy's filmed persistency attempting to access coupe and breaking in via the window originally broken into in original breach. Also accessing over fence in the same location as original break-in.

2020-07-07 16:20 CO set culvert trap and provided safety advice to COM. CO canvassed properties on all sides. Provided trap safety advice. Left note with contact info. of house to the north.

2020-07-13 06:22 CO briefed by ECC and transferred thru to COM. COM advised trap heard closing and can hear bear in trap. Doesn't hear vocalizations. Provided safety advise.

2020-07-13 07:00 CO attended and found lone Black Bear in trap. No other bears present. CO removed bear and took it to office compound, washed trap bottom, only cherries seen in scat. Immobile, easy induced, applied eye-ointment. Bear sexed as boar. Teeth good, No noted injuries. Ear tagged left ear 5-226. Took fur and tissue (ear tag punch) samples. Secured in yard in trap in shade with tarp cover to recover. BC Parks Rangers assisted.

2020-07-17 13:30 CO ANDERSON attended site and chickens fully secured, no fresh bear sign seen at site.

2020-07-20 15:00 CO ANDERSON attended met COM. Advised of GB sow capture nearby. COM has seen no bears. Advised to call RAPP if bear seen again, and that file would be concluded for now.

2020-07-06 19:46 CO called COM. s.22 Provided advise on fortification with e-fencing. COM saw only very small tracks he believes are cub tracks. The wildlife went in pen, into chicken port and knocked over feed. No chickens lost.

2020-07-09 07:46 CO called COM in regards to Update 1. COM reported a sow grizzly with 2 coy's jumped over fence into chicken run and then broke into chicken coupe. COM heard them and then used spotlight to scare them away where they fled over fence. COM only saw them for about 5 mins and didn't realize made entry until next day. COM reported no loss of chickens. COM runs a chicken farm operation. CO provided advise on e-fencing.

When the family group is confronted during the night the sow has attempted to close the distance between herself and the com in a sneaky manner by flanking and using cars and buildings to conceal her approach. The com is now afraid to try and scare the family unit off. TYRE and MILLER set to culvert traps and two snares and staked the area out in the dark for two nights. The bears did not return.
