Good afternoon Gerard

I was glad to see in the news that, despite all the restrictions imposed by Covid-19 regulations, there was a good turnout at the drive-by Port Alberni Toy Run this year. I wanted to make you aware of an incident occurred at Little Qualicum Falls Provincial Park this past Saturday, September 19, 2020.

Despite all the notices published on your website, Facebook page and the paper, two large groups of motorcyclists arrived at the Park on Saturday for the event. When the Park Operator notified the first group that the event was not occurring in the Park, he was threatened and verbally harassed. The second group of approximately 60 motorcyclists was turned around by the RCMP, who had arrived on site as a response to the threats received by the Park Operator. Individuals were observed uttering threats, causing a disturbance and participating in illegal mass gatherings. This behaviour is unacceptable and, as you can appreciate, we are concerned about the safety of the Park Operator and our staff.

I understand this was an unfortunate incident the organizers of the event could not anticipate. However, it would be important that future promotions of the Toy Run make clear to participants that the event will not start at Little Qualicum Falls Provincial Park anymore. I appreciate your time and I wish you all the best in your endeavours.
