Ministerial Order on Interim Targets 30 Day Decision

Issue:

 Establishment of a legislated interim greenhouse gas emission reduction target by December 31, 2020.

Background:

- The Climate Change Accountability Act requires the establishment, by December 31, 2020, of an interim (i.e pre-2030) greenhouse gas emission reduction target or targets and decision on the year(s) for which the target(s) is set.
- The target(s) are to be set by Ministerial Order.
- Fulsome engagement, including release of a discussion paper, was planned but interrupted by the Covid-19 pandemic and then the interregnum period.
- Limited engagement has been conducted with some industry, Indigenous and environmental non-government groups (ENGOs) about interim targets. There is now insufficient time for substantive further engagement prior to establishing interim target(s).
- The Climate Action Secretariat is conducting economic and policy analysis and will provide recommendations on potential interim targets.
- From engagement to date, ENGOs are more concerned with interim targets than other stakeholders of Indigenous groups. They are lobbying for a strong early target.
- As a province-wide rather than sector specific target, it is not anticipated that the establishment of the interim target(s) will elicit as much reaction among industrial stakeholders.

Decision required:

• The Minister will be required to establish the level(s) and date(s) of new legislated interim greenhouse gas emission reduction target(s) via Minister Order prior to December 31, 2020.



Sectoral Targets Discussion Paper for Stakeholder Consultation 30 Day Decision

Issue:

- Authorizing release of a discussion paper on the design and level of the sectoral targets required to be set by legislation before March 31, 2021.
- The discussion paper was due to be released in October but delayed due to the election. It is recommended to be sent only to targeted stakeholder and not posted for public engagement.

Background:

- The *Climate Change Accountability Act* requires that the Minister establish greenhouse gas (GHG) emission reductions targets for individual sectors of the economy.
- The target(s) are to be set by Ministerial Order by March 31, 2021.
- In order to establish these targets, the Province will need to determine both how to divide the
 Province's emissions into individual sectors and what is the appropriate greenhouse gas emission
 reduction target for each sector. The basis for the sector definitions is currently anticipated to be the
 emissions sector categories in the Provincial Inventory.
- This subject is complex and of high interest to industrial and environmental stakeholders. The Climate
 Action Secretariat is conducting economic and policy analysis and requires external feedback from
 affected parties to support this.
- Fulsome engagement was planned but interrupted by the Covid-19 pandemic and then the interregnum period. Limited engagement has been conducted with some industry, Indigenous and environmental non-government groups (ENGOs) about sectoral targets.
- Prior to the interregnum, the Province had planned to distribute a discussion paper on sectoral
 targets to elicit feedback from industry, Indigenous and environmental groups about sectoral
 definitions, criteria for establishing level of target stringency and alternative compliance pathways
 (e.g. offsets) to achieve targets.
- Industry is concerned that targets will add to climate policy costs, restrict growth and investment opportunities. ENGOs are lobbying for robust targets to support achievement of the overall 2030 GHG target of a 40 percent reduction from 2007 levels.
- The discussion paper is a simple and time efficient way for staff to get wide feedback to support the
 analysis and ultimate recommendations to the Minister on the sectoral targets prior to the March
 2021 deadline to set them.

Decision required:

 The Minister must decide whether the Province should distribute the targeted discussion paper to industry, Indigenous and environmental groups and advise on alternative/additional engagement activities.



Ministerial Order on Sectoral Greenhouse Gas Emission Targets 90 Day Decision

Issue:

Establishing greenhouse gas emission reduction targets for individual sectors by March 31, 2021.

Background:

- The *Climate Change Accountability Act* requires the Minister to establish, prior to March 31, greenhouse gas targets for individual sectors of the B.C. economy.
- The targets are to be set by Ministerial Order.
- To establish the targets, the Province must determine both how to divide the Province's emissions
 into individual sectors, and the appropriate greenhouse gas emission reduction target for each
 sector. The Province will also need to determine the target date, but it is currently assumed that it
 will align with the already-established 2030 province-wide target.
- In a 30-day decision note, staff have requested approval to distribute a discussion paper to engage
 with industry, Indigenous peoples and environmental groups. This paper will elicit feedback about,
 among other things, sectoral definitions, criteria for establishing level of stringency and alternative
 compliance pathways (e.g. offsets) to achieve targets.
- This decision is of keen interest to other ministries and their stakeholders. It is also of interest to Indigenous Peoples. In the limited engagement conducted to date (interruptions due to Covid-19 and the election period) the feedback received is that industry is concerned that targets will add to climate policy costs, restrict growth and investment opportunities. ENGOs are lobbying for robust targets to support achievement of the overall 2030 GHG target of a 40% reduction from 2007 levels.
- This information, along with analysis by the Climate Action Secretariat (CAS), will inform the recommendations that CAS will provide to the Minister by February 2021.

Decision required:

- The Minister is required to establish, by March 31, 2021, targets for individual sectors.
- It is recommended the target decision goes to a Cabinet committee for review before being set.



CleanBC – Current Status, Next Steps, Challenges and Opportunities

Issue:

- B.C. has a world-leading climate plan backed by significant government investment, but is not on track to meet its ambitious greenhouse gas reduction targets.
- A comprehensive suite of innovative measures are required to meet the targets in a manner that contributes to positive economic growth and restoring the Province's revenue base.
- This note describes the current status of CleanBC, and challenges associated with achieving B.C.'s targets. It then presents policy options that could be considered by a new government.

Background:

- The Climate Change Accountability Act (CCAA) sets B.C.'s greenhouse gas (GHG) targets as a 40 percent, 60 percent and 80 percent reduction below 2007 levels for 2030, 2040 and 2050 respectively. B.C. is not on track to achieve any of these targets.
- CleanBC, launched December 2018, contains 39 initiatives that were projected to achieve
 75 percent of the 2030 GHG target. It is a combined climate plan, energy roadmap and vision for a low-carbon economic transition. Implementation is on track.
- The CCAA is one of the most fulsome pieces of climate accountability legislation in the world and CleanBC is one of the most detailed emissions reductions plans globally.
- Climate policy is a cross-government initiative. Fifteen ministries have direct responsibility for elements of B.C.'s climate policy. Eleven have legislation, programs or initiatives that are designed to reduce GHG emissions; and a further four have responsibilities or programs relating to climate adaptation. Several other ministries have indirect links.
- B.C. contributes a small portion of global emissions (approximately 0.14 percent) and its efforts to reduce GHGs will be meaningless in the absence of global action.
- B.C. has been successful at 'decoupling' economic growth from emissions growth, but the trend is not
 fast enough, and our strong economy and growing population have increased emissions by 7 percent
 compared to 2007. B.C.'s per capita emissions and emissions per unit of GDP remain above those of
 many developed nations and sub-nationals due to our primary industrial base and lifestyles.
- B.C.'s commodities are, on average, lower carbon than specific competing jurisdictions. B.C.'s primary industries can experience a higher cost to deliver products to market than those competitors. Much of the competitiveness discussion has focused on climate policy costs, particularly the carbon tax. However, the carbon tax represents approximately one percent of overall production costs for average facilities in each sector, much lower than other costs such as labour costs, income taxes or transportation of goods to market. This suggests government may have other levers to help with business competitiveness beyond weakening climate policy.¹

• Climate remains a key concern of B.C. citizens, but it has slipped down the priority list during the Covid-19 pandemic. CleanBC is not well known by the general public.

Issue/Opportunity:

B.C.'s climate plan is world-leading and well-funded, but achieving B.C.'s targets remains a challenge

 The actions outlined in CleanBC were projected to reach approximately 75 percent of the legislated 2030 target of reducing GHG emissions by 40 percent below 2007 levels. The latest modelling suggests those same policies will now only get us 56-72 percent of the way, meaning further policy stringency and/or new policy will be required.




Figure 1: Pathway to meeting our climate goals

- Some CleanBC policies are not being designed and implemented as originally planned due to affordability or competitiveness concerns (e.g. Low Carbon Fuel Standard, renewable gas target, CleanBC Program for Industry). As such, CleanBC may not deliver on the reductions that have been modelled, despite funding commitments of over \$1.4 billion over four years.
- Any incremental emissions from new industrial development will make it harder to achieve our GHG targets. This includes LNC-Canada Phase 2 which is not included in the CleanBC modelling.² Even best-in-class global development, or new industry that supports the low-carbon economy such as biofuel or hydrogen plants, may create new emission sources.
- Closing the gap to B.C.'s target could be expensive because B.C. is already advancing the more
 economically affordable and easily actionable initiatives to reduce GHG emissions. For example, B.C.
 already has a clean electricity grid, continent-leading electric vehicle adoption rates and relatively
 clean industry. Achieving additional GHG emissions reductions requires additional funding (at an
 increasing cost per tonne), new taxation, or significant new regulations.
- Modelling estimates the cost of incremental policy to achieve the 2030 target could be upwards of \$245 per tonne on average. This is the economy-wide equivalent cost regardless of whether tax,

regulatory or government spending paths are chosen.

- The price difference between natural gas and electricity is amongst the most significant, structural barriers to progress on climate action. Low cost natural gas is preventing fuel switching in homes and industry.
- Almost half of the remaining emissions after CleanBC (i.e. the gap to target) are from heavy industry.
 This remains a policy challenge. These industries make up B.C.'s economic base, provide significant revenues to government and form the life-blood of many rural communities. Many are already struggling to maintain economic production, and, in some industries, there are few economically viable emissions reduction opportunities. However, modelling and applications to the CleanBC Industry Fund suggest that relatively cost-effective reduction options do exist, especially in the upstream natural gas sector.
- Without care, further GHG-reducing policy will create household affordability or industrial competitiveness impacts. If new climate policy increases costs for B.C. business faster than their competition, we may suffer 'carbon leakage', where the business moves production and jobs to a higher-emitting jurisdiction with a more competitive regulatory regime, resulting in economic losses for B.C. while global emissions increase. To help mitigate this, B.C.'s CleanBC program for Industry returns all of the carbon tax paid by industry back to industry via performance-based rebates and the Industry Fund. Measures that weaken climate action in industry result in other sectors of the economy needing to do more to hit B.C.'s targets.

Meeting B.C.'s targets will require new approaches to climate action in B.C.

- Instead of policies which directly reduce fossil fuel use or target fugitive emissions, there are options
 to target emissions that are not counted within the B.C. GHG Inventory ('off-inventory' reductions) or
 initiatives that shift behaviours or the market and create the opportunity for longer-term reductions
 ('enabling policies'). These initiatives may reduce the overall cost of achieving B.C.'s targets but may
 face increased scrutiny by environmental organizations. Examples include:
 - Carbon sequestration in forests (including land-based offsets);
 - Utilizing forestry waste/ slash for bioeconomic or bioenergy products;
 - B.C. liquified natural gas (LNG) as a lower-carbon replacement for marine bunker fuel;
 - Capturing carbon directly from the air through direct air capture;
 - o Investments in innovation and technology to develop future reduction options;
 - Circular economy systems to increase material efficiency, avoid waste and decrease costs;
 - Tax shifts to incentive cleaner choices, e.g. variable PST, road pricing; and
 - Low carbon infrastructure investments, e.g. active travel, transit, electricity transmission.
- When done right, climate policy is about more than just reducing GHGs. It can also:
 - o Spur technologies and innovations that become the employers and exporters of the future;
 - Reduce costs for business through energy and material efficiencies and process innovations;

- Support household affordability through increased mobility options, decreased refueling costs with electric cars, and cheaper to run, energy efficient homes;
- Support more livable communities through walk- or wheel-ability, urban green spaces, and localized services and jobs; and,
- Deliver cleaner air, cleaner water and decrease associated healthcare issues and costs.
- Regardless of B.C.'s success in hitting our GHG targets, the climate is changing and the social impacts, business impacts and costs to both government and the economy of responding are increasing. Studies have shown that early action will save money over the long run. A cross-government Climate Preparedness and Adaptation Strategy (CPAS), developed in collaboration with Indigenous peoples, is in development. The Economic Recovery Plan included approximately \$90 million in initiatives that support climate adaptation (e.g. reduce wildfire risk; highway improvements).
- Climate and energy policy, as well as rural economic development are key Indigenous relations and reconciliation issues. First Nations are key participants in many climate related files, including reducing diesel dependence, clean energy development, Site C, fossil fuel pipelines, LNG export opportunities, and adapting to a changing climate.

Summary/Next Steps

- A credible approach to climate policy must consider:
 - B.C.'s economic and government revenue situation;
 - Citizen affordability and industry competitiveness;
 - The high cost of additional climate policy in B.C.;
 - B.C.'s growing population;
 - Action (or lack thereof) in other jurisdictions;
 - The economic opportunities associated with the low carbon transition; and
 - The imperative for all jurisdictions to take meaningful action to reduce emissions and prepare for the inevitable impacts of climate.
- Therefore, the next phase of CleanBC should include a suite of initiatives that reduce emissions while supporting economic growth and helping to restore the Province's finances, for example:
 - Continue with increases to the carbon tax by \$5/year while further strengthening protections
 for low income British Columbians and Emissions-Intensive, Trade-Exposed (EITE) sectors. This
 is the most economically efficient and equitable way to reduce emissions and spur innovation
 while providing additional revenue to the Province;
 - Advance measures that incent change with net positive revenue impact to the Province (e.g. higher taxes for luxury, high emission vehicles);
 - Develop a more comprehensive carbon offset program to support lower cost and immediate reductions in B.C. and increase viability of large industrial projects;

- Make existing household incentive programs (e.g. for energy efficient upgrades to homes, electric vehicle purchases) means-tested or taxable;
- Explore reduction activities in areas that are currently 'off inventory' (e.g. carbon sequestration in forests, LNG bunkering);
- Target innovation/R&D funding and government supports to areas where B.C. has a real
 comparative advantage and where investments return not only GHG reductions but also
 incremental returns to British Columbians in the form of increased economic activity and
 government revenue (e.g. hydrogen production/use; certain carbon capture technologies;
 biofuel production; circular economy);
- Pursue a rate structure for BC Hydro that encourages fuel switching from natural gas to electricity, as articulated in the BC Hydro Review Phase 2 report;
- Increase methane regulations for upstream oil and gas sector beyond 2025;
- Position B.C. as a leader and influencer in global discussions related to carbon-based border tariff adjustments and ESG certification;
- Develop a Climate Preparedness and Adaptation Strategy; and
- Continue to align COVID recovery spending with climate action imperatives.
- The Climate Action Secretariat will work with the Minister responsible and partner Ministries to develop a plan for Cabinet consideration
