Hello everyone. It was nice to see you all last Thursday – thank you for the welcome to DMC. I'm really looking forward to working together with you to support the Planning and Priorities Committee.

1. Further to Lori's request on Nov 26 for an initial high-level timeline for priorities over the 4 year term – 2 templates are attached to assist with that. This information will be used to inform Cabinet's first planning session in early January.

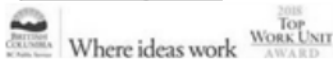

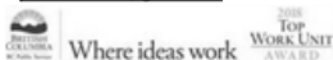
