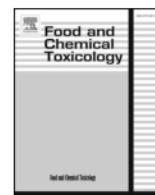

Dear Ms. Greene,,

My name is s.22 and I am a constituent in your riding. I'm writing because I have serious concerns about the proposed Tilbury LNG terminal expansion. My concerns include the health and safety impacts on nearby communities, on at-risk species of fish and whales, and the overall climate impacts of LNG expansion.

The Society of International Gas Tanker and Terminal Operators recommends a 3,500 metre hazard zone around the shipping route and terminal – an area around the proposed Tilbury Expansion project that encompasses large swaths of North and South Delta and Richmond.

Beyond the direct risks to community residents, LNG is almost as bad for the climate as burning coal. In the midst of a climate crisis when we need to be rapidly winding down our emissions, expanding fossil fuel infrastructure is simply unacceptable.

One of the main purposes of the expansion is to provide fuel for ships. However, research has shown that LNG as a shipping fuel is actually a huge threat to the climate. More on that here:

The Eulachon (a species that is very important to local Indigenous Peoples), and a population of Steelhead that was recently recommended for an emergency listing under the Species At Risk Act, would also be impacted. In addition, the Southern Resident Killer Whales could be harmed by the increase in ship traffic linked to the project.

The risks of this project far outweigh any potential benefits. I believe under no circumstances should this project be allowed to move forward.

I look forward to hearing back from you with regards to your position on the Tilbury LNG expansion.

Re: Oil and Gas Sector GHG Modelling

We write to follow up to the questions that Andrew Gage asked you on behalf of our organizations as part of the Organizing for Change Panel that you attended on April 8, 2021, and our subsequent follow up with your Ministry.

As you may recall, on the Panel Mr. Gage asked you how the Ministry could reconcile BC's 2025 Target (16% reductions relative to 2005) and 2030 Sectoral Target for the Oil and Gas Sector (33-38% reductions relative to 2005) with the province's plans for Liquefied Natural Gas (LNG). He expressed scepticism that the expected increase in GHG emissions from LNG Canada could be reconciled with the steep reductions in greenhouse gases required to meet either target.

In response you indicated that your Ministry had developed both targets based on its existing modelling for CleanBC, which includes LNG Canada. You insisted that there was no contradiction between the construction of LNG Canada and achieving either target and suggested that we request a meeting with your staff to get the details of this modelling.

We followed up on this suggestion, and on April 29th, 2021, met with Neil Dobson and Hurrian Peyman of the Climate Secretariat. While we appreciate their willingness to meet, Messieurs Dobson and Peyman told us that they were unable to share details of the modelling for the oil and gas sector, as it has not been made public. Mr. Dobson indicated that any decision to share the modelling that could demonstrate whether and how LNG Canada is consistent with the climate targets will require Ministerial approval.

We request that you authorize your staff to share the detailed modelling, methodology and assumptions on GHG emissions associated with LNG Canada and BC's Oil and Gas sector. The disclosure of this modelling is

essential given your government's repeated commitments that LNG in the province will only proceed if it can be shown to fit within the province's climate targets. Your government has committed to transparency in measuring your progress towards the climate goals, and the fact that this key modelling has been withheld from the public raises many questions.
