**RE: TransPulse Results are in – Trans Day of Visibility 2021 – Wednesday, March 31**

Dear Minister Heyman

I am writing you today about our 2021 Trans Day of Visibility Initiative. As we have in the past few years, we send a package with a trans flag and resource information to every MLA and ask you to share the package with a transgender constituent and then share the story of your meeting with us. This year, the package includes a special invitation to you and your constituents.

In 1948, Dr Alfred Kinsey and his associates published what is widely known as the Kinsey report, the first large scale survey of human sexual behaviour. This report still stands as a milepost in today's world of human diversity.

In 2019, TransPulse Canada completed the first national survey of Canada's gender diverse community. Its findings have the potential to stand as another milestone of what we know about our families and our communities. We are excited to tell you that the survey is done, the BC results are ready for review, and we need your help to do so.

With the help of our partners, the University of Victoria, the Victoria Native Friendship Centre, and especially our funding partner, the Vancouver Foundation, we are hosting a **special kind of gender reveal event on July 21**.

Our goal is to invite community members from every constituency in BC and we are asking your help to extend that invitation. We have separated the data by five BC Health Authority Regions and will be hosting a virtual community engagement for each region. The analysis also includes specific information for the Indigenous, the disabled, BPOC, low-income, and rural communities. [A copy of the invitation is found here.](#)

We have tried to make extending the invitation easy; it is included in the package with this letter. Each package has two parts, one for constituents and one for your staff. We are asking you to forward the entire package to your constituency office. At the same time, through a social media campaign we are letting community members know the package is at the office. Further details are in the package.

Many BC families are experiencing anxiety as they navigate an increasingly complex world, now beset with a global pandemic. These anxieties are multiplied in families and individuals living through physical, social, and personal transition related to gender. They look to government for guidance and resources, and government in turn desires to respond in a way that is regionally equitable, and evidence based.

The information to shape equitable, evidence-based, gender wellness programming is now available thanks to the great work by TransPulse Canada. Please help us get it into the hands of decision makers, whether members of a family, or health service providers, and help everyone - **Get Better Together**.

**Re: Trans Day of Visibility – Healthy Voices Vocal Practices**

Dear Minister Dix,

Each year we observe two dates on our community calendar, Trans Day of Remembrance, when we remember those lost, and today, Trans Day of Visibility, when we celebrate the lives of those living and those to come. On both occasions we take the opportunity to reach out to government to forge new paths in our common quest to improve the lives of all British Columbians. Today we wanted to update on the great work that is happening in our community.

In 2014, the previous government convened a committee of over two dozen health care professionals to advise on health services for the transgender community. Included in those discussions was the role of vocal modification as a gender affirming therapy. Like other issues before the committee, an overview of existing practices was completed but no detail work was done due to time constraints. As you know, in health care, the devil is in the details.

**---Vocal therapy as a metaphor for trans healthcare**

The co-op has always seen and promoted vocal modification both as a needed service and a metaphor for the overall process of physical, social, and personal transition related to gender. As demonstrated in the MOH sponsored Changing Keys program, most can learn the fundamentals of vocal modification in a weekend, but it takes months, and sometimes years of regular, weekly practice to internalize the knowledge. As such, the prerequisite ongoing vocal practice program provides the opportunity to individuals to access other services in an environment that is socially supportive. It reiterates for the individual that transition is incredibly complex, requires full commitment, persistence, and most importantly, it is something one does for themselves rather than something done by others to them.

**--- Lack of choices leads to unintentional outcomes**

No one can be even marginally involved in gender wellness in BC without awareness of the number of BC minors accessing transition related surgical modifications, despite this being contrary to the standards set by the World Professional Association for Transgender Health. (WPATH) WPATH states the age of majority as one of the criteria for accessing treatments that result in permanent changes. Some community members, myself included, see in this practice a potential backlash such as we are currently seeing in the United Kingdom regarding hormone blockers. One must ask why the BC Ministry of Health is allowing this to happen.

In our shift to a community-based research-based organization, we have worked to identify, articulate, and authenticate, the premises that underlie transgender health services as part of our Vancouver Foundation systems change investigation grant. Our initial findings center **on this premise; that the trans phenomena is best understood as consisting of two concurrent, interrelated states, the innate state, present at birth, present at death, and the persistent state which is the interpretation of the first state by ourselves and our culture.** These two states broadly align with the literature, gender incongruence in the ICD and gender dysphoria in the DSM.

Our observation is that health services typically focus on the second and ignore the first, a paradigm common to the treatment of many chronic conditions. Substance misuse comes to mind. Again, one must ask why families and individuals pursue these permanent changes so early in a path that will continue for the rest of their lives. It is not the lack of good intentions. Regardless of their choice, most parents are motivated to do what is best for their child. **The problem is that these are the only choices the system is presenting as valid.** It does not recognize the trans phenomena as both innate and persistent, or rather it does not allocate resources in a way that recognizes both states. It does little to nothing to prepare individuals for the interventions it does provide, let alone include it amongst a range of services as part of an overall ecosystem of care, such as we see in more mature care models in communities with longer histories of (more) equitable health services, such as the diabetic community.

#### --- A comparative problem and solution

After the initial committee was concluded without finalizing their work, we began to look at the 'devil in the details' of why there was inequity between feminizing and masculinizing transition related surgeries. By 2016, we had identified that the lack of specific billing codes for transition related surgeries was a significant part of the problem. Once you became Minister with the change of government, your staff confirmed this, and began the process of altering billing codes. This year plus long process illustrates the complexities of a \$22 billion healthcare system, complexities that inherently impact everyone's say / do ratio. It also illustrates the necessary role of advocates in all aspects of healthcare, political, bureaucratic, and community, working together as equitable stakeholders.

We see a similar problem with billing codes related to transition related speech pathology resources. All the health authorities maintain speech pathology resources, and our anecdotal knowledge is that many of them provide services 'off the side of their desks', but the lack of billing codes makes it impossible for care providers to create referrals.

Since 2015, the co-op has invested thousands of dollars and hours into **Healthy Voices**, our community-based, all-gender, ongoing, low barrier, vocal practices. We currently offer this on a weekly, year-round basis across BC at no cost to the participants. This stands in contrast to the Ministry of Health's **Changing Keys** program, which requires a speech pathologist, focuses on a narrow range of gender, is periodic at best, and presents a high barrier due to cost.

We have done so without any assistance from the BC government. We have applied for funding every year through your **TransCare BC** program. Your own records show that while we have submitted more applications than any other BC organization, we remain one of the few organizations never funded. We rely instead on federal and community funding sources, and thousands of volunteer hours. Given our demonstrated history, from participation in the original recommendations committee, to our formation of the O\_CHI research partnership, it appears reasonable that we both understand the needs of our community, and how to develop an evidence-based approach in delivering services to meet those needs.

But we have reached the point in our vocal programming where our investment needs the integration and support of the healthcare system to continue development. Our community-based model always included a role for speech pathologists. These professionals, who are not needed for the practices, are needed in both assessing the individual at the start of their vocal modification work, then periodically, to provide ongoing assessments of their progress.

The first step toward this integration is a scoping review of current speech pathology resources, a review of current billing codes, and implementation of new codes to set the basis for the inclusion of equitable transition related speech pathology services.

We have demonstrated our commitment to a model of trans healthcare that engenders an overall ecosystem of care resulting in maximum choice within existing resources. Many families are in crises and need many kinds of help.

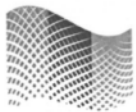

Thank you for your email of August 9, 2021, addressed to the Honourable John Horgan, Premier, regarding The Discover Camping Reservation System. I am pleased to have the opportunity to respond.

I am sorry to hear about your frustration with the Discover Camping call centre. The purpose of the call centre is to assist customers with making reservations, modifications and cancellations. Call centre staff are subcontracted by our reservation system provider. It is disappointing to hear that the call centre's approach did not meet your needs. I will be sure to pass along your feedback to the Discover Camping program to ensure we do a better job of supporting the needs of our customers.

I appreciate that you also sent us previous emails at [parkinfo@gov.bc.ca](mailto:parkinfo@gov.bc.ca) on July 28, 2021. This is the best point of contact for questions about, reservations, cancellations, policies, and other general BC Parks and website navigation questions. While every effort is made by the team to respond to emails in a timely manner, the team has experienced a higher-than-normal email volume due to the extreme wildfires that are affecting our province.

You mentioned that you were on the Discover Camping website looking to book a campsite. I understand you may not have intended to reserve a campsite or were aware the reservation went through. However, there are several steps to take and confirmations to agree to before a reservation is complete. Our multi-step process is to ensure you have multiple opportunities to select, review, and confirm your reservation before proceeding to make your payment. I am sorry that this process proved difficult and confusing which may have resulted in an inadvertently booked reservation.

If you feel this booking was made in error and you would like to request a refund, you may do so on our BC Parks website by going to <https://bcparks.ca/reserve/refund-application.html?r=1> and filling out the refund form. Please make sure to select "Incorrect charges" as grounds for a refund. The Discover Camping team will assess the submission and, should it meet refund policy criteria, a refund of all camping fees will be returned to you. Our normal assessment timeline of 6-8 weeks has been significantly delayed due to a large volume of refund requests that resulted from wildfires, Covid-19 travel ban, and poor air quality throughout a large portion of BC. We thank you for your patience as we work to respond to every customer who submits a refund request.

In your email you mentioned a reporter's tweet regarding issues with the Discover Camping reservation website. This was speaking to a distinct error with our minimum stay policy that occurred over the August long weekend. The tweet was specific to one issue and not the entire reservation process, which has seen thousands of successful reservations take place over the summer.

I've tried everything, no one responds to anything - I contacted BC Parks reservation help - BC Parks request a refund with all the explanations below. When I started the process of the possibility of booking sites in BC Provincial Parks, I tried contacting the call centre for help, plus got caught up in Covid for cancellations - never have I talked to a call centre who will not help, no information. I would make the suggestion that Premier Horgan or George Hyman call in (sorry I know you are busy but you need to hear the messages (5-10mins worth), cut you off when you hit certain numbers plus talking to these people is insane with their customer skills).

First of all here is the message I sent:

"" I did not make this reservation - received no confirmation email

I was on this site but the length etc was too small for our unit. I had no idea this went through...tried multiple times to contact the call centre! I've never in my entire life witnessed a more dysfunctional IVR - you hit numbers re the instructions - you get disconnected - happened three times

There is way more to this! I've also sent a message to discover camping but nobody answers anything - I've tried and tried to get help! We are seniors the probably no way more about technology than most of our friends. As an example first time we made a reservation we got a confirmation email - nothing the second time or this time when we were charged for a reservation we had no intention of making.

I know there was issues and problems with reservations as different reporters were twitting about it...in particular Richard Zussman who is a respected reporter.

I have a copy of a thread of texts with the gatehouse at the Okanagan Lake Park plus there supervisor Ronnie who I understand operations out of Alberta.

Please call us at S.22 . Plus I had a conversation with an employee/Manager in Lake Country for the contractor. They all tell me there is problems with the call centre & reservations. When I was having problems in May With the call centre I asked to speak to a manager - guess what they told me - I could wait for hours to be able to speak to a manager - I had to stay on my phone for that long - no one is allowed to call back.

Please help, we feel so taken advantageous! We would love to have a camping site in South Okanagan for those dates that would fit our rig, even in the smoke!!

When we were at the North Okanagan site in June, we talked to there people and employees, everyone agree there are many issues not being resolved.""

**Now here are copies of the set of text messages from the gate keeper and her supervisor in Alberta. Why would I answer these texts as I did, if I thought I had made reservations. I honestly thoroughly thought we were getting scammed. The sequence of the text is from the bottom to the top. These people understood and could tell we had never made this reservation & apologized to us.**

Hi there

It's Brenda at the Gatehouse at okanagan lake park. Just checking our 'no show' tags.

You didn't arrive for site S 19 yesterday - will you be coming to camp?

Hi Brenda I texted earlier on the following message.

We do not have a reservation

This is not the correct phone number - I have no reservations- would like them but couldn't get any!  
What's going on???

Also I texted the number you had listed and advised them you were texting me in error - they responded thank you

Have we been charged?  
No charges I don't think unless your name is s.22
