Hi,

This email is to provide an update on activities currently happening in the Morice area. I will flag that the situation is fluid so this information is being shared "to the best of my knowledge".

Sunday, November 14th, members of the [Gidimt'en Clan](#) informed [Coastal GasLink \(CGL\)](#) that they were to remove their employees from the Wet'suwet'en territory in line with the eviction notice original provided in 2020. CGL did not leave the territory.

The Morice Forest Service Road was ultimately blocked around kilometer 39 by individuals opposed to the project. The access is now blocked for both incoming and outgoing traffic. There are other blockages, including destruction of the road at the Lamprey Creek bridge (photos in the CGL link below).

CGL has around 500 people in Camps 9A and P2, east of the established blockades. Today, the only available egress out of these camps is by helicopter. The camps are limited on essential supplies right now. Keeping people in these camps safe is a priority for all.
