Unfortunately some bears that were able to den, may not have been able to put the fat reserves on that were necessary to survive the winter and are emerging sooner than normal. Caeley Thacker, provincial wildlife vet advised the following: Hi Ken, Mites tend to be species specificà they may get onto other animals or people, but generally donÆt live long or cause an issue. If people have elderly pets or are immune compromised themselves, they may wish to treat their pets for parasites and treat their home if theyÆve been in contact with an infected animals, but generally this is not necessary. Freezing, drying, and UV light will kill them in the outside environment. Severe infections are a welfare concern for bears as (apparently) they are incredibly itchy and uncomfortable. Severe infections like the one on this bear are usually associated with some underlying condition, so poor immune function. I think, for anyways, severe infections are rare and more mild infections often clear up when the animal has access to better nutrition in the spring.
