Here are some bullets (mostly extracted from previous background on this issue):

- Keremeos Columns Park (20 hectares) does not protect the geologic formation known as the 'columns'. A survey conducted after park establishment (1931) confirmed that the columns were outside the park.
- The columns are located on a private parcel (DL 2963) located immediately south of the park boundary.
- At this time, public access to the column features is not permitted.
- Public viewing of the column features must be done so by using valley bottom vantage points that do not involve
 encroachment or access onto private land.
- Keremeos Columns Park, while not protecting the columns themselves, protects important grassland habitat and flora species at risk as well as a acting as a natural buffer to the column features.

Hi Evelyn:

Thanks for reaching out....encouraging to hear that outreach on the OCP is occurring and definitely the timing aligns nicely with that of the planning process for Cathedral Park.

Just so you are aware, BC Parks owns both land parcels (DL 2056S and DL 3025S) that comprise the operations of Cathedral Lake Lodge Ltd. and the lodge continues to operate its business under both a park use permit and through provisions of a lease (which is registered on title for both DL 2056S and DL 3025S). Our agency works very closely with the lodge operator and oversee compliance with the lease. If there is zoning to be applied via the OCP, those land areas should be synonymous with that of the balance of the park- rather than private commercial/tourism.

There is no residential development occurring at the base camp property (DL 2056S) within the park. There is a small residential area that has been developed along the Ashnola FSR on private land north of the base camp property....however, our agency is not involved although we monitor the park/private land interface for encroachment.

Regarding Keremeos Columns Park...the park land area does not actually protect the unique columnar geologic features- those features are located on private land of which there is no authorized access. Our agency has attempted to explore opportunities/park reconfiguration with the principle private land owner, but at this time there is no willingness to provide public access to the features. The park land can be accessed from the north, but it requires considerable roadless backcountry travel, not suitable for most visitors, and even then, the park does not contain any columnar geologic features.

I am working with Regional District of Okanagan Similkameen and EcoPlan on the development of the first Official Community Plan (OCP) for Electoral Area "G" (which includes Hedley, rural Keremeos and Olalla areas). We have had some community engagement to this point and are in the process of having a second community survey. To date, we have put together a draft land use map and are working on developing the broad goals and policies.

We have had several questions/comments about two of the Provincial Parks in the area, Cathedral Park and the Keremeos Columns Park, so I am hoping you can answer some of the questions posed to us!

1. Cathedral Park: I have read about the planning process on line (today!) and am glad to see that being done. Is it correct to assume that BC Parks desires to own all of the land in the park, including the resort/lodge? Is there a desire to phase out the resort, or are there plans to keep it privately run? In terms of designating the whole Park, the OCP could show it all as 'Parks and Recreation' following the designation of other Provincial Parks. Given the privately held/run lodge/resort area though, there is some consideration to designation this as 'Commercial Tourism' if the future desire it to maintain the commercial aspects of this area.

Also, we have been told that the land at the Ashnola parking area (base area) is currently being developed into some sort of residential area? Would you know anything about this? As there are no building permits or zoning in the area, it is difficult to determine what is being constructed.

1. Keremeos Columns Park: We have had several comments about allowing access to this park again. Checking on line, it appears that there aren't really any directions on how to get into this park and local residents have told us that the road in has been decommissioned. Could you provide some insights into this Park, and if there is a desire to provide access??
