

Statement from Coralee Oakes, Minister of Small Business and Red Tape Reduction and Responsible for the Liquor Distribution Branch:

"We are confident that our wine in grocery model strikes the right balance of support for B.C. businesses, health and safety protection, and added consumer convenience.

To put this issue into perspective, there are two grocery stores selling wine off the shelf right now and this model will only ever represent a small fraction of the total number of retail outlets in the province.

When it comes to keeping British Columbians safe, I can assure you that grocery stores selling wine are doing so following the proper public safety requirements – the same requirements that are mandatory for all liquor retailers.

At the end of the day, the goal is to create a competitive market that sees both private and public sectors finding success, and I'm confident we are on the right path."

#### Background information:

- Wine in grocery was one of the most popular topics during the Liquor Policy Review, and government took action, making the necessary changes to allow for it.
- The made-in-B.C. wine on shelves model promotes B.C.'s wine industry through 100% B.C. wine sales available
  right off the shelf and supports added consumer convenience allowing British Columbians to grab a bottle of
  local wine to go along with their meal.
- For example, the Surrey South Point Save-On-Foods has almost 700 types of wine manufactured by small to medium-sized wineries and the BC Wine Institute has said that around 50% of their grocery sales are from small to medium-sized wineries.

#### **BC Liquor Stores:**

- BC Liquor Stores have long been known for their vast selection of products and their good customer service.
- Since April 1st they can now offer extended store hours, Sunday openings, and refrigeration with the understanding that they are expected to be a competitor in the liquor retail business.
- Government is also very away of the obligations that exist in current collective agreements. These obligations
  were considered and will remain top of mind as work to modernize B.C.'s liquor laws continues.

#### Public Safety background information:

- Options for liquor sales in grocery were created with responsible liquor sales in mind.
- Grocery store tills must be staffed by adult cashiers that Serving It Right training and are required to display mandatory social responsibility materials—similar to public and private liquor retailers.
- In many cases, grocery stores are also set up with closed circuit television systems and "store walkers."
- We have also expanded our Minors as Agents program to grocery stores that sell liquor, to further safeguard minors from access to alcohol.

#### International Trade background information:

- Government does not plan to issue any net new licences and plans to keep the number consistent with those allowed and already created under existing trade laws.
- A limited number of dormant licences will be offered to take advantage of the new model with plans to issue under two dozen dormant licences in the future.

As I believe you are aware, Music Canada has been focused intently upon helping the Government of BC build a comprehensive Music Strategy. I have had the opportunity to meet with two of your staff on my first visit to BC in September. We have also had very positive meetings with the Premier's Office and Ministers Bond, Fassbender and Virk, together with their staff, and have met with the North Shore Caucus.

We believe we are now very close to being in the position to put forward a coherent and detailed music strategy for your review. There is a very significant red-tape component to our proposal.
