LPR Mandate

Three guiding recommendations define the scope

- 27: Manufacturers should be able to establish low-risk tasting venues such as a picnic area as part of their existing licence without the need to apply for a specific endorsement. Government should work with industry, local government and First Nations to increase flexibility for tasting options for manufacturers while being sensitive to potential negative impacts, such as noise, on the community.
- 28: Allow manufacturers to offer patrons liquor that was not produced on site (interim implementation July 2015).
- 30: Government should consult with industry and review the minimum requirements to obtain a brewery, winery or distillery licence. Government should also consider how these requirements are regulated by LCLB and LDB to ensure transparency and an effective regulatory system.

What we heard... Phase 1

- Current system is mostly fine – more clarity in some areas needed and consistent enforcement
- Reduce duplication of information requested at application and align/reduce reporting requirements (LDB/CRA)
- Manufacturers should manufacture – OK to do some limited contracting when starting up but need truth in origin labelling
- Simplify on site consumption endorsements

Applications

Harmonize information requirements (LDB/LCLB) at application and streamline applicant experience

 - Valid interest (lease, own) in property
 - Applicant eligibility, suitability (police check etc.)
- Specific business intent information to determine:
 - Basic eligibility for manufacturer licence
 - Type of manufacturer (for direct delivery benefit assessment)
- Site information to:
 - Define site for sampling (urban vs rural)
 - Area for lounge/ SEA (if applicable)

Criteria for a manufacturing licence

- Setting criteria for licensing and ongoing operation supports the integrity of the manufacturer licence by ensuring licensees manufacture.
- Recent feedback suggests manufacturing licences are being used as a “back door” method of obtaining hospitality centres and/or stores.
- Equipment and onsite production requirements support those who are manufacturing liquor and wish to showcase it on site. Other licensing options exist for by-the-glass and retail businesses.

Criteria: Equipment

Equipment (all types)

- Manufacturers must have sufficient equipment to complete all stages of production for the product (to meet on site production requirement – next slide)
 - Application information submitted regarding equipment ownership becomes part of licence - like a floor plan (acknowledges diverse production techniques with specialized equipment needs)

Feedback: Should the equipment policy be outcome-based (as above) or require specific essential equipment? If specific, what would that be?

Criteria: Onsite production

On site production- Wineries and breweries

Feedback- discuss options

- Option 1:
 - Wineries: Maintain the 4500 ltr **on site** production requirement for wineries and expand “production” beyond fermentation to include at least one other production task (e.g. crushing, filtering)
 - Breweries: no min amount (equipment for on site production required)
- Option 2: (Breweries and wineries)
 - Require a minimum percentage (25/50%) of product be produced on site from juice or mash to finished product. (Ensures integrity of manufacturer licence and maintains connection to site to strengthen endorsement link)
- Option 3: Combination
 - Combination – manufacturers must produce a proportion on site and wineries also maintain the 4500ltr minimum

Criteria: Distilleries

Distilleries

Feedback

- Basic licence permits use of neutral grain spirits or distillation as part of production process (not eligible for lounge/SEA)
- Craft distillery designation = eligible for lounge/SEA. Any current non-craft designated distilleries w/ lounge/SEA may maintain.

Question: Should there be a middle ground to accommodate those that don't meet CD threshold but want a lounge/SEA?

Criteria: LDB Agreement

Compliance with LDB sales agreement and record keeping requirements

- LCLB record keeping requirements will focus on product inputs and movement (red tape reduction)
- Alignment with federal requirements where possible
- Compliance with LDB sales agreement is required for licence and endorsement(s)

Producing for other licensees: T&Cs

Status Quo

- Must maintain minimum on site production (buyer and seller)
- May manufacture liquor, all or part of process, for other licensees
- Licensees must track and maintain records of liquor movement – bulk or bottled product, origin etc
- Manufacturers cannot sell products to unlicensed individuals for further resale (see “brand builders”)

***Feedback:** If any part of the manufacturing process occurs away from the licensed manufacturing site should the product be labelled to reflect this? (e.g. “produced in conjunction with.....x manufacturer)*

Brand builders/ contract production

- Some companies/individuals want to build their brand prior to investing in land/equipment
- Manufacturers may manufacture and sell a product that is branded differently than its main label to support business entry
- Manufacturers must ensure unlicensed individuals acting as sales representatives only promote products (no sales– may take orders from licensees). For example, virtual winery sales via an unlicensed third party are prohibited.
- Manufacturer retains ownership of products until **final sale** – the manufacturer **must** take payment.
- Any sales websites **must** clearly link to manufacturer.

Proposed: Products must be labelled for origin with manufacturer's licence number and name

On-site store and online sales

Proposed new flexibility

- Store authorizes specific store area on site as well as temporary and/or outdoor points of sale on site (no additional applications)

Status quo

- Sales (on site and online) require a store endorsement and an LDB sales agreement
- Market authorization continued
- Manufacturers must demonstrate a clear, auditable link for all online sales
- Only a manufacturer may sell products regardless of product branding

On-site consumption

- Two levels of on premises consumption permissions:
Basic tasting and full service (options to follow)
 - Eliminates separate picnic area/ tour area application and T&Cs
 - Creates additional accountability to surrounding community
 - Increased flexibility for consumption of samples throughout manufacturing site

On-site consumption

- **Basic permission** comes with licence (no fee)
 - General permission to consume samples on the manufacturing site
 - Urban vs rural location may limit permission (e.g. no appropriate land= no outdoor sampling area)
 - No amplified sound outside (ambient background music OK)

Proposed transition: Existing picnic areas convert to general site permission (wineries may still sell bottles from store for consumption in an area with line of sight from sales area)

On-site consumption

Feedback on options

Option 1- Status Quo (lounge/SEA)

- 20% sale of other's products (all types of liquor) *Interim measure in place
- Flat renewal fee (status quo)
- **Required** for outdoor events with amplified sound

Option 2 - Full service endorsement (lounge/SEA)

- Volume-based renewal (like all other by-the-glass licences)
- May serve all types of liquor (no % cap)
- **Required** for outdoor events with amplified sound

*ALR size restrictions for lounges may apply

*Other current options: Food primary licence may also be obtained for full service restaurants on site, liquor primary licence for pub/bar

The BC Liquor Control and Licensing Branch (LCLB) and the Liquor Distribution Branch (LDB) are conducting a review of several elements of the manufacturing licence regulatory structure.

The 2014 B.C. Liquor Policy Review final report¹, prepared by Parliamentary Secretary John Yap and accepted by government, have set a mandate **to review on-site consumption endorsements and the requirements to obtain and maintain a manufacturing licence**. The associated recommendations² in the final report are numbers 27, 28 and 30. Government, via the LCLB and LDB, is requesting feedback from licensees and stakeholder groups on the appended questions to inform our review of the regulations in this area.

The key objectives of this feedback process are to ensure any new policies respecting liquor manufacturing will:

- protect public safety and the public interest,
- are modern and support the growth of the liquor manufacturing industry,
- minimize administrative burdens with regard to application and reporting,
- provide clear guidance around on-site consumption and reflect community standards, and
- provide a framework of requirements for manufacturing operations that reflect industry standards and maintain the integrity of the manufacturer licence.

- Fall 2015: LCLB and LDB staff will hold facilitated discussions with other agencies that regulate liquor (Canada Revenue Agency, Ministry of Agriculture, local governments).

These consultation components are important to ensure government has the information required to prepare updates to the current manufacturing policy framework. We ask that you review the attached information, and provide responses to the questions you feel are relevant to your organization. Written submissions must be received by August 21, 2015 and should be addressed to Melanie Golder at Melanie.Golder@gov.bc.ca. This information will also be posted on our website during the consultation period.

Liquor Control and Licensing Branch Consultations

Introduction

This paper has been organized into two parts that reflect the Liquor Policy Review (LPR) recommendations shown below. You may submit additional feedback in other areas not covered here for government consideration. However, the scope of this consultation is limited to the questions below and it may not be possible to incorporate feedback that falls outside of this mandate.

Part 1: Minimum requirements for a manufacturer licence

Liquor Policy Review Recommendation 30: Government should consult with industry and review the minimum requirements to obtain a brewery, winery or distillery licence. Government should also consider how these requirements are regulated by LCLB and LDB to ensure transparency and an effective regulatory system.

Part 2: On site consumption

Liquor Policy Review Recommendation 27: Manufacturers should be able to establish low-risk tasting venues such as a picnic area as part of their existing licence without the need to apply for a specific endorsement. Government should work with industry, local government and First Nations to increase flexibility for tasting options for manufacturers while being sensitive to potential negative impacts, such as noise, on the community.

Liquor Policy Review Recommendation 28: Allow manufacturers to offer patrons liquor that was not produced on site (e.g., a winery could sell a beer to a visitor).

Part 1: Minimum requirements for a manufacturer licence

Currently, provincial liquor legislation and policy contains a number of requirements to obtain a manufacturer licence. Liquor Distribution Branch (LDB) and Liquor Control and Licensing Branch (LCLB) requirements are summarized in Appendix A. Part 1 of this paper seeks feedback on how these requirements affect licensees and applicants and will be used to determine if there are opportunities for procedural streamlining and consideration of changes to the regulatory structure.

Recent feedback suggests there are concerns within the manufacturing industry with respect to equity under the current regulatory regime. In the past, much of the criticism from the liquor industry is that it is over regulated. The opposite appears to be the case for the feedback received regarding requirements for manufacturers – that the current regulations are not sufficient to properly regulate this growing industry. The sudden and extensive expansion of liquor manufacturing in BC calls for a set of clear entry and operational requirements that will maintain the integrity of the industry as a whole.

One issue that has come to the forefront is the practice of contract manufacturing. While the spirit and intent of the manufacturing licence places the expectation that manufacturers have equipment and actually manufacture liquor, some licensees simply acquire liquor to sell under the licence without manufacturing any product themselves. Feedback from industry suggests this practice may compromise the integrity of the liquor manufacturing industry as some licensees do not make the capital investment into equipment and simply distribute the product. These manufacturer licensees are then eligible for endorsements such as a store and lounge. It can be argued that this creates an unfair, and in some cases unlawful, competitive advantage as well as potentially compromising the industry by misleading consumers about the true source of the product.

Government would like to hear the opinions of industry on this practice and whether or not this type of business has a role in the BC liquor industry. Some jurisdictions have permitted these types of businesses through specific licences, while others have restricted them by imposing and enforcing strict minimum requirements (production and equipment). BC currently has minimum production requirements for wineries but not for breweries or distilleries. While setting and enforcing minimum equipment and production requirements may reduce contract manufacturing, they may also create a barrier to entry for genuine small production manufacturers. Furthermore, minimum equipment requirements prohibit and discourage the use of cooperatively owned equipment (and other innovative alternatives to large capital outlays).

Part 1: Questions

Through this consultation, government would like to hear the comments of current manufacturers and applicants on the elements of a modern regulatory structure for manufacturers, contract manufacturing and other related topics. Prior to answering the questions below, please review the LCLB and LDB requirements inventory in Appendix A of this document.

1. What basic requirements should be part of the regulatory structure for liquor manufacturing in BC? (please answer for your type of manufacturer licence only)
2. Are the current provincial (LDB, LCLB) application requirements for manufacturers reasonable? Why or why not?
3. Are the current provincial (LDB, LCLB) reporting requirements for manufacturers reasonable? Why or why not? Please be specific on which requirement(s) (LCLB or LDB) you are commenting on.
4. Are the current equipment requirements reasonable? Why or why not?
5. How would a change in minimum production or equipment requirements impact your business?
6. Are the current production requirements (wineries only) reasonable? Why or why not?
7. Are the criteria for inclusion as a land-based winery reasonable? Why or why not?
8. Should minimum on-site production requirements apply to some licences and not others? Why or why not?
9. Should there be a distinct licence for contract manufacturers or those that rely on them to produce the bulk of their product? If so, what type of entry and operational requirements are appropriate and why?

Part 2: On site consumption

Currently, most manufacturers choose to apply for one or more of the licence endorsements that permit the sale and consumption of their products on site. These endorsements are tour area, picnic area, lounge endorsement and special event area (SEA), and were designed to allow wineries to showcase their products at the winery site.

The first on-site consumption endorsements were the winery picnic and tour areas and then, as the wine industry grew, the lounge and SEA were added. With the rise of the small brewing and distilling industries these endorsements were extended to all manufacturers in 2013. This layering over time has resulted in a complex application process and a confusing enforcement and management situation for licensees and Liquor Control and Licensing Branch compliance staff. The LPR's recommendation # 27 calls for a review of endorsement areas.

LPR feedback has suggested that some licensees, particularly those who routinely hold large events (such as weddings) as part of their business, would appreciate the ability to serve all types of liquor in their manufacturer lounge or SEA. In permitting any expansion around the types, places and times liquor is served, the LCLB must balance community standards around noise and disruption to the surrounding area. In regions where there are high concentrations of manufacturers who hold frequent large events, local governments and neighbors continually seek ways to reduce the often significant, ongoing impacts of these events while still supporting the manufacturing industry. The Agricultural Land Commission (ALC) permitted uses for Agricultural Land Reserve (ALR) land must also be adhered to and licensees located on the ALR are responsible for ensuring their activities/events are permitted uses under ALC regulations.

Even without an event business, many licensees would like to provide greater on-site liquor options for their visitors. The Agricultural Land Commission recently changed its regulations so the type of liquor that manufacturers located on the ALR may serve is no longer restricted. Government is considering a change to the Liquor Control and Licensing Regulation that would permit lounges and SEAs to serve a limited amount of outside liquor.

Operating policies for endorsement areas are layered and can be complex to navigate as different endorsement areas have different rules. For example, service is prohibited in the picnic area but customers may buy a drink from one of the other endorsement areas, including a bottle of wine from the store, and carry it out to the picnic area to consume. Sometimes the picnic area can be activated as the SEA and service is then permitted. Also, some endorsements may overlap, such as the store and the lounge, but if there is a food primary or liquor primary on site no overlapping is permitted.

A goal of this regulatory review is to look for ways the current endorsement structure can be simplified so it is both easier to understand for customers and licensees, and easier for the LCLB to monitor.



I just wanted to address the worries you expressed around the review being incomplete/ farce etc. Government did announce the ability for manufacturer lounges and special event areas (SEAs) to serve a limited amount of all types of liquor at the same time as this review is taking place. There are some constraints around this ability because of its interim nature (see full policy directive [here](#)) . The consultation, which is much broader, and the associated questionnaire went out prior to (but very close to) the announcement so I know it seems odd to ask a question about it here (although a smaller consultation paper went out to manufacturer industry associations in June about this policy outlining the possible interim solution). I am hoping manufacturers will have ideas about how this Liquor Policy Review recommendation (#28) could be implemented long term as we construct all new regulations.

Also would you be interested in being involved in a focus group in the fall? I am trying to time them after crush and before Christmas so they will likely occur in November.
