Hi Lorne,

The Craft Brewers Guild provided a submission on the wholesale mark up in meetings with PS John Yap last fall. They have requested that government reduce the markup starting point and scale accordingly for craft breweries that produce under 200,000 hectoliters. Secondly, they have recommended an increase in the wholesale markup on global beer producers ('big beer').

The submissions from all stakeholders have been collated and analysis is currently underway to support the development of recommendations by PS John Yap and government decisions in the coming months.
