This is to advise that on Friday, 2003Feb07, agents employed by the Liquor Control & Licensing Branch were employed to determine the level of compliance with the above regulation within your establishment. These agents are all between the ages of 19-25 and all appear to be under the age of 25. They all carried the required 2 pieces of approved identification and were under the supervision of a Liquor Inspector.

The result of this inspection showed that your establishment was not in compliance with Section 45 (2) LCL Regs. (copy attached), in that the agents were either asked for no identification at all or were not asked for the required 2 pieces of approved identification. In all of these inspections anywhere from 2 to 3 agents entered your establishment during the inspection and they were able to enter and /or purchase alcohol within your establishment.

You will find enclosed a Contravention Notice which details the alleged contravention, You will be contacted by a Liquor Inspector within 30 days advising of any further action deemed necessary by the Branch. This will include attendance at a mandatory Compliance Meeting.

I must remind you that the Branch takes the issue of access by minors to alcohol as a serious public safety issue. The attached regulations require the **mandatory** ID check on all persons who appear to be under 25, every time they enter the premises. We expect that you will take immediate steps to come into compliance, as these inspections will be carried out on a continuous basis.
