

- 1. Set out the branch's allegation(s) of non-compliance with the Act, and or the Liquor Control and Licensing Regulation (the Regulation) and or the terms and conditions of the licence.
- 2. Provide a narrative of events.
- 3. Describe the evidentiary basis for the elements of each alleged contravention,
- 4. Provide reasons why the branch is pursuing enforcement,
- 5. Provide reasons why the branch believes the particular enforcement action (i.e. penalty) proposed is warranted, and
- Outline the licensee's options and the branch procedures that will be followed depending on whether or not the licensee disputes what is being alleged.

Included with this NOEA is the licensee's enforcement history and an explanation of how that history will be applied in any hearing decision of the general manager.

2. NARRATIVE

The Golden Spike Pub located at 3224 St. John's St Port Moody, BC holds a valid Liquor Primary Licence expiring July 31, 2012. The hours of operation approved by the General Manager are 9:00 am – 2:00 am Monday –Sunday. This establishment has two patios identified as Patio 1 and Patio 2 as well as a Pub area identified as Person 01. The person capacity is 250. Patio totals are taken from the person capacity and have no designated amounts.

While on duty March 11, 2012 00:10 a.m. Port Moody-Police Officers Cst Boechler, A/Sgt Faulkner-and others attended the Golden Spike Pub to conduct a "licensed premise check" known as an LPC. During the LPC they noted that the establishment was crowded and possibly over capacity. With little room to move Cst Boechler inquired about person capacities. A/Sgt Faulkner advised Cst. Boechler that the licensee Cheryl Semeniuk had indicated that the licence allowed for 250 persons. Cst. Boechler requested a mechanical counter and was directed to the front doormen. Neither doormen had mechanical counters so a doorman s.22 left to get one. The doorman known only as s.22 never returned. Another unidentified male staff member returned approximately ten minutes later with a mechanical counter and a clip board. The counter indicated 274 and the clip board had several marks and numbers crossed out with the final number being "- 36". These numbers represented 274 persons who had entered and 36 persons who had left.

It was at this point Cst. Boechler started a systematic patron count with a borrowed mechanical counter from the Golden Spike Pub. Cst. Boechler was familiar with the use of the mechanical counter and how to accurately count people as she had worked in a licensed establishment in the past. Cst. Boechlers first person result was 374. Cst. Boechlers result was shared with A/Sgt Faulkner who requested a second person count. A second count was conducted by Cst. Boechler with a result of 383. During the second count 12 people were observed leaving and with no persons entering. At the conclusion of the second count Cst. Boechler physically showed and told Cheryl Semenuik of the results. According to A/Sgt Faulkner Cheryl Semenuik did not appear concerned by the results. She explained she was having difficulty with people leaving the bar with stamps (inked wrist stamps) and then re-entering through the rear entrance where people smoke. They also had an over flow of customers who watched the Canucks Hockey Game earlier and decided to stay for the evening. Traditionally the hockey patrons leave at the conclusion of the game.

Convinced that person capacity exceeded 250 patrons Cst.Boechler completed LPC B092302 "overcrowding" contrary to section 6(4) Liquor Control and Licensing Act. LPC B092302 signed and served on Managing Partner Cheryl Semenuik.

From LCLB Documentation obtained by Inspector Farina dated June 1st, 2004 "Person Occupant Loads" were confirmed as 250 Persons.

Inspector Farina Served Contravention Notice B012267 for Overcrowding to Assistant Manager Dan LNU March 17, 2012.

3. THE ELEMENTS OF THE ALLEGED CONTRAVENTION(S)

3.1 Overcrowd beyond person capacity more than occupant load, s. 6(4) Reg.

The number of persons in the establishment exceeded the licensed person capacity, and

The licensee knew or ought to have known that the establishment was overcrowded.

The number of persons was greater than the occupant load of the establishment.

Other Factors:

Typically there are 25 staff members working on a Saturday Night according to Managing Partner Cheryl Semeniuk.

First Count by Police - 374, 124 (49.6 %) over maximum allowable when 25 staff not included.

With 25 staff added the count increases to 399, 149 (59.6 %) over maximum allowable.

Second Count by Police - 383, 133 (53.2 %) over maximum allowable when 25 staff not included.

With 25 staff added the count increases to 408, 158 (63.2 %) over maximum allowable.

4. REASONS FOR PURSUING ENFORCEMENT

4.1 Overcrowd beyond person capacity more than occupant load, s. 6(4) Reg.

Licensees that exceed their capacity by overcrowding are operating contrary to public interest. Specifically, they are operating contrary to the principles of public safety, community standards and the term and conditions of their license.

The issue of public safety is most apparent when volumes exceed the person capacity or occupant load. Exiting a building safely during a fire or other emergency event is difficult.

It becomes even more difficult when the place serves liquor, lighting is low and there is generally a lot of noise. The ability for emergency personnel to respond quickly to an event is significantly reduced by overcrowding. This may cause serious injury or death.

The public interest and community standards are relevant to the contravention of overcrowding. The maximum capacity established for a liquor primary is the result of community input during the licensing process. Maximums are set to reduce the risk of negative impact on neighbourhoods and communities. These negative impacts include but not limited to noise complaints, disturbances, parking and other related traffic flow issues. Permitting licensees to exceed their approved capacity minimizes and in some cases negates community input.

In this case, the Golden Spike Pub exceeded the person capacity of 250 as well as the building occupant load. The person capacity includes Patio 1, Patio 2 and Person 01. The two counts conducted by Cst. Boechler with a mechanical counter confirmed that this licensee had exceeded their person capacity. When the licensee Cheryl Semeniuk was presented with the results she did not appear surprised.

Based on the Port Moody Police officer's observations and specifically Cst. Boechlers two counts it confirms that the licensee did not have adequate measures in place to monitor the number of persons entering and remaining in the establishment. The result being extreme overcrowding.

5. REASONS FOR THE PROPOSED ENFORCEMENT ACTION (i.e. penalty)

5.1 Overcrowd beyond person capacity more than occupant load, s. 6(4) Reg. : six (6) day suspension proposed

For the alleged contravention of overcrowding beyond person capacity more than occupant load, s. 6(4) reg. (Contravention Notice Number B012267), a suspension penalty of six (6) days is proposed. This recommended suspension penalty falls within the penalty range set out in schedule 4 of the Regulation for a first contravention of this type.

The suspension will be served starting on a Saturday and will continue on successive business days until completed.

The licensee is responsible for managing and controlling their establishment. The person capacity overages are excessive with little regard for public safety.

First Count - 374, 124 (49.6 %) over maximum allowable when 25 staff not included. With 25 staff added the count increases to 399, 149 (59.6 %) over maximum allowable.

Second Count- 383, 133 (53.2 %) over maximum allowable when 25 staff not included. With 25 staff added the count increases to 408, 158 (63.2 %) over maximum allowable.

Operating a Liquor Primary licensed premise contrary to the public interest can have

considerable negative impact such as noise (inside and outside) drunkenness and unruly patrons all of which are disruptive to the community. Significant resources may be required by the Port Moody Police Department or LCLB personnel to ensure compliance.

Although the Port Moody Police Department enjoys a positive working relationship with the licensee they have a real concern regarding public safety at this licensed establishment.

A license suspension gives the licensee an opportunity to refocus and retrain staff on the importance of providing a safe environment for patrons, staff and others who might frequent their establishment. It re-enforces the importance of community safety and the strict adherence to accepted community standards.

Due to the seriousness of this contravention the recommended penalty is necessary to ensure future voluntary compliance.

6. THE PROCEDURES

The licensee may agree with or dispute the above allegation(s) and proposed enforcement action.

If there is a dispute, the general manager will decide if the contravention(s) occurred and what enforcement action, if any, is warranted. A hearing may be scheduled for that purpose.

If the general manager decides that enforcement action is warranted, the general manager will determine what enforcement action will be imposed on the licensee. The general manager may

- Impose a suspension of the liquor licence for a period of time
- Impose a monetary penalty
- · Cancel the liquor licence
- · Rescind, amend or impose new terms and conditions on the licence
- Order a transfer of the licence

Imposing enforcement action is discretionary. Where the general manager finds that a suspension or monetary penalty is warranted the general manager must follow the minimums set out in Schedule 4 of the Regulations. The general manager is not bound by the maximums and may impose a higher suspension or monetary penalty when it is in the public interest to do so. The general manager is not bound to order the enforcement action proposed in this NOEA.

Schedule 4 of the Regulation sets out the range of enforcement actions when a contravention occurs in an establishment within a 12 month period of a contravention of the same type. It is the date that the contravention occurred that is used for the purpose of determining if a contravention is a first, second or subsequent contravention for penalty purposes.

If the licensee agrees that the contravention(s) took place and accepts the enforcement action proposed, there is no need for a hearing. In that case, the licensee must sign a document called a waiver. By signing a waiver, the licensee irrevocably

- · Agrees that the contravention(s) occurred,
- · Accepts the proposed enforcement action,
- Agrees that the contravention(s) and enforcement action will form part of the compliance history of the licensee, and
- · Waives the opportunity for an enforcement hearing.

If you do not sign a waiver, the branch will schedule a pre-hearing conference for you to discuss the hearing process with the branch registrar and the branch advocate.

Port Moody Police have concerns with the number of calls for service at the establishment specifically on Saturday nights. The issues include fights and intoxication, which then impact the surrounding area and police resources.

The licensee has been provided with a copy of the Liquor Primary Terms and Conditions Guide (October 2013 edition).

Section of the Act, Regulation, or T&C Guide Reviewed at the Meeting:

Contravene term & condition, s. 12 Act. Terms and Conditions of license are requirements of licensees that are set by legislation, regulation, or branch policy. All license terms and conditions must be followed. Not following them may result in endforcement action.

Minimum Monetary and/or the Minimum Suspension for a first contravention of the above cited section of the Act or Regulation is a \$1000-\$300 monetary penalty and or 1-3 day license suspension

Operate contrary to the public interest/disturb persons in the vicinity, s. 20(1)(c.1) Act

Noise emanating from a licensed establishment or from patrons entering or exiting the establishment may disturb neighbouring businesses and residents. Indecent or illegal behaviour by patrons entering or exiting the establishment may result in property damage and / or public safety concerns.

Regard for community standards is one of the two operating principles that guide the branch's regulation of liquor. While it is not the intention of the branch to make licensees responsible for policing the streets around their establishments, the operational practices of licensees influence whether an establishment has a negative or positive effect on the surrounding community. Licensees cannot prevent every incident occurring around establishments, but they do have an influence over the number and severity of incidents and their effect on people in the vicinity.

Minimum Monetary and/or the Minimum Suspension for a first contravention of the above cited section of the Act or Regulation is a \$7500- \$10,000 monetary penalty and or a 10-15 day license suspension.

Permit intoxicated person to remain, s. 43(2)(b) Act

To avoid the possibility of further liquor consumption and avoid any harm to other patrons or staff, a licensee must not permit a person who is intoxicated to remain in the part of the establishment where liquor is served. To ensure their safety, intoxicated persons may remain in unlicensed areas of an establishment while waiting for assistance or a ride home.

Minimum Monetary and/or the Minimum Suspension for a first contravention of the above cited section of the Act or Regulation is a \$5000-\$7000 monetary penalty and or a 4-7 day license suspension.

"Events" include calls for service, on view events reported by officers, citizen complaints and/or various offences (ie. Criminal or other statute, like LCLA). > Out of 161 events total, 66 general occurrence reports (GO's) were generated. GO's are completed when there is a substantial matter dealt with by the police that requires reporting and includes narrative details, offence details/arrests or other such information. > I then looked at what days of the week the calls were occurring on and whether any pattern appeared present. Sure enough, Saturday nights stand out as clearly busier than any other day of the week. > From my own personal observations over the course of this year, I can tell you that Saturday nights are busier and more problems seem to occur then, usually at bar closing time. > The kinds of files we are generating on Saturday nights include fight calls, disturbances, SIPP arrests and liquor enforcement stats (tickets for intox in public and the like). · The findings from analyzing the files do match my anecdotal observations as a patrol supervisor. > The primary concern for Saturday nights at the Golden Spike Pub are that with an increased attendance rate specifically on that night of the week, more people than normal empty onto the street at closing time. It may be that because it is Saturday night people are also more intoxicated than other days of the week and willing to stay out later. This leads to more street-level behavioral issues than we are seeing at any other time. > The pub staff routinely clear everyone out of their parking lots at 0215 hours, which then leads to the large groups mustered on the sidewalks and left for the police to deal with if necessary. Often there are many people waiting for cabs or continuing to socialize. This tends to lead to fights, disputes, yelling, shouting, jaywalking, jockeying for

cabs in the roadway and generalized disturbances in and around the apartment buildings also at that location. Open

> All of these above issues cause our police department to routinely send some or all of the on-duty patrol members
on Saturday nights to the pub's immediate vicinity to try and provide sufficient police presence to quell the issues.
We usually are there from 0130 to 0300 as it takes that long to disperse the people and problems. Often times the
problems are so blatant that we directly observe or intervene in any number of ways.
