I started making edits, but I actually am okay with these responses. I added in one small change to the second response. Feel free to make edits and send them back to me if you have a different opinion.

I understand there is a \$500 per year subsidy for eligible individuals who are receiving disability or income assistance for the counselling portion of methadone dispensing.

The ministry has a supplement for the cost of alcohol or drug treatment, counselling or related services. In July 2016, the ministry changed the policy and began to cover the full cost of methadone counselling programs.

What is the largest amount a clinic has charged for methadone clinic fees for the counselling portion? I understand that where this fee exceeded the \$500 subsidy, disability/income recipients had the amount deducted from their cheques. What was the largest amount ever deducted? Can you give an example of what would be a large amount? I note the plaintiff's case had an example of approximately \$18.

The monthly amount charged for methadone clinic fees is set by individual clinics. This amount varies by clinic and has changed over time. However, a common example is a clinic charging \$65 per month. In this scenario, prior to July 2016, the individual would have had about \$23 deducted from their cheque.

The information I have received regarding the total amount to be paid back, including interest, would be \$5.85 million. Is this correct?

\$5.7M

I understand there are 12,000 people in the "class" of patients eligible for repayment, is this the ministry's understanding?

11,700

Has the ministry stopped deducting monies from disability and income assistance recipients for the provision of counselling for methadone treatment? If so, when was this practice halted?

Yes as per the above, this took effect in July 2016.

HEALTH is responding to the following questions.

I understand there is an interaction fee of \$7.70 and a \$10 dispensing fee that was initiated on June 1, 2015, pursuant to s. 4 of the Pharmaceutical Services Act... under plan C?

I understand there is a MSP payment schedule payment of \$22.85, payable once per week for any visit, called item T00039.

Any clarity you can provide on these? How often are the \$7.70 and \$10 charged? Is the \$22.85 per person, per visit, limited to once per week?

The \$500 then is only subsidized for eligible patients, in other words non eligible patients would foot the counselling costs themselves?

Hi Jayne,

I hope all finds you well. We haven't yet had the pleasure of meeting since I joined TELUS a few months ago. I hope to remedy that soon. I wanted to put on your radar an important development related to our TELUS/BC Internet for Good Program.

My Community Investment colleagues are engaged with members of your department on matters related to our Internet for Good Program. We are proud that as a result of the BC program, we were able to provide low cost internet to close to 2.3K low income families in BC.

The federal government took notice of the BC program and engaged TELUS to share its experience in leading the establishment of such a program with the government and other carriers.

Based on these discussions, ISED today announced the launch of a national *Internet for Good*-like program called 'Connecting Families' with other carriers. <https://www.canada.ca/en/innovation-science-economic-development/news/2018/06/government-of-canada-improves-telecommunications-services-for-canadians.html>

The national program will offer at least 10Mbps and 100GB of data for \$10/month to anyone receiving the maximum child care benefit. **See below FAQ for details.** While the services and pricing offered under the national program differ, the program is based on TELUS' *Internet for Good* program jointly launched in BC and AB in 2016 and 2017 respectively for single parents on provincial income or disability assistance (provincial programs offered 25Mbps and 300GB of data for \$9.95/month).

The announcement is great news for citizens and expand access to internet for low income families. Further, the national announcement will leave space for us to continue to work with the Province on delivering the provincial *Internet for Good* program. The TELUS/Province of BC program remains best in class.

We look forward to exploring how the provincial and federal program can continue to run in parallel, and how we can build on the success of our 2016 program – including scope and the possibility of a next round of mail outs via the provincial program so that we may work together to support even more British Columbians through this program.

I have also sent a note to ADM Chris Brown and A/Executive Director Kerry Taylor to apprise them of these developments.

Connecting Families Q&A (ISED)

Q1: What is Connecting Families?

A: Connecting Families will help bridge the digital divide for low-income Canadian families who may struggle to afford access to home Internet. As part of this program, Bell, Cogeco, Rogers, SaskTel, Shaw, TELUS, and Videotron will voluntarily offer discounted home Internet service to low-income Canadian families that qualify.

Q2: Why is this initiative being offered?

A: Currently, 1.2 million Canadian children live in poverty¹ and almost half of Canadian households with an annual income of \$30,000 or less do not have access to the Internet². Around 70% of teachers assign homework that requires Internet access and students with Internet access at home have a 7% higher rate of graduation compared to those without³.

Access to high speed Internet in today's world is essential. Connecting Families will enable more Canadian families to gain access to the valuable resources available on the Internet, and ensure learners have the tools they need to succeed as they work toward completing high school and/or pursuing post-secondary education.

Q3: What will participants receive and when will it be available?

A: Eligible participants will receive home Internet service for \$10 per month (plus tax). Each Internet Service Provider (ISP) will offer at least 10 Mbps download speed (*or the fastest available if less than 10 Mbps*) and a minimum of 100 GB of data usage each month, with no equipment or installation fees applied.

Our objective is to have this program available in the fall of 2018, but final dates are still to be determined.

Q4: I am a low-income Canadian, should I call my local ISP right now to register for this initiative ahead of the fall 2018 launch?

A: No, eligible participants will be contacted through a direct mail-out starting at the launch of the initiative in the fall of 2018.

Q5: What are the eligibility criteria and how were they determined?

A: The initiative was designed to connect low-income families to the Internet. The lowest-income families, those that currently receive the maximum Child Care Benefit (CCB), are eligible for this initiative. Eligible families will be contacted via a mail-out starting in the fall of 2018. This is a good start in addressing both affordability and access barriers for those with the lowest income in the country. Interested eligible families will be connected with a participating ISP through a secure online portal which will ensure that the privacy of participants is protected. ISPs are not responsible for determining eligibility and will not have access to any taxpayer information.

Q6: Do newcomers to Canada qualify for the CCB and can they participate in this initiative?

A: People who are residents of Canada for tax purposes are eligible for the CCB and therefore are potentially eligible for this initiative. More information on the CCB can be found on the CRA website:

Q7: Will there be a limit on the number of customers who can participate?

A: Up to 220,000 households could sign up for this initiative. Eligible participants will be contacted through a direct mail-out starting at the launch of the initiative in the fall of 2018.

Q8: How do I access this offer?

A: We anticipate that the initiative will be launched in the fall of 2018. To facilitate the application process, the federal government has partnered with Computers for Success Canada, a not-for-profit organization, to develop a secure online portal that will enable eligible low-income families to access discounted Internet from participating ISPs. Eligible families will be contacted via a mail-out once the initiative has launched and will be provided with details on how to sign up.

Q9: When will the initiative be available?

A: The objective is to have this initiative available in the fall of 2018. Stay tuned for more details on how the initiative will be rolled-out to ensure the best customer experience.

Q10: I am currently in a contract with my existing ISP. Can I still join this initiative? Will I have to pay a cancellation fee or early termination fee?

A: Each ISP is responsible for implementing the initiative for eligible participants. If you are eligible and choose to participate, your ISP will work with you on an individual basis to access the initiative. If you are currently in a contract or received a promotional offer, you may be required to pay the remaining value of that offer or contract.

Q11: Can I get a higher speed and pay the difference, or a larger data bucket?

A: Each ISP determines the speeds and data buckets available to customers eligible for the initiative. The minimum download speed is 10 Mbps (or the fastest available if less than 10 Mbps) and minimum data is 100GB per month.

Q12: How long is the initiative being offered?

A: Connecting Families is being offered until March 31, 2022.

Q13: What happens if my income is different from year to year?

A: The eligibility of participants will be verified annually, and only those who remain eligible will continue to receive discounted Internet through Connecting Families. Details regarding the renewal process will be provided at a later date.

Q14: Is this the true cost for ISPs to provide service?

A: No, the cost to provide this service is higher than the \$10 monthly fee. The participating ISPs volunteered to support this initiative, an investment they committed to make for the future of Canadians. There is no government subsidy and no cost to taxpayers or the government.

Q15: Who is paying for this?

A: The discounted offer is entirely funded by the ISPs, at no cost to taxpayers or the government. The Government is not subsidizing ISPs to provide discounted Internet.

The federal government has partnered with Computers for Success Canada, a not-for-profit organization, to develop a secure online portal that will enable eligible low-income Canadian families to access discounted internet service from participating ISPs.

To help close gaps in accessibility, this initiative will also distribute up to 50,000 computers to eligible families through the Government of Canada's [Computers for Schools](#) program.

Q16: Will my ISP have access to more of my personal information than they would in a regular service contract?

A: No, ISPs are not responsible for determining customer eligibility and will not see taxpayer information. The protection of customers' privacy is of paramount importance to Canada's ISPs. If you decide to participate in the initiative you will need to provide your address and a piece of valid ID to your ISP.
