It is an honour to share with you the attached BC Coalition to End Youth Homelessness Provincial Meeting Report which provides a visual record of the day's activities and outlines "next steps" identified at the meeting.

Your generous support for this event and your gracious participation enabled us to engage government, community and youth representatives in thoughtful discussions of priorities that need to be considered and address as we move towards the vision of a provincial plan that ensures every youth has a way home.

It was so valuable and important to have had both of you join us! Hearing your support for addressing youth homelessness was the highlight of the day for many. The efforts you have made in such a short amount of time has made significant differences on the front-line and given hope to many who are struggling to address the many issues that place youth at increased risk of exploitation and homelessness.

As you know, the goals for this meeting were to identify steps toward the realization of our goal to end youth homelessness in BC and to begin working together with provincial representatives to establish a provincial plan by January 2019.

Also attached is a media release that we are planning to send out on Monday, June 11 to coincide with the release of the report. This is intended to highlight that the provincial meeting was a milestone in government engagement with BC communities and youth voices towards a provincial plan to end youth homelessness. It is also intended to express our gratitude to both of you for your support in making this issue a priority and making this important event possible.
