Dear Minister Simpson:

On December 6th, 2018 we sent a request attached to an email asking for a meeting with you to discuss our concerns about the increased size of the employment Services catchment areas. You directed our request to Hovan Baghdassarian, Ex. Director, WorkBC Operations. As the RFP was still in active procurement, he could not meet with us at that time, but willing to meet with us once procurement was complete. Now that it is complete, we will proceed with that meeting.

We would like to share with you the paper that outlines the effect in rural communities as a result of the increased size of the catchments for EPBC.

It would be an understatement to say that we were disappointed in the creation of larger catchments. Our disappointment was matched with our surprise that this approach came with the New Democratic Party in power. Our disappointment certainly lay in the fact that we could not compete financially, nor do we have the capacity, to go up against large corporations. But **more importantly**, our concern is for the profound impact on rural communities. As you will see in the attached paper, services to rural communities throughout the province have been reduced. This is contrary to what you said on the conference call on February 6th, that services have been increased and that more people can access services.

We also want to point out to you, that although we are deeply concerned, we continue to support the NDP and the strategy toward poverty reduction. Rather than submit our paper to the opposition which could turn this into a political hot potato (urban vs rural divide) we want to work with you and your staff

to seek ways of meeting the needs of employment in rural communities through the work of community-based service providers.

Thank you for your time on this matter. And thank you for your work toward reducing poverty in our province.
