- To help us with that we will be meeting with Indigenous Groups, local governments, business leaders and the disability community. I want to hear about their experiences and how we can make life better for people in our province. I also meet regularly with a panel of experts and academics.

- There are a number of ways the public can get involved and help shape the Poverty Reduction Strategy.
- There is a public meeting in Prince George on February 7, it's one of 20 community meetings that will take place between now and the end of March.
- I hope that many people will attend and share their ideas on how to reduce poverty in Prince George and the Province.
