First off, I would like to thank you Craig for your quick response to the initial emails from \$.22 . Also thank you to \$.22 for your excellent advocacy. You have raised some important issues that need to be addressed.

Craig – I just completed a meeting with s 22 — and she has provided some important information to help be better understand he experience as a disabled person and specifically parking, but it goes much further than that.

Following my conversations with them, we would like to accept the offer of meeting with you and other Ministry officials to discuss this issue further. There are a few concerns which I feel need to be canvassed in more detail.

- 1. Who was consulted on this decision? From the information I have received it does not appear that many (if any) organizations representing disabled people were consulted about this decision.
- 2. Disabled people are currently finding it difficult to locate parking spots that are suitable for wheelchairs. As \$.22 pointed out to me there are regular spots with a painted sign and then there are those that she can actually use.
- 3. This brings me to the biggest challenge with deferring to the municipality with no minimum standards, each will define it as they see creating inconsistent across local government jurisdictions. In a place like the CRD (13 municipalities) it creates huge problems.
 - a. The result is that disabled people are less likely to leave their homes and more in danger of marginalization and lonliness.

It appears we need a minimum standard for municipal governments to meet and build on.

I have copied my Constituency Assistant Ryan Clayton who is \$5.22 until the end to the year and I am not available until the New Year as well. Ryan – please connect with Craig when you return and set up a meeting in January or February for us all to get together to discuss this further.

Thank you all for your work on bringing this important topic to discussion.
