Dear Mr. Horgan, Ms. Furstenau:

I am looking for information on how the BC Government will be handling the 60's Scoop settlement situation. I assume you are familiar with it, but if not please read this email string from the bottom.

Bottom line, many BC natives are eligible for a "60's scoop" payment of \$25,000. However, currently, the disability department of the BC Government has told my friend that they CAN take the Federal Government "60's Scoop" money, BUT if they do they will NO longer be eligible for their BC Provincial disability pension.

I would hope the BC Government wouldn't play games with this by taking people's disability away if they take the 60's scoop money and then use that as a way to get these people off disability, even though they are in legitimate need to be on it.

I would certainly encourage you to allow these payments without it affecting the disability status of the recipients. \$25,000 is hardly a major financial windfall that will change the life of the recipients to the extent that they can live on it and no longer require disability payments. It may allow them some new furniture or a better car, or buying better food but it won't change their basic need for long term disability assistance.

As well, there would be the boom to BC's economy if these payments were allowed. I don't know how many 60's scoop victims live in BC, but if it's even only 1,000, my calculations make that 25 million dollars added to the BC economy. You pretty much know that money will be spent by most of the recipients so this makes sense for BC's economy too.

Please don't punish the victims of the 60's Scoop again!

Has the BC Government made a decision on this?

For example, the family unit's scheduled child benefits payment may be reduced to less than the child benefits top-up supplement amount if the family had net income over the established child benefit threshold in the previous tax year.

The automatic child benefits top-up supplement is equal to the child benefits top-up supplement minus the actual child benefits payment.

Hi Kirsty,

Minister Simpson has heard from many Home Share providers over the last year and half regarding this and other issues that impact their work. He's aware that there are many long standing concerns for Home Share providers, and over the past months he's been talking with stakeholders, partner agencies, and front-line workers to understand the challenges they face.

As a first step, Minister Simpson directed Community Living BC (CLBC) to engage with Home Share providers and agencies to identify support needs that can improve the system. During the month of April 2018, CLBC conducted a survey of Home Share providers and met with people in the home share community. The feedback has been captured in the attached report.

This report reflects the voices of the Home Share providers —the people who not only support individuals with developmental disabilities, but who consider them a part of their family—and it provides the foundation for solutions going forward.

The minister understands that the challenges Home Share providers face did not materialize overnight. And while solutions cannot be achieved overnight, this report is an important first step in the right direction. With time and input from the Home Share providers, the minister is confident that the collective concerns can be addressed. Minister Simpson continues to meet with CLBC, Home Share providers, and other service providers to discuss these issues and next steps.

You may also be interested to know that the minister has initiated a process he's called Re-Imagining Community Inclusion. This is a broad group of people in the Community Living sector, including self-advocates and Home Share providers, who have been brought together to evaluate the goals and vision of CLBC and re-imagine what they would like the sector to look like in the coming years. This group has until the end of March to report back to the minister on their findings and plans for a way forward.

Minister Simpson has heard from many Home Share providers over the last year and half regarding this and other issues that impact their work. He's aware that there are many long standing concerns for Home Share providers, and over the past months he's been talking with stakeholders, partner agencies, and front-line workers to understand the challenges they face.

As a first step, Minister Simpson directed Community Living BC (CLBC) to engage with Home Share providers and agencies to identify support needs that can improve the system. During the month of April 2018, CLBC conducted a survey of Home Share providers and met with people in the home share community. The feedback has been captured in the attached report.

This report reflects the voices of the Home Share providers —the people who not only support individuals with developmental disabilities, but who consider them a part of their family—and it provides the foundation for solutions going forward.

The minister understands that the challenges Home Share providers face did not materialize overnight. And while solutions cannot be achieved overnight, this report is an important first step in the right direction. With time and input from the Home Share providers, the minister is confident that the collective concerns can be addressed. Minister Simpson continues to meet with CLBC, Home Share providers, and other service providers to discuss these issues and next steps.

You may also be interested to know that the minister has initiated a process he's called Re-Imagining Community Inclusion. This is a broad group of people in the Community Living sector, including self-advocates and Home Share providers, who have been brought together to evaluate the goals and vision of CLBC and re-imagine what they would like the sector to look like in the coming years. This group has until the end of March to report back to the minister on their findings and plans for a way forward.

Re: Budgeting question

Each year, CLBC forecasts the number of individuals who will become eligible for both the developmental disability and Personalized Supports Initiative eligibility streams. This is the basis for identifying overall funding required for support services. Once deemed eligible, support services for each person are determined based on disability related need, regardless of stream.

Re: Eligibility question

To be eligible for CLBC based on a developmental disability, one must meet three criteria established in the Community Living Authority Act and Regulation including: significantly impaired intellectual functioning; impaired adaptive functioning, and; onset before age 18.

These criteria are consistent with diagnostic criteria for an intellectual disability in the manual used by psychologists (DSM-5). You can find detailed information about these criteria in <u>CLBC's</u> <u>information sheet on eligibility</u> and CLBC's <u>Eligibility Policy</u>. Section 3.10 of the policy refers to the IQ requirements.
