PRAC Media Update

Dec. 2 – Dec. 17, 2019

Affordability

Last bills mark end of MSP premiums in B.C.

(Dec. 5) People in B.C. will receive their last bill for Medical Services Plan (MSP) premiums in December 2019, putting more money back into the pockets of British Columbians, as the B.C. government works to make life more affordable for all. As of Jan. 1, 2020, MSP premiums will be fully eliminated.

Better access for Kelowna families to affordable, quality child care

(Dec. 6) Child care is getting less expensive and easier to find in Kelowna as the province invests in 68 new child care spaces to give more parents the option to return to work, go back to school or pursue other opportunities.

New affordable homes for seniors coming to Salt Spring Island

(Dec. 9) Seniors with low to middle incomes will soon benefit from 22 new affordable rental homes, as construction begins on the expansion of Croftonbrook.

Affordable homes open for people in Williams Lake

(Dec. 11) People with low to moderate incomes, including those with disabilities, now have access to 39 new affordable rental homes in Williams Lake.

Better access to affordable, quality child care for Victoria families

(Dec. 16) Child care is getting less expensive and easier to find in Victoria as the Province invests in 260 new spaces to give more parents the option to return to work, go back to school or pursue other opportunities.

Better support for food security

(Dec. 5) The Province provided \$3 million to the Victoria Foundation in March 2019. \$1.1 million helped establish the new Food Security – Provincial Initiatives Fund. Opportunity

Young people get training, mentorship to work in arts, culture

(Dec. 4) More than 50 young people are getting on-the-job experience in the arts and culture sector, thanks to early career development grants delivered through the BC Arts Council.

B.C. investing in EV skills training for a cleaner, better future

(Dec. 4) With support from CleanBC, a new electric vehicle (EV) training program for automotive technicians has successfully completed its first pilot and will be available to the public in 2020.

Gang prevention program expands to keep more students safe

(Dec. 5) The Province is investing an additional \$4.93 million over the next three years to provide immediate support to students, parents, educators, law enforcement and community partners through gang prevention and awareness training programs in Campbell River, Chilliwack, Courtenay and Hope.

Skills training leads to encore careers for older workers

(Dec. 6) Melanie Mark, Minister of Advanced Education, Skills and Training, announced \$5 million in annual provincewide funding to provide skills training to 733 people aged 55 and older. The college is one of 17 service providers throughout the province offering locally designed programs over two years.

Skills training, job supports for those who need them most

(Dec. 9) New programs throughout the province will support British Columbians who face multiple barriers to employment to build the skills they need to embark on new careers. Nicholas Simons, MLA for Powell River-Sunshine Coast, announced \$10 million a year to support more than 1,100 people a year throughout the province.

Skills training supports people over 55 in Surrey

(Dec. 13) People aged 55 and older in Surrey are getting opportunities to build skills for new careers with training programs that break down barriers to employment for older workers. Seventeen skills-training programs throughout B.C. are receiving \$5 million annually to deliver locally designed skills-training programs and supports to an estimated 733 British Columbians a year.

Social Inclusion

Launch of connectivity fund creates opportunity for communities

(Dec. 2) The Province is now accepting applications for this historic \$50 million in grant funding for rural, remote and Indigenous communities to access grants for high-speed internet projects.

Gang prevention program expands to keep more students safe

(Dec. 5) The Province is investing an additional \$4.93 million over the next three years to provide immediate support to students, parents, educators, law enforcement and community partners through gang prevention and awareness training programs in Campbell River, Chilliwack, Courtenay and Hope.

Making travel in B.C. more accessible for all

(Dec. 6) Travelling in British Columbia will be easier for people with disabilities, as the Province and Destination BC embark on a multi-phased plan to make B.C. tourism more accessible and inclusive.

The capital projects program is part of the annual \$140-million Community Gaming Grants program supporting about 5,000 community organizations.

Reconciliation

New Indigenous court in Williams Lake

(Dec. 16) The provincial court chief judge has approved Williams Lake's proposal for an Indigenous court. The Province is working with Indigenous communities to establish Indigenous courts throughout British Columbia. These courts will help government build a justice system that better respects and addresses the needs of Indigenous peoples.

Our micro-homes will lift people out of tents and the elements and into a warm, safe and dry place while on the wait-list for more long-term residence.

When we talk about "the homeless" it's often in abstract terms but these are folks sleeping in the cold tonight and they are your neighbours, friends and family. Some people are uncomfortable in shelters and sometimes for good reasons. Others are ashamed and live in much harsher conditions because of pride. There are many unique predicaments that lead to lack of secure long-term housing that are well beyond the scope of this message.

However, we have a proposal that may offer comfort and security to some of our most marginalized citizens. The My Home 4 Now team has designed a micro home, in its most basic form, is a secure place to sleep and store one's personal belongings. The features are described in detail in the attached documents and the highlights are as follows:

- *Designed and manufactured in British Columbia
- *Walls, roof and floor panels are insulated with energy efficient Polyurethane Foam
- *Polyurethane has a Class 1 Fire Rating and is Moisture/Mold Resistant
- *Flat Pack and Forklift friendly
- *Single Unit shipping package is six feet by eight feet by thirty inches (6' x 8' x 30") and is about 500 lbs.
- *Similar footprint to a tent (6' x 8') but with a ceiling height of 7' one one side and 8' on the other
- *These micro homes can be assembled in under fifteen minutes, using just screwdrivers.
- *They can be disassembled in fifteen minutes

In a province where homeless people are asking to be allowed to live in their cars, surely we can do

better.

It will take some creativity and flexibility, but we believe that My Home 4 Now can be part of the solution and come together to try to help in a realistic and timely manner.



Please contact me if you have any thoughts to share. I will be happy to bring a small model of our home to demonstrate how it's assembled and discuss the variations that we can offer and the costs associated with them. I hope to hear from you soon, so that vulnerable people can sleep securely, possibly for the first time in years.

Public Interest Disclosure Act

What's happening?

The Public Interest Disclosure Act (PIDA) is now in effect for employees of provincial government ministries.

Reporting wrongdoing demonstrates our public service values and the accountability we have to citizens and colleagues. Under the <u>Standards of Conduct</u>, public servants have a duty to report any situation relevant to the BC Public Service Agency they believe contravenes the law, misuses public funds or assets, or represents a danger to public health and safety, or a significant danger to the environment, internally through the processes outlined in the Standards of Conduct under "Allegations of Wrongdoing." The Standards of Conduct makes clear the expectation employees are also required to report incidents of bullying, breaches of the Standards of Conduct and wrongdoing. We have always encouraged employees to speak up about wrongdoing – and when they come forward, we protect them against reprisal.

PIDA gives all ministry employees (current and former) an additional avenue to report serious wrongdoing and provides legislated reprisal protections and the option of reporting directly to the BC ombudsperson. Ministry employees can make a PIDA disclosure to their supervisor, ministry ethics advisor, the BC Public Service Agency designated officer, or to the Office of the Ombudsperson. The Act makes it an offence to commit or direct reprisal against an employee who makes a good-faith disclosure under PIDA or seeks advice about PIDA. The Office of the Ombudsperson's mandate also includes the responsibility of investigating reports of reprisal against employees.

With the implementation of PIDA, some employees in government ministries will have new roles and responsibilities. Ministry ethics advisors will assist potential disclosers by providing advice on process and receiving disclosures about wrongdoing.
