That's correct. The \$300 temporary COVID payment is an SDPR payment (like regular income and disability assistance payments) and does not have to be reported on a stub. However, if an individual has received CERB, or any other non-SDPR income, the individual does need to submit a stub. If an individual needs to submit a stub and does not want to attend the local office they can either:

- submit a stub via MySS or

- call 1-866 and request a stub be mailed to them. The ministry will also provide a self-addressed stamped envelope to return the stub via mail.

They would need to submit if they receive CERB but we are not asking all PWDs to submit and not asking anyone to report the \$300 they received from us. Trust that is correct?

Hey MLA Simons,

As part of the B.C. Government's \$5 billion COVID-19 Action Plan, a new \$300 monthly supplement was put in place to ensure that people on income or disability assistance and low-income seniors, do not encounter additional barriers.

These supports are designed to complement federal supports and fill in gaps for people who are not receiving the \$2,000 federal Canada Emergency Response Benefit.

If a PWD client is receiving CERB then they are not eligible for the \$300 crisis supplement. This is why if they are receiving CERB they must submit the documentation(a stub), because they will not receive the \$300. The provincial government has decided not to roll back regular disability assistance of people receiving the federal support, so they will receive their regular assistance rate just not the additional \$300.

If a PWD client is receiving income they must submit a stub because income above the current income exemption limit is not exempt and will affect their assistance rate. They will be getting the \$300 automatically as they are not receiving CERB.

If a PWD is not receiving CERB and does not have an income they will be getting the \$300 automatically and do not need to submit a stub.

If a client has a concern about being able to submit the proper documentation on time we encourage them to phone their local SDPR office for assistance.

I am happy to discuss further is there are more questions.
