Hi Krystal,

As mentioned the other day, we are looking to expand our Internet for Good program to cover individuals with a disability. We know that there are vulnerable populations in our communities living off of very limited means, and often relying on government assistance to get by. For many, things like internet access are beyond their means. For that reason, we are eager to expand our Internet for Good program beyond families accessing the Canada Child Benefit or on Income Assistance, to now include those accessing the provincial PWD assistance program.

This would be available in all our ILEC territories where we provide internet service (BC, AB, and QC). We are looking to put out individual news releases in each jurisdiction, announcing the new program for those eligible. We would very much like to include the government in celebrating this announcement with us, and would like to include a quote or quotes from relevant Ministers if you thought that appropriate. As you and I discussed, our initial thinking would be Minister Kang and Minister Simpson. However, I'm open to any recommendation or guidance you may have on that.
