To the management of s.22

My name is $\frac{s.22}{2}$ and I live in unit $\frac{s.2}{2}$. I am writing to book repairs for my suite that are long overdue and have become a health hazard.

When I first moved in in 2013, I noticed wood rot in my cabinet below the sink. It was odorous and there was visible moist wood. I noticed a similar issue in the cabinet right beside it, only in this case the wood surface was actually bowed and slightly collapsed from the damage. I wrote a maintenence request form describing the problem, that is in the buildings possession, and after having management look at it nothing was done. Months later there was water leakage below my sink that created a puddle. I wrote out a request form, and the leakage was mended...but the overall issue of wood rot was still not addressed. At this time I also asked about the wall in my kitchen that has a visible repair and raised bump in it, and was told this was due to a water damage issue that occured years earlier.

A few weeks ago I looked under my kitchen sink and noticed the wood rot had gotten much worse. I removed everything and saw that a small piece of the sink had fallen out of the wood, leaving moist wood fragments scattered around. I looked up and realized the wood rot was not just on the cabinet floor, but in the entire sink unit...not only this, but the cabinet floor had also collapsed and bowed like it did in the other cabinet described. This is no longer just a maintenence concern, but a health one. The probability of mold and the possible collapse of the unit is of serious concern to me.

When I had my walk through of the apartment in 2013, they were doing renovations in the kitchen and I'm assuming they didn't take in the severity of the wood rot problem. This has been an ongoing issue from the moment I moved in, and one that should have been addressed before I did...as the building has been aware of it for the over 3 years I've been here.

The sink and cabinet unit need to be completely replaced, and the cabinet beside it needs to at minimum, have the bottom shelf replaced. I would like to have a date for the repairs set within the next two weeks as I'll need to find somewhere to stay during that time.

This building has always been wonderful to me when it comes to repairs and I am truly grateful for that. I look forward to your response and resolution of this problem. I have been so happy here at the \$.22 and have been very proud to call this my home.

VANCOUVER HOMELESS CAMP

<u>Topic:</u> A homeless camp of about 50 people has been set up on a city-owned vacant lot at 58 West Hastings St. in Vancouver since July 9th.

- We are monitoring the situation closely and addressing the shelter needs of any homeless campers.
- Our outreach teams are attending the camp on a regular basis and offering shelter options to campers who are in genuine need of housing.

DTES Investments:

- Close to \$70 million was invested in the Downtown Eastside last year to support almost 4,000 housing units for the homeless. This includes:
 - o 540 permanent year-round homeless shelter spaces;
 - o Over 3,000 subsidized or supportive units; and
 - o 360 rent supplements to help people access rental housing in the private market.

Background:

About 50 people have been camped out on the vacant lot in the downtown east side in Vancouver since Saturday, July 9th.

There are about 47 tents set up featuring three specific populations: protestors, a group of people moving in from a private-sector SROs (this was an issue at the Oppenheimer Camp) and people in genuine housing need.

The campers are demanding that the City transform the site into social housing and that the City also provides porta-potties as well as wash stations. Their demands were not met by the Mayor on July 12th when the Mayor met with the campers.

Outreach teams are focusing on most vulnerable at site and those in need of housing.

Housing Investments in Vancouver

In 2014/15, the B.C. government provided over \$148 million to support affordable housing for more than 27,000 low-income individuals, seniors and families in Vancouver.

New Affordable Housing

- Since 2001, close to 7,600 units of affordable housing have been developed or preserved in Vancouver.
- More than 760 units are in development or under construction.

Homeless Supports Overview

Last year, over \$125 million was provided to support more than 6,400 housing units for the homeless or those at risk of homelessness across Vancouver, including:

- 740 permanent year-round homeless shelter spaces, close to 630 of which are provided through the <u>Emergency Shelter Program</u> (more than 130 of these are for women only).
- Close to 5,000 subsidized or supportive units for homeless or at risk individuals.
- · And approximately 730 homeless rent supplements.

Additional temporary shelter spaces were also available in Vancouver, including:

- 200 temporary HEAT shelter beds that continue to receive provincial funding until more supportive housing is built.
- Additional shelter spaces are available during extreme weather in several communities.

<u>Homeless outreach</u> and shelter workers across Vancouver connected people who are homeless or at risk of homelessness to housing, income assistance and a range of support services.

The B.C. government is investing close to \$300 million in a partnership with the City of Vancouver to build more than 1,500 new supportive housing units for those who are homeless or at risk of homelessness. Most of the developments are now open (see sidebar).

- Kindred Place (2009) Supportive housing units for people who are homeless or at risk of homelessness and those recovering from alcohol and drug dependencies.

Single Room Occupancy (SRO) hotels

- The B.C. government acquired <u>24 SRO hotels</u> in Vancouver, 20 of which are in the Downtown Eastside (DTES) and surrounding vicinity – protecting approximately 1,400 affordable housing units in Vancouver.
- The Province is investing \$143.3 million into the <u>SRO</u> <u>Renewal Initiative</u> to renovate 13 SROs under a publicprivate partnership. This includes \$29.1 million from the Government of Canada through the P3 Canada Fund. Lifecycle and facilities maintenance services will also be provided for these 13 SRO's for 15 years.

Since 2001, the B.C. government has developed or preserved more than 4,000 units for those who are homeless or at risk of homeless in Vancouver.

Support for People with Disabilities and Seniors

The B.C. government provides support to more than 12,000 seniors' households in Vancouver through a range of housing options, including:

- More than 2,900 households receive <u>Shelter Aid for Elderly Renters (SAFER)</u> benefits. The program was expanded in 2006 and enhanced in 2014 to better meet the needs of low-income seniors. With the new enhanced benefit, the average monthly payment is expected to increase from approximately \$150 to \$180.
- More than 2,600 seniors live in supportive and assisted living units in Vancouver.
- There are more than 6,400 affordable homes for independent seniors in Vancouver.
- The <u>Home Adaptations for Independence</u> program offers financial assistance for home adaptations to help eligible low-income seniors and people with disabilities improve accessibility and safety in their home.

More than 2,600 new units of housing for seniors and people with special needs have been created in Vancouver since 2001.

Families

The B.C. government provides support to more than 6,500 low-income families in Vancouver through:

- More than 1,300 low-income working families receive rent assistance to keep the cost of private market rental housing affordable (the majority receive monthly benefits from the <u>Rental Assistance Program</u>).
- Over 5,200 low-income families live in subsidized housing.
- There are 75 provincially funded spaces available for women and women with children who are at risk of violence.
- There are more than 1,200 units of designated Aboriginal housing in Vancouver.

Approximately 800 units for families have been created in Vancouver since 2001.

- Kettle on Burrard (2014) 141 units of supportive housing for individuals who are homeless or at risk of homelessness.
- Marguerite Ford (2013) 147 supportive apartments for people who are homeless or at risk.

- Sanford Apartments (2012) 62 supportive housing units for people who are homeless or at risk of homelessness.

Services and Supports for the Homeless: Vancouver

Over \$125 million was provided last year to support more than 6,400 housing units for the homeless or at risk of homelessness in Vancouver.

Emergency Shelters	Approximately \$27 million was spent last year to provide 740 permanent, year round homeless shelter spaces in Vancouver (close to 630 are funded through the <i>Emergency Shelter Program</i>).
Extreme Weather Shelters	Last winter, 260 spaces were available across Vancouver to increase emergency shelter space when extreme weather conditions threatened the safety and health of individuals.
HEAT Shelters	Last year, the B.C. government provided approximately \$4 million to fund more than 200 year-round, emergency shelter spaces through the HEAT project.
Winter Response Shelters	Each winter, depending on need, the Province opens temporary winter shelters in Vancouver that are available 24/7 during the winter months.
