Recognizing this is a marine spill and Coast Guard Lead, we've had and will enhance our resources on the ground this am as part of the integrated/unified response to this incident – the Manager for the Environmental Emergencies program will be at the Integrated Incident Command (ICC) Post, we have a number of Environmental Emergencies Response Officers (EEROs) on the ground, EMBC has staff integrated with the City of Vancouver since early yesterday afternoon to ensuring situational awareness within the wider Metro region and to provide supports to the ENV and other partners, and GCPE will have a public affairs officer in the ICC this morning.
