We need to raise wages in this province. At the very least, the minimum wage needs to be raised to \$15 in the city of Vancouver. Cities like Seattle, Los Angeles, and San Fransisco are all in the process of implementing \$15 minimum wages and now even Alberta is increasing the minimum wage to \$15. Thank you for your response.

Even if we are providing better opportunities to move up and away from minimum wage jobs, there will always be people earning minimum wage, and it should be enough to keep them out of poverty. I know that your government is planning on increasing the minimum wage by 2% per year- I'm very happy with the idea of increasing the minimum wage every year to keep up with inflation. However, since we have not been increasing wages every year for the past 30 years, they have severely lagged behind the increased cost of living. The only reasonable thing to do is boost the minimum wage by a large amount (\$15) over a moderate period of time (3 years) and THEN increase it every year with inflation. I want to high-light that \$15 is actually a conservative amount- the amount that two parents with two children would need in Metro Vancouver is \$20.86(each).

The supports that are mentioned in the news release are about making the transition from living on assistance to working easier. I think that's a good thing to do, but it's not directly relevant to what I'm saying. The POINT is that people who are working full time should not have to be living on assistance. Employers should have to pay their workers a reasonable salary (especially for Vancouver) and not rely on the government to fill the gaps.

I would also like to mention that I think that your statistics on the news release are misleading: 57% are part time workers - companies often prefer to hire people part time so that they don't have to pay them benefits and people often have to get 2 or more part time jobs to make ends meet.

7,800 (7%) were defined as being the head of the family -- part of this is due to the fact that the majority of minimum wage workers are women, who are probably less likely to define themselves as 'head of the family' - by the way, what a STRANGE way to poll. They could have just asked if they were a parent.

57,800 (52%) lived with their parents - maybe because their wages are way to low to have a decent life on their own. How would you like to live on less than \$20 000 a year in the one of the most expensive cities in the world?

Of the minimum wage earners living with their parents, 47% were attending school-- I don't see why the fact that university students earn minimum wage is an argument against increasing it. University is financially straining and these are adults who are working hard for very little. We allowed universities to have a big boost in tuition shortly after the liberals took office- maybe we could do something similar for students (and everyone else).

I don't see how any reasonable person could look at the cost of living, especially in Vancouver, and tell me that \$10.45 is enough to live on for a single person, let alone anyone with a dependent or anyone who has any notion of saving for the future. If you refuse to increase wages across the province I think you need to consider how we could increase it in Vancouver

only. We are living in an affordability crisis right now.

Subject: BC Minimum Wage Announcement

The Vancouver and District Labour Council represents 60,000 unionized workers with membership in over 100 affiliated unions in our region. We are strongly committed to improving the lives of all members of our community, regardless of whether they enjoy the benefits of a unionized job.

Lifting people out of poverty is one issue that impacts the whole community and significant improvements to the minimum wage must be implemented as steps towards a living wage for all.

It isn't just low waged workers who would benefit. Our provincial economy would be stimulated by a workforce able to buy more than bare necessities. Other benefits include reduced demands on our health care, social services, and other publicly funded programs.

Claims that small businesses can only survive if allowed to pay low wages are not borne out by experience. Further, it is mostly medium sized and large businesses that pay the lowest wages: 65% of the employers paying the minimum wage have 20 or more employees and nearly half have 500+ employees.

In this context we are completely dismayed by your March 12 announcement that the minimum wage would be increased by a miniscule 20 cents, and that these poverty wages would be further institutionalized by linking to the Consumer Price Index. Such indexing would be appropriate if tied to a reasonable starting point, but does not salvage your misdirected policy.

Women and their children are disproportionately impacted, as are immigrants and aboriginal people. These are people who have little voice in our society, which puts the onus on government to balance the inequality.

The VDLC will continue to promote and participate in the Fight for \$15 and Living Wage for Families campaigns because "work should lift workers out of poverty, not keep them there."

We urge you to revise your announcement with one that assures every British Columbian an immediate minimum wage of at least \$15.00 combined with a review system that maintains CPI increases combined with other factors with a living wage objective.
