It's the greatest reduction in unemployment in the country since the Jobs Plan was introduced.

That's the path to building our future ...
And we build on a strong foundation of fiscal responsibility.
With three consecutive balanced budgets, we are
unmatched in Canada when it comes to fiscal
responsibility.

Promise made, promise kept.

That's a collective achievement. It took all of us in BC to get here – we shouldn't forget that.

I also don't want people to forget how hard it is to climb out of a fiscal hole.

I've had to do it twice.

In 2002, after ten years of the NDP, and in 2011, after the global recession.

Many other jurisdictions tried to hold off on digging themselves out. We've already done it.

Back in September 2009, spending was expected to grow by an average of 3 per cent every year.

Thank you.

I want to talk to you today about all that our two societies have in common.

There are many differences. Korea is an ancient civilization; BC and Canada are recent creations.

And British Columbians are blessed to have good, trustworthy neighbours.

But there is so much more that unites us.

As the much of the world struggles to climb out of recession...

Korea is an example of what can be accomplished.

50 years ago, Canada and Korea first established formal diplomatic ties.

What Korea has accomplished in such a short time is nothing short of amazing.

It's something I see every time I visit. You're changing the world with leadership in fields like business, design, and innovation.

I've noticed the pace of growth even in the two times I've visited since becoming Premier, and discussed it with Governor Kim of our sister province Gyeonggi.

On the long flight home, I watched the movie Yuk-Rin: The Fatal Encounter.

There's a young king under attack by members of his court – and he prevails.

The king has a favourite Confucian verse:

"Do your utmost in the small things. Because when others see your utmost sincerity, they are changed by it."

That changes the world. Your sincerity changes the world by getting small things right.

That's something you have in common with British Columbia.

We are both sometimes overlooked. Even underestimated.

It's a mistake. Because British Columbians and Koreans both punch above our weight.

Our success has been due to controlling spending, and a growing, diverse economy, with diverse markets.

So while the global economic slowdown has affected B.C. – we have weathered it better than most.

We're one of just three Canadian provinces with a balanced budget – and the only one with three in a row, and a billion-dollar surplus.

And unlike some other provinces, BC isn't dependent on a single commodity – or one predominant trading partner.

We prize our reputation for stability, and as a safe harbour for investment.

It's reflected in our Triple-A credit rating, and in companies like the Korean Exchange Bank opening branches in British Columbia.

None of this happened by luck. I've focused on expanding our export markets, including and especially our partners in Asia.

Since I became Premier four years ago, five different BC trade missions have visited Korea – I led two of them myself.

We have had success. On my second trade mission...

- Samsung opened a research and development facility in Burnaby.
- UBC signed agreements with KOGAS and the Korea Institute of Science and Technology.
- Roadhouse Interactive partnered with Korea's Red Pig Games to adapt and publish video games.

But everything we accomplished together – all the partnerships we formed...could have been more.

For 10 years, B.C. has advocated for a free trade agreement between our two counties. It was long overdue.

Over those 10 years, Korea successfully negotiated agreements with the United States, European Union, and Australia.

So we have some ground to make up. That's a big part of the reason BC's exports to Korea actually declined between 2011 and 2013 – after years of steady growth.

Now that the free trade agreement is in place – the path ahead is clear.

With an even playing field - I like BC's chances.

The federal government predicts exports will increase by a third – boosting Canada's GDP by \$1.7 billion per year.

As we've seen, there are opportunities in everything from agrifoods and seafood to natural resources.

On my visits to Korea, what I've noticed is Koreans are getting increasingly refined in style, in design, in taste for things.

So what do Koreans want from BC?

It can be summed up in this word: Clean. Healthy and natural.

The best in the world

AGRIFOODS AND SEAFOOD

It starts with our agrifoods and seafood.

British Columbians take a lot of pride in the food we grow and catch here – from Okanagan cherries and wine, to the best salmon in the world. BC-Korea Trade and Investment Forum June 23, 2015 CHECK AGAINST DELIVERY

We see these are gifts – which we are eager to share with the world.

Until recently, B.C. exported \$8.1 million per year of fish and seafood to Korea – and that was with tariffs of up to 47 per cent.

The free trade agreement will eliminate 70 per cent of tariffs in the next four years – and 100 per cent by 2026.

The agreement also eliminates tariffs on 87 per cent of BC produce. BC cherries and blueberries had tariffs of up to 45 per cent.

With those eliminated, BC's farmers will have an even playing field...and Korean food lovers will have access to the world's best.

We're already seeing positive results: compared with the same quarter last year...

agrifoods exports are up 79 per cent, and seafood exports by 150 per cent.

NATURAL RESOURCES

While the free trade agreement will create opportunity across the board – it's natural resources that might be the biggest opportunity in the short term.

Because you know in BC...it is clean. Harvested and extracted at the highest standards.

So with tariffs eliminated in forestry and wood products, including biomass, and commodities like coal...

You can feel confident about the source.

Korea imports 98 per cent of its energy and British Columbia has a 150-year supply of the world's cleanest-burning fossil fuel.

Your neighbours in China are betting on LNG to power their growth while lowering emissions.

Cleaner air for them will mean cleaner air in Korea – and cleaner air in British Columbia.

This is nothing new in Korea, where they already lead the world in LNG imports, and stand ready to profit from it.

BC's LNG industry has come a very long way in a very short time.

We've put in place a tax framework that rewards investment, gives proponents certainty – and still gives a fair return to British Columbians.

We've established environmental regulation that will ensure BC has the cleanest LNG facilities in the world.

That's why there are 19 LNG proposals in the works – with \$12 billion invested in BC already.

And last month, we took our biggest step forward so far – an agreement with Pacific NorthWest LNG. That could be the first big project.

There are still two conditions to meet: One, the approval of the provincial legislature.

And two, a positive outcome in the federal environmental assessment process, along with continued constructive engagement with First Nations.

The project development agreement will be scrutinized and debated in the legislature.

And we will continue to do everything we can to work with Pacific NorthWest LNG and First Nations to ensure the highest environmental standards.

As we develop this industry – Korea has a major role to play.

In fact, the Korea Gas Corporation is already a key partner in the LNG Canada project in Kitimat.

And it's not just proponents. As we build export facilities, and supply clean power across the Pacific – opportunities will be created in services, manufacturing, workforce housing, and more.

That's why Husteel opened an office in Vancouver: LNG facilities need steel pipes.

CONCLUSION

Governments around the world are increasingly concerned with two things:

- Finding ways to maintain or renew economic growth;
- And finding ways to protect the water we drink and the air we breathe.

In BC, we've shown it's possible to do both. That's why leaders and investors around the world are taking notice.

BC and Korea share a lot in common – but the most important thing we share is an opportunity.

The Canada-Korea Free Trade Agreement clears the path for nothing less than a chance to build a better world.

A cleaner world. A more prosperous world, with more opportunity for people on both sides of the Pacific.

Let's have the courage to work together...to shape our future for our children and grandchildren.

Because by working together, we have a chance to transform our world for the better.
