TEN MATTERS THAT SHOULD BE 2015 ELECTION ISSUES

(1) A significant number of recent immigrants have grossly abused Canada's income tax system, have regarded Canada as an easy dupe, and have to be held to a severe accounting. A recent Vancouver Sun column by Douglas Todd re-confirmed that Chinese immigrants living in Richmond, B.C. (as a result of under-reported income revealed to Stats Can) were classified as "poor", but lived in mansions. Such people live not just in Richmond, but over all of Metro Vancouver and in many other parts of Canada.

(2) This is a major problem. For example, according to UBC Professor David Ley, in the case of Business Immigrants alone, between 1980 and 2001, the Business Immigrant (BI) Programme allowed about 330,000 immigrants (BI's plus their dependents) to enter Canada. That programme was almost a complete failure, yet it was allowed to continue for about 35 years. Almost all BI's had no intention of fulfilling Ottawa's purpose for the programme : establishing job-creating businesses in Canada.

(3) All of Canada's cities can take only a limited number of people. Limits have to be established. Metro Vancouver's population in 1981 was 1.268 million. In 2001, it was 1,986 million. Business Immigrants and dependents alone were completely unnecessary, yet they were permitted entry. They and other unnecessary immigrants have comprised almost all of Metro Vancouver's 718,000 population increase. Southern Ontario's population has increased much more ---as has immigration-driven gridlock there. Our politicians continue to delude themselves and Canadians into thinking that our cities and the country can take unlimited numbers of people.

(4) Canada's tax system has to have strong checks to ensure that it has the ability to support Canada's social services. It cannot tolerate wealthy parasites. As Metro Vancouver lawyer Samuel Hyman recently stated in a Vancouver Sun OP ED, Ottawa sent a very foolish signal to Canada's home-grown tax cheats and new immigrant cheats when it cut \$300 million from the

Canada Revenue Agency's enforcement budget and laid off 3000 auditors in 2012. It sent a similar message when it recently dismissed 61 of its most experienced auditors. These people had the ability to prosecute corrupt international cheats.

(5) UBC Professor David Ley has clearly shown that relentless immigration demand for housing has been the cause of Metro Vancouver's astronomic housing prices. Corrupt figures in the immigration lobby and the real estate industry have conspired to conceal the truth and have to be held to a severe accounting. The same applies to governments who have allowed this disaster to unfold.

(6) Our treasonous, government-funded CBC continues to act as the propaganda arm of the immigration lobby. It has betrayed the interests of Canada's majority population and it too has to be held to a severe accounting.

(7) Unnecessary immigration necessitates costly infrastructure projects. For example, British Columbia's \$8.8 Billion Site C Hydro-electric dam and Metro Vancouver's \$7.5 Billion Transit Infrastructure additions are being built almost solely to prepare for the arrival of another million people in the Metro Vancouver area. Canada has no need for most of them. Almost all will be from offshore.

(8) Canada's Treason legislation has to be activated to charge the country's immigration lobby for activities that threaten the existence of Canada's majority population and give priority to the interests of recently-arrived minorities.

(9) The Economic Council of Canada established in 1990 that immigration has never provided any significant economic benefit to Canada. In addition, according to veteran economists Herbert Grubel and Patrick Grady, recent immigrants to Canada are now taking up to \$30 Billion per year more out of Canada's economy in transfers (social benefits) than they are contributing in taxes. In 2011, that figure was \$23 Billion. In other words, the figure has increased substantially, not decreased.

(10) Unneeded immigration has turned Canada's federal elections into National Grovelling Campaigns in which many politicians perform countless treasonous, degraded acts in order to get their share of the recent immigrant vote. This is a national disgrace and should never have been allowed to happen, let alone have been permitted to continue for 25 years.

On May 5, 2015, the Alberta NDP won government with 40.57% of the majority vote compared to the combined vote of the Conservatives and the Wild Rose at 52.03%.

Dear Prime Minister Harper, Federal Finance Minister Joe Oliver, BC Premier Christy Clark, and Minister Responsible for Housing Rich Coleman,

In the Preamble to the Universal Declaration of Human Rights (UDHR, 1948) it states in part that (bold emphasis, mine):

Whereas the peoples of the United Nations have in the Charter reaffirmed their faith in fundamental human rights, in the dignity and worth of the human person and in the equal rights of men and women and have determined to promote social progress and better standards of life in larger freedom,

I write to all of you as we near a federal election period, and are within two years of the next BC provincial election, to remind you of your collective responsibility as elected public officials to strive for and uphold such societal goals, and to serve all Canadians (existing and aspiring) towards these worthy and necessary ends.

Article 25 of the UDHR further states:

1) Everyone has the right to a standard of living adequate for the health and well-being of himself and of his family, including food, clothing, housing and medical care and necessary social services, and the right to security in the event of unemployment, sickness, disability, widowhood, old age or other lack of livelihood in circumstances beyond his control.

(2) Motherhood and childhood are entitled to special care and assistance. All children, whether born in or out of wedlock, shall enjoy the same social protection.

Why is "Canada ... one of the few countries in the world without a national housing strategy" (page 7) ? This 2009 United Nations Human Rights Council report details several existing deficiencies, many of which have either remained stagnant or worsened in: homelessness; women and their right to adequate housing; Aboriginal populations.

The lack of accessible, secure, affordable housing is costing Canada and many Canadians their

health, dignity, well-being and sometimes their life. Six months ago the Canadian Association of Social Workers (CASW) appealed:

"to the Government of Canada to provide the leadership to develop a national long-term affordable housing plan. This plan must link all levels of government, as well as the private sector, in creating a comprehensive strategy to eliminate homelessness in Canada.... Since the 1990's, successive federal governments have reneged on this commitment of providing affordable housing for all Canadians. The consequences have been well documented, and include a dramatic rise in the use of emergency shelters and food banks across Canada: what began as temporary solutions have become permanent fixtures in our communities."

One excellent, available solution to some of these pervasive housing problems in the City of Vancouver is the opportunity to build quality, accessible, secure affordable housing on the 8.5 hectare site located at West 33rd Ave and Heather Sts. Our Member of Parliament, Don Davies, has advocated for this area (The Fairmount Complex) to be used for the maximum number of affordable housing units. These could be jointly developed and operated by First Nations organisations, non-profits, housing co-operatives and other community groups.

> Given that this space is situated on unceded aboriginal territory (Musqueam, Tsleil-Watuth and Squamish), which is also viewed as public land, in co-operation with these First Nations, can you see that one very progressive, productive way forward is to simply start doing the right thing ? Make it available for some of the thousands of people and families in the Lower Mainland who can not afford to live here under the current, very expensive housing conditions. In any case, this large, central space should not be sold to/for private interests.

Whomever forms the next federal government must commit to, and follow through with broad, supportive plans, funding and space to make such areas available for affordable housing. Work productively with our Premier and Minister of Housing in BC to make it happen. It is your collective responsibility to ALL Canadians.

I look forward to your written responses at your earliest opportunity, and to a full, frank and forward-looking discussion of your responsibility towards this essential human right over the next four months.
