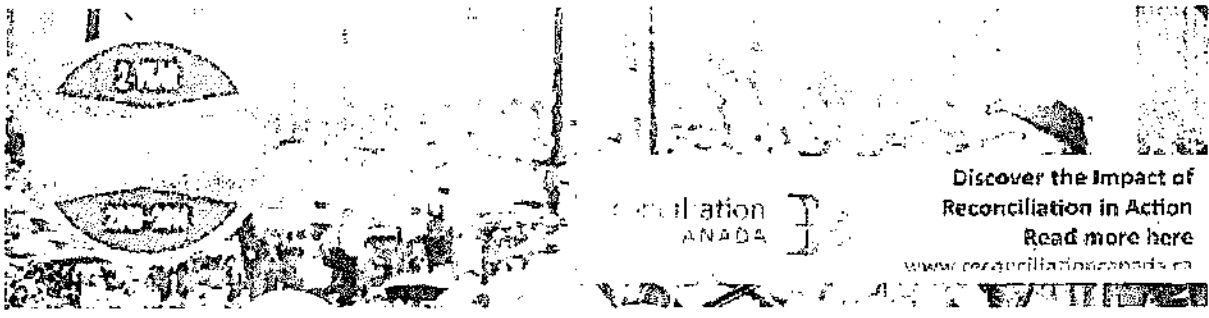

Evan, here is what we have. Standing by for further clarification.

Do you have BC's GDP forecast numbers?

We have controlled costs.

For example, salaries represent 60% of direct operating costs. Between 2010 and 2014, we reached agreements with our public service that saw no additional taxpayer dollars added to compensation. Under the current bargaining mandate, our employers have achieved labour stability by negotiating longer-term agreements within a fixed fiscal envelope of 5.5% over five years.

In addition to these modest increases, the mandate also provides public sector employees with the opportunity to participate in the Province's economic growth through the Economic Stability Dividend.

Between 2001 and 2013 average Provincial Government wages in B.C. have grown by 11.2%. This compares with 22.6% in Ontario, 30.0% in Alberta and 33.2% for Federal Government Employees across all provinces.

During the past 10 years we have invested \$35 billion on taxpayer supported infrastructure and plan \$11.4 billion over the three years fiscal plan (to 2017/18)

On cost control we have controlled our expenditures to an average of 2.56% growth over the three year fiscal plan - health care is our largest expense we now have the cost curve to an average of about 3% per cent over the three years of our fiscal plan.

We have lowest smoking rates in Canada and one of the best outcomes for certain cancer rates. \* Need fact checking on specifics.

By maintaining fiscal discipline and controlling spending, government has achieved surpluses for the last two fiscal years and we are forecasting modest surpluses over the fiscal plan period.

Evan, here is what we have. Standing by for further clarification.

Do you have BC's GDP forecast numbers?

We have controlled costs.
