Re: **Recusal Directive – Mark Marissen, Pacific Future Energy Corporation**


As you know, Premier Christy Clark holds herself to the highest ethical standard and expects the same of all of those in her employ.

Today she directed John Dyble, Deputy Minister to the Premier, Cabinet Secretary and the Head of the Public Service to ensure that she would be fully recused from any discussions, issues, decisions or dealings with her ex-husband Mark Marissen or the firm he joined in an executive capacity, Pacific Future Energy Corporation, or any other refinery project.
