The Public Policy Forum will release its Governance Panel's report, *Time for a Reboot: Nine Ways to Restore Trust in Canada's Public Institutions* tomorrow, Wednesday, October 28. The Panel was established earlier in 2015 to assess the weakening of key pillars of the Westminster democratic system.

An embargoed copy of the report is attached, in French and English.

In their report, the Panel makes recommendations to reinvigorate and rebalance our system of governance in Canada and in provinces across the country.

The report recommends: Strengthening parliamentary committees by giving them greater independence from party discipline, reducing the number of committees, allowing them to determine their own meeting schedules, and providing them with the resources needed to fulfill their mandates. Empowering cabinet by allowing ministers to be ministers and making them more accountable for their portfolios. Restoring the public service to its role by enshrining in legislation the principles, roles and accountabilities of a non-partisan, professional public service. Building similar accountability principles into the 'political service,' including a code of conduct and formal oversight mechanisms, as well as governance training for political staff.

All of these recommendations are practical, readily implementable and none require constitutional changes. In the end, we seek more productive, more transparent and more accountable public institutions in our Canadian system of governance.

The Governance Panel includes Honorable Jean Charest, Partner at McCarthy Tetrault LLP and former Premier of Quebec and federal cabinet minister; Monique Leroux, Chair, President and CEO of Desjardins Group; Honourable Kevin Lynch, Vice-Chair of BMO Financial Group and former Clerk of the Privy Council; Heather Munroe-Blum, Chair, Canada Pension Plan Investment Board and Principal Emerita, McGill University and myself.

My Panel colleagues and I are keen to hear your comments and feedback on the report.

The Security Conversion spreadsheet is a list of all employees and the roles they are assigned in TOL. Unless any changes are made to these roles, they will be automatically converted as is to Time and Leave. However, if a change is necessary, it must be changed on this spreadsheet so that I can submit it to TLAM (Time, Leave and Absence Management) and it can be uploaded into Time and Leave accurately. If no changes are necessary, please indicate that to me.

Please note that if an employee is not assigned the appropriate role to be transferred into TLAM, we can update the role directly in TLAM; however, that causes more work and service disruption.
Therefore, I cannot emphasize enough how crucial it is to review this spreadsheet and ensure the roles assigned are correct.

After reviewing and updating (if necessary), please obtain approval from branch head(s) before returning it to me. Please let me know in your return email that the branch head(s) has approved.
As Security Administrator, I will have Steve Klak, CFO, review the Security Conversion spreadsheet and then submit it to TLAM.

Upon deciding an employee's role, please review the appropriateness of the roles assigned, and ensure that no individuals have a conflict of interest, and that there is proper segregation of duties within the roles.

Attached is a Security Conversion Spreadsheet Guide with instructions on how to complete the spreadsheet.

Here are some other notes to aid in completing the spreadsheet:

1. Every employee has employee self-service, so that is not entered onto the spreadsheet. If an employee is listed with no roles ticked off on the right hand side of the spreadsheet, that means that the employee will only have employee self-service.
2. The roles are captured in columns K-T on the spreadsheet. Please ignore the role "Employee View Only". The "Scheduler" and "Scheduler Admin" roles have restricted access and do not apply to our organization. The roles applicable are the following:

Role Name	Description
Expense Authority	A security role that has permissions to all approval actions (and final reimbursement requests and edit timesheet information on behalf of an employee.
Time Approver	A security role that has permissions to all approval actions for reimbursement requests and edit timesheet information on behalf of an employee.
Timekeeper	A security role that has permissions to edit timesheet information on behalf of an employee (record time / compensation exceptions such as stand by, to higher job classification, overtime, meal allowances).
Leave Approver	A security role that has permissions to all approval actions for leave requests as well as edit leave requests on behalf of an employee.
Leave Keeper	A security role that has permissions to enter, edit and submit leave requests on behalf of an employee.

3. Column G determines who you can do work on behalf of, i.e., department, ministry, etc. Please ensure that the value in column G is applicable to all the roles for that employee. For example, if an employee is both Leave Keeper and Time Keeper, the group value in Column G should apply to both. If the employee is Leave Keeper for a certain group and Time Keeper for another group, there must be separate lines for each role.
4. If there is a blank value in column G (For Whom), please fill in the appropriate values (employee or department) for the roles indicated.
As well, if an employee has something filled in in column G, but no roles indicated, then either the roles need to be input or the information under column G for that employee needs to be deleted.
5. **Only update the following columns: Column A (Empl ID); Column G (for whom) and Columns K – T (Roles).** These columns are highlighted in yellow. If you update any other columns, the data conversion will ignore those updates.
6. Please remember that Expense Authorities are not Leave Approvers. If they require that role as well, please indicate that on the Conversion spreadsheet.

Chief Joseph is an eloquent and inspiring speaker. Through speaking engagements, Chief Joseph shares his journey of reconciliation, including his childhood experience at St. Michael's Residential School. He speaks about the important role of reconciliation in moving forward through trauma and will address the reconciliation work that is being done across Canada to build meaningful relationships among Aboriginal peoples and all Canadians.

Chief Dr. Robert Joseph, O.B.C.

Chief Dr. Robert Joseph, O.B.C. is a true peace-builder whose life and work are examples of his personal commitment. A hereditary chief of the Gwawaenuk First Nation, Robert has dedicated his life to bridging the differences brought about by intolerance, lack of understanding and racism at home and abroad.

His insights into the destructive impacts these forces can have on peoples' lives, families and cultures were shaped by his experience with the Canadian Indian Residential School system.

As one of the last few speakers of the Kwakwaka'wakw language, Chief Joseph is an eloquent and inspiring Ceremonial House Speaker. He shares his knowledge and wisdom in the Big House and as a Language Speaker with the University of British Columbia, an internationally recognized art curator and as co-author of "Down from the Shimmering Sky: Masks of the Northwest Coast".

In 2003, Chief Joseph received an Honorary Doctorate of Law Degree from the University of British Columbia for his distinguished achievements in serving BC and Canada. In 2012, he was presented The Diamond Jubilee Medal by the Right Honourable David Johnston, Governor General of Canada. In 2014, he received the Jack P. Blaney Award for Dialogue from Simon Fraser University and an Honorary Doctorate of Divinity from Vancouver School of Theology for his work in reconciliation and renewing relationships between Aboriginal peoples and all Canadians. In 2015, Chief Joseph was presented a Deputy Ministers' Recognition Award for Collaboration and Partnerships and was appointed to the Order of British Columbia, the Province of British Columbia's highest honour.

Chief Joseph is currently the Ambassador for Reconciliation Canada and a member of the National Assembly of First Nations Elders Council. He was formerly the Executive Director of the Indian Residential School Survivors Society and is an honorary witness to Canada's Truth and Reconciliation Commission (TRC). As Chairman of the Native American Leadership Alliance for Peace and Reconciliation and Ambassador for Peace and Reconciliation with the Interreligious and International Federation for World Peace (IFWP), Chief Joseph has sat with the leaders of South Africa, Israel, Japan, South Korea, Mongolia and Washington, DC to learn from and share his understanding of faith, hope, healing and reconciliation.
