Issue: Carbon Tax Relief Grant for Greenhouse Sector

Ministry: Agriculture

Background:

- In Budget 2012, government announced that it would undertake a review of the carbon tax and that a one-year carbon tax relief grant for greenhouse growers, administered by the Ministry of Agriculture, would be provided while the tax was being reviewed.
- The grant was \$7.6 million, the amount of carbon tax the sector (and Ministry of Agriculture) estimated at that time it would pay in 2012. Grants were based on 2011 fuel volumes of natural gas and propane and the carbon tax rates for 2012.
