Background and Analysis

- Since March 2011, Syria has been engaged in a civil war, which has displaced over 11 million people.
- Canada is one of 30 countries around the world that is working with the UN Refugee Agency to provide resettlement opportunities to refugees from Syria.
- Based on historical patterns, it is expected that between 2,700 and 3,500 of the 25,000 refugees from Syria will settle in B.C.
- Annually B.C. receives approximately 37,000 permanent residents and last year our province took in just over 1,500 refugees. These numbers show that provincial services such as health and education are able to absorb the costs of refugees within our current system.
- All resettled refugees are permanent residents upon arrival in British Columbia. This includes refugees who are resettled by the Government of Canada, and refugees who are resettled by private sponsors.
- Provincial services for all refugees resettled to BC include:
 - o MSP coverage
 - Enrollment in our schools.
 - Employment programs
 - Child care subsidies

- Student aid
- Since BC's \$1 million dollar fund was formed in September, the province has consulted with more than 85 stakeholder individuals and organizations from across BC.
- BC government staff has been actively engaged in regional planning sessions with cities, municipalities, the Ministry of Immigration, Refugees and Citizenship, and federally-funded service providers such as the Immigrant Services Society of BC (ISSofBC).
- BC has established a cross-ministerial ADM Committee on Refugee
 Readiness and Response. The committee is comprised of representation
 from 12 Ministries with the goal of sharing knowledge and information
 to action BC's response to the impending influx of refugees from Syria.
- In additional, BC has sent a provincial staff person to Ottawa to assist with planning for the resettlement of refugees in BC alongside federal staff at the Government Operations Centre.

SIGNIFICANCE:

The 228 member delegation will be visiting Vancouver, Calgary and Montreal (private program), and is comprised of senior government representatives from Brussels, Wallonia, and Flanders, and business representatives from companies, chambers of commerce and federations.

This is the largest Belgian delegation to ever visit BC. It is preceded by a visit by His Royal Highness King Philippe (then Prince Philippe) to BC in March 2008.

The EU is BC's fifth largest export market, with Belgium's port of Antwerp being a major point of entry for Canadian goods in Europe.

EXMAR and Fluxys, a Belgium-based independent industrial shipping company and a natural gas transmission system operator, respectively are both members of the business delegation and will have representatives in attendance at the meeting with HRH Princess Astrid.

EXMAR is a partner on the Douglas Channel LNG project, a floating LNG facility to be located near Kitimat. s.17

EXMAR will be delivering a presentation on their activities in BC to the delegation later in the day on Oct 26th.

A seminar on 'the Belgian Film Industry and Tax Shelters' will be delivered to the business delegation by Michela Ritondo, an international tax expert from Belgium's Fiscal Department for Foreign Investments.

ICEBREAKER:

Belgian liberation by Canadian forces in the Second World War; BC government's support of veterans who were influential in liberating Belgium and western Europe.

Minister de Jong holds the rank of Captain in the Canadian Armed Forces Air Force Reserve. Princess Astrid is a member of the Belgian Armed Forces; she is a Colonel in the Medical Unit.

KEY BC OBJECTIVE:

Promote BC as one of North America's most competitive, flexible, and supportive business climates, with consistent AAA credit ratings, vast resources, low taxes, a stable and well-regulated financial system, and a fiscally responsible government.

Signal BC's continued support for engaging with Belgium to expand cooperation and strengthen energy-related business opportunities.

Recognize that Belgium plays a significant role in Europe's natural gas system. It is expected to increase its LNG demand substantially over the next ten years, and Belgian companies are welcome partners in BC's LNG industry.

KEY MESSAGES:

Welcome HRH Princess Astrid and her accompanying delegation to BC.

Comprehensive Economic and Trade Agreement (CETA) - BC values the good political and economic relationship we have with Belgium, and hopes that the relationship will be further strengthened as Canada and the EU have reached an agreement-in-principle on the CETA.

LNG – BC acknowledges EXMAR'S further investment and strategic partnership with BC and the Douglas Channel LNG project.

Euro Bond - On October 1, 2015, BC issued its inaugural public Euro bond issue at a benchmark size of €500 million (about C\$ 750 million equivalent) in the 10 year term. The issue delivered excellent diversification, introducing the province to new investor names and should set the stage for further Euro issuance. BC's triple—A credit rating helped with the success of the offering.

Energy and LNG

CETA – The Belgian business sector is very supportive of CETA; Belgian business leaders participating in this mission are either already present in Canada and projected to expand in North America, or are seriously exploring new investment or trade opportunities.

II. BACKGROUND:

Canada – Belgium Relations - Belgium is the 11th largest foreign direct investor in Canada. In 2014, Belgium direct investment in Canada was \$5.7 billion; Canadian direct investment in Belgium was \$1.11 billion.

BC – Belgium Relations - In 2014, BC exported \$95.7 million worth of goods to Belgium. The top exports were: wood and articles of wood (\$40.7 million), mineral products (\$26.5 million), and machinery and mechanical appliances (\$13.8 million).

The Brussels-Capital Region has an economic and trade office in Vancouver. In 2013, the BC government opened a Trade and Investment office in Europe (based in London).

<u>LNG</u> – EXMAR is partnered with EDF Trading and AlJVLP (AltaGas Idemitsu Joint Venture Limited Partnership) on the Douglas Channel LNG project.

Fluxys is a Belgium-based company, mainly acting as a natural gas transmission system operator. s.17 Aside from natural gas transmission, the company owns and operates the Zeebrugge LNG terminal. The combination of this import terminal with its comprehensive gas transmission system has allowed Fluxys to play a large role in the international gas flows in North Western Europe.

<u>BC-Belgium MOU</u> - The MOU will formalize a framework for discussion, information exchange and cooperative activities, with the long-term goal of strengthening the bilateral relationship between BC and the Brussels-Capital Region (BCR).

<u>BC's Public Euro Bond</u> - The bond was well received by investors, who were mostly European, including central banks/official institutions, fund managers and insurance companies. The province saved about 2 basis points compared to its domestic cost of borrowing.

Belgium is rated AA with Standard and Poor's, and AA minus equivalent with Moody's.

<u>Technology</u> - In June 2014, BC's MOTI and EU TIR Office represented BC at the ERA-Can "Strengthening Science, Technology and Innovation Partnerships between Canada and Europe" in Brussels. The event provided a platform for BC to highlight innovation capabilities and support mechanisms and learn about relevant European funding mechanisms for trans-Atlantic collaborations.

ERA-Can is a project mainly funded by the European Community's Programme for International Cooperation which promotes cooperation between the EU and Canada in science, technology and innovation with a broad range of activities.

<u>Agrifood</u> – In 2014, BC was represented by a contingent of companies, organized by the Ministry of Agriculture, at the Seafood Expo Global in Brussels.

BC exhibitors reported an estimated \$29.5 million in sales from their participation in the BC booth at SEG 2014, with one company expecting deals from 30% of the companies they met with. Staff distributed 3,135 product samples over three days while promoting BC as a leading source of high-quality, environmentally-sustainable seafood products. Based on available feedback from the exhibiting companies, participation in the show is expected to lead to increased sales as high as 15 per cent over the next year.

IV. APPENDIX 2: BIOGRAPHIES OF OFFICIAL DELEGATION

HRH Princess Astrid of Belgium



Princess Astrid, Princess of Belgium, was born in Brussels on 5 June 1962. She is the second child of King Albert II and of Queen Paola.

After her secondary education in Brussels, Princess Astrid studied art history for a year at Leiden in the Netherlands. She completed her education in Geneva, at the Institute of European Studies and in Michigan, U.S.

Princess Astrid is married to Lorenz, Arch-Duke d'Autriche-Este, who became Prince of Belgium in 1995. The couple have five children: Amedeo (21 February 1986), Maria Laura (26 August 1988), Joachim (9 December 1991), Luisa Maria (11 October 1995) and Laetitia Maria (23 April 2003).

Princess Astrid was Chairwoman of the Belgian Red Cross between 1994 and 2007. As Honorary Chairwoman of the Queen Elisabeth Medical Foundation and the European Organisation on Research and Treatment of Cancer (EORTC), she supports clinical and fundamental research.

The Princess is active in the fight against epidemics and pandemics. As "Special Representative" of the Roll Back Malaria partnership, she engages in raising awareness of the deadly consequences of the disease and assists in mobilizing resources to fight malaria.

Princess Astrid is particularly concerned by the plight of victims of violence i.e. domestic violence or violence against civilians in war circumstances. She is engaged in the efforts to ban antipersonnel mines and cluster munition.

Princess Astrid is known to be highly concerned about persons who - through a variety of circumstances - become marginalized citizens. She visits and encourages in many ways those Organisations which offer assistance to those who are in need of help.

End of June 2009 the International Paralympic Committee (IPC) Governing Board ratified the appointment of Princess Astrid as a member of the IPC Honorary Board.

Since 22 November 1996, Princess Astrid has been a member of the Belgian Senate as senator by right. She also joined the Belgian Armed Forces on 22 May 1997. The Princess is a Colonel in the Medical Unit.

On June 20th, the Secretariat of the Anti-Personnel Mine Ban Convention/Ottawa Convention announced that Princess Astrid - as Special Envoy of the Convention - has joined a task force which will undertake diplomatic efforts to obtain the signature of the Convention by States not yet party to it.

After the break-up of his former party, the Volksunie, he founded the Nieuw-Vlaamse Alliantie (N-VA) in 2001 and became the first Chairman. In 2004, he moved to the Government of Flanders.

Cécile Jodogne (born 1 April 1964) is a Belgian politician. In July 2014, she was appointed State Secretary of the Brussels-Capital Region, in charge of Foreign Trade, Firefighting and Emergency Medical Assistance. She is also Minister and Member of the Board of the French Community Commission (COCOF), in charge of Civil Service and Health Policy.

Jodogne was born in Louvain (Leuven) and has a degree in geography and economics (UCL). After graduation, she worked in education (university and secondary school). She then specialized in urban studies and mobility. Her political involvement began early. She became a member of the FDF (Fédéralistes Démocrates Francophones) in 1985. In the early 1990s, she became consultant for the Office of the Secretary of State for Monuments and Sites, where she was responsible for monitoring urban plans, various publications on Brussels heritage and cultural and sports policies of the COCOF. She then became Head of Office of the Deputy mayor of Schaerbeek Bernard Clerfayt, before being elected municipal councilor in Schaerbeek. At the next election, in 2006, she was appointed Deputy mayor for Urbanism, Environment, Urban Renewal, Heritage and Tourism. In 2008, she took on, in addition to this mandate, the role of acting mayor, replacing Bernard Clerfayt who was then appointed Federal Secretary of State.

In 2014, Cécile Jodogne became Secretary of State for the Brussels Region and Minister of COCOF. Despite her new role, she continues to closely monitor her municipality since she remains communal advisor in Schaerbeek. Next to her political responsibilities, she is also active in the sector of urbanism and architecture. She presides of RenovaS, an association supporting urban renewal, and the association Autrique House.

III. BACKGROUND:

CHINESE PEOPLE'S INSTITUTE OF FOREIGN AFFAIRS (CPIFA)

- The purposes of CPIFA is to engage in studies on the world situation, international issues and foreign policies, and to carry out exchanges with statesmen, scholars, etc., with a view to enhancing mutual understanding and friendship between the Chinese people and the people of all other countries.
- Members of CPIFA Council consist of distinguished figures in China, including international activists, senior diplomats and well-known scholars and specialists in international studies.

BC - CHINA RELATIONS

- Education China is the largest source country for international students studying in BC;
 approximately 28,700 students studied in BC in 2013-14. There are currently 31 BC
 Offshore Schools in China.
- Bond Market BC's success to date in the RMB bond market two-year issue yielded
 2.85% and raised about \$559 million Canadian (Nov 2014), with another bond issue expected in 2016 provided there is cooperation from the Chinese authorities.
- Trade China is BC's second-largest trading partners, and accounts for 17.7% of BC's commodity exports (valuing \$6.3 billion). BC leads Canadian provinces in trade with China (\$6.3 billion or a third of Canada's \$18.8 billion exports to China in 2014). Top BC exports to China (2014) include chemical woodpulp (\$1.5 billion), lumber (\$1.4 billion), coal and fuels from coal (\$845.2 million), copper ores (\$712.1 million).
- Tourism Visitor volume from China has increased steadily (53,000 in 2001; 130,000 in 2011; 203,100 in 2013).
- **Sister Province -** This year, BC celebrated its 20th anniversary of sister province relations with China's Guangdong Province. In BC, 19 municipalities have 32 friendship, sister city, or other MOUs with communities in China.
