I am writing this letter to thank you for the special time on Tuesday June 14th when I was able to interact with you and express my concerns face to face. s.22 s.22

We are so thankful that

you have provided a way for us to keep our school. Delegation from Kersley and Parkland attended the school board meeting on Wednesday evening and were met with extreme coolness. There were about 50 of us and there was standing room only at the board office. They would not make eye contact with any of us. We sat quietly while the board and trustees went thru their meeting and nothing was discussed. Whatever Sue-Ellen Miller said was just blindly accepted. The big topic was a retreat they plan on going to in December at Whistler and they are reserving 10 rooms and it is in American funds. After the meeting we could ask questions so we asked if they were going to apply for the rural school money available. After humming and hawing, Chairperson Tony Goulet said they would try to fill out the application but it might be too difficult and they might not get enough funds. They were very reticent to commit to having the school remain open. One of the community members raised their hand and asked if they would apply every year and they thought they would. Another parent asked if they would consider going to a 2-week spring break like 82% of school districts are doing. They have always refused to discuss this because of putting their students at risk for not having breakfast or lunches for the extra week. And also for their CUPE workers missing a week's work. They didn't worry about that when so easily closing the schools. How do the students survive starvation during Christmas and summer break? If the children were their main concern they could contact social services and have a room set up in West quesnel and open from Monday to Friday from 11-2 for at risk children to come for a meal and some snacks. Lastly a parent stood up and said the school board should thank the parents present for all their hard work in writing letters and campaigning for their kids to have their schools stay open. The meeting was adjourned and we were escorted out. We are thrilled that the funds were made available but really don't trust the school board and trustees at all. Hopefully someone in the Minister of Educations office will assist them in the application and the schools will be open in September.

We in Kersley would also still like to pursue having a rural library operating in the school. We will talk to our CRD representative Ted Armstrong. Since Ecole Baker is closing and they have the Strong Start program happening there we would like to have it available in Kersley. One of the school board members is in Charge of this and has refused us before so we really don't know whom to approach about this. Do we need to raise funds to have this in our school or would we be able to do this in our Community hall. We have young families in Kersley who would take advantage of this if they didn't have to travel so far to participate. I would appreciate some advice as to how to proceed with this. Thank you,

I live in the Kootenays and our only elementary school in the Lardeau Valley, Jewett School at Meadow Creek, is not included in your list of 9 eligible schools to remain open. Although this announcement at the last minute is welcome news, I ask you to please reconsider how this list was determined. Yak Elementary has no enrolment and the Jewett School enrolment is increasing, is located 40 minutes north of the nearest school in Kaslo (where the students would need to be bussed, some an hour one way, past bluffs that are often closed in winter due to avalanches), and appears to meet the other criteria. The closure of Jewett would be the last nail in the coffin for a community that has been hard time since the downturn in the forestry industry.

Hon. Premier Clark, Hon. Ms. Larson and Hon. Mr. Ashton,

I would like to register my strong desire to see West Bench Elementary included in the schools to benefit from the recently announced Provincial Rural Education Enhancement Fund.

From the premier's press release:

Districts would be able to apply annually for Rural Education Enhancement Funding if they meet the following criteria:

- In a rural community or sub-community outside Greater Victoria, the Lower Mainland, and Kelowna areas with a population less than 15,000;
- Closure would eliminate specific grades within the community;
- Funding is used to keep the school open; and
- Closures due to facility condition or extreme enrolment decline are not included.

Trout Creek Elementary is included by the arbitrary choice of a population of under 15,000. This selection criteria unfairly excludes West Bench, which shares Trout Creek's geographic challenge of a highway separating it from other schools in the area. Closing the schools in either of these communities jeopardizes the safety and security of the youngest and most vulnerable students. Children of families in the West Bench community should not be put at risk simply because of a number.

West Bench Elementary can't be classed as a facility to be closed because of its condition. As for declining enrollment, the board is relying on the forecasts of a consultant to indicate that declines at WBE are imminent for the next 5 years. This is the same consultant who in 2011 predicted that enrollment would stabilize by 2015, so the credibility of the current data must be viewed in the light of this historical inaccuracy. Absent of a reliable forecast for future enrollment, I ask that you consider that West Bench is a community that is built for young families, right from when it was created through the Veteran's Land Act after World War II. The legacy of that initiative is a community of large properties with 4 and 5 bedroom homes. The likely buyer for a large, older home on a large property is a young family.

West Bench also has a rare and unique quality with the successful integration of First Nations students. One third of the current WBE student population have ancestry, and are the beneficiaries of an inclusive, safe and motivating educational environment. Students and staff alike respect and incorporate the traditions of the First Nations, and students of all heritage are learning a life of mutual understanding that can't be duplicated in a line item of a curriculum. You have a perfectly successful model for how to make this happen, so rather than being seen as a government and school board who eliminate this success story, I ask that you use it as a blueprint and incubator for all BC schools to benefit.

The West Bench/Penticton Indian Band area is and will continue to be a magnet for families with school-age children - unless the provincial government and the board of SD67 create a self-fulfilling prophecy and remove the critical component for these families by eliminating the elementary school in this area.

Dear Premier Clark:

Your announcement yesterday of the creation of a Rural Education Enhancement Fund has been received by B.C.'s boards of education with mixed emotions. While every trustee in this province is supportive of more money for public education, we are perplexed as to why all of the recent funding announcements could not have been made earlier this year. Communities and school districts across B.C. have been unnecessarily torn apart by the timing of this and other recent funding announcements.

Many times BCSTA has called on government to create a funding model for school districts that allows boards of education to implement long-range strategic plans that meet the needs of all students; rural, remote, urban and suburban. Likewise, we have on numerous occasions called for the establishment of co-constructed policy to address the needs of schools in rural B.C. We are frustrated that we find ourselves in a place that could have been avoided had our requests been answered earlier.

School trustees across B.C. have had the unenviable responsibility of implementing the very tough financial and educational decisions your government has called on them to make. They have had to close schools, cancel programs and lay off employees as the result of unsustainable funding and the realities of declining enrollment. Boards of education have acted honourably and responsibly to address a situation that they did not create.

Our issues with yesterday's announcement are in regard to process and timing. As cogovernors of the public education system, it is our expectation that government will work with us in the best interest of students, parents and communities. Failure to consult and work with us only leads to the furthering of the conflict recently seen around the province. Had government consulted with us when requested and provided all of the recent funding announcements earlier this school year, communities, parents and students could have been spared both the disruption and the upset experienced over recent months and years.

In closing, I would like to make two strong, but sincere recommendations to you:

Continue to provide B.C. school districts with additional funding, but do so within a predictable and sustainable co-constructed long-range vision.

SUBJECT: Temporary Funding for Rural Schools under Consideration for

Closure

BACKGROUND:

The Ministry has undertaken a preliminary assessment of schools currently being considered for closure, by Boards of Education across the Province, in relation to their significance in supporting the local economy and viability of rural communities.

Numerous rural communities have requested government undertake a review of the importance of the schools as "anchor tenants" within rural communities, and their role in attracting or retaining businesses, professionals and other government services to rural communities.

The Ministry is considering undertaking a review and potentially developing a rural schools strategy. Until this work is completed, the Ministry is exploring options to delay further funding based closures in rural communities.

DISCUSSION:

The ministry applied the following criteria when assessing the list of schools currently being considered for closure. This criteria includes:

- School located within a rural community outside Greater Victoria, Vancouver, Kelowna areas with a community population less than 15,000.
- School closure will eliminate grade offerings within K-12 from the community or a sub-community. (Sub-community could be an area within a community with a distinct economic area or an area physically separated from neighbouring schools by a unique geographic features such as a major highway, active railway, or body of water such as a river or lake; which pose a significant accessibility issue for students.)
- School closure will threaten the ongoing viability of the community.

Exceptions to the criteria include:

- School closures based on condition.
- School closures based on inability to offer fundamental educational programming due to lack of enrollmen and or available educators.

The analysis resulted in the determination that nine schools across six rural school districts meet the above criteria and 13 schools across nine school districts do not meet the criteria and an undetermined number of schools within Vancouver and Richmond do not meet the criteria.

Seven rural schools get \$2.2 million funding to help them stay open

VICTORIA – Close to \$2.2 million from the new Rural Education Enhancement Fund will flow to four school districts to help keep seven rural schools open.

Students at schools like Osoyoos Secondary, Trout Creek Elementary, and Kersley Elementary will see their schools remain open, while the communities will see the benefits of classes continuing.

Premier Christy Clark announced the new Rural Education Enhancement Fund on June 15 to help school districts with the unique challenges of keeping schools open in rural communities.

To be eligible for funding, the amount of funding districts could receive needed to be equal to their expected savings from closing the school. Districts who were successful met the following criteria:

- A rural community or sub-community outside Greater Victoria, the Lower Mainland, and Kelowna areas with a population less than 15,000;
- The potential school closure would eliminate specific grades within the community;
- · Funding is used to keep the school open; and
- Closures due to facility condition or extreme enrolment decline are not included.

As well, three districts that applied for support for schools slated to close in 2017/18 received confirmation that four of their schools will be eligible for funding that year. The Ministry will make all districts aware of the application process for the 2017/18 year before the end of February 2017.

The Rural Education Strategy will look at rural school district budgets and the role education and schools play in communities outside the Lower Mainland, Greater Victoria, and Kelowna. The strategy will aim to find solutions for the unique challenges facing rural school districts while recognizing the economic impact of single schools in small communities. Details of the review will be announced in the near future.

"For students, families, and rural areas, the local school is the centre of the community and the local economy. In my time as minister I've seen that our education funding model doesn't take all the unique rural factors into account," Bernier said. "My Ministry will work with the Parliamentary Secretaries to take a hard look at how we can make sure the unique community and economic role of rural schools is supported in how we fund school districts."

As a parent proud to call rural B.C. home, my family understands the unique opportunities and some of the challenges that come with living in a rural area.

We've just launched a new program that recognizes these challenges - the Rural Education Enhancement Fund. When a school closes, it impacts more than K-12 education - it negatively affects the local community and economy.

The Rural Education Enhancement Fund is ongoing and is ready today so districts can get the funding needed to keep eligible schools open this September. Districts will receive the amount equal to the expected savings from closing their school if the application is successful.

To be eligible, a district must be located in a rural community or sub-community outside of Greater Victoria, the Lower Mainland and Kelowna. As well, the closure would eliminate education for specific grades from a community. Finally, the funds must be used to keep the school open.

In addition to the fund, the Province has launched the Rural Education Strategy to find solutions to those unique challenges rural school district face. Linda Larson, my new parliamentary secretary for Rural Education, along with Donna Barnett, the parliamentary secretary for Rural Development, will lead the study.

As an MLA and as a minister I have seen that our current funding model may create challenges for rural districts. We are going to find a solution for students, teachers, and parents from rural B.C.

"With Canada's strongest economy it's important that we make sure the benefits are shared by rural communities throughout our province to ensure they have the infrastructure they need to grow, attract talent, and provide critical services like health care. Our rural education strategy will help us accomplish this."

The amount of funding districts will be eligible for is to be equal to their expected savings from closing the school. Districts would be able to apply annually for Rural Education Enhancement Funding if they meet the following criteria:

- In a rural community or sub-community outside Greater Victoria, the Lower Mainland, and Kelowna areas with a population less than 15,000;
- Closure would eliminate specific grades within the community;
- Funding is used to keep the school open; and
- Closures due to facility condition or extreme enrolment decline are not included.

While the ongoing Rural Education Enhancement Fund will help keep schools open starting this coming school year, Premier Clark also tasked newly appointed parliamentary secretary for rural education Linda Larson and parliamentary secretary for rural development Donna Barnett to conduct a full study of rural education funding in the province to seek a long-term solution.

The Rural Education Strategy will look at rural school district budgets and the role education and schools play in communities outside the Lower Mainland, Greater Victoria, and Kelowna. The strategy will aim to find solutions for the unique challenges facing rural school districts while recognizing the economic impact of single schools in small communities. Details of the review will be announced in the near future.

"For students, families, and rural areas, the local school is the centre of the community and the local economy. In my time as minister I've seen that our education funding model doesn't take all the unique rural factors into account," Minister of Education Mike Bernier said. "My ministry will work with the parliamentary secretaries to take a hard look at how we can make sure the unique community and economic role of rural schools is supported in how we fund school districts."

The Rural Education Enhancement Fund is ongoing and is ready today so districts can get the funding needed to keep eligible schools open this September. Districts will receive the amount equal to the expected savings from closing their school if the application is successful.

To be eligible, a district must be located in a rural community or sub-community outside of Greater Victoria, the Lower Mainland and Kelowna. As well, the closure would eliminate education for specific grades from a community. Finally, the funds must be used to keep the school open.

In addition to the fund, the Province has launched the Rural Education Strategy to find solutions to those unique challenges rural school district face. I want to thank Coralee for everything she's done for Quesnel – and for being a relentless force for optimism in the community and at the cabinet table.

Right now, BC is getting some attention – finally – across the country. It can be hard to perceive what's happening out here from Toronto...but they seem to have awoken to the fact that Canada is changing.

And right now, Canada is being led from BC.

- #1 in Economic growth
- Growing at 2 times the national average
- 4 consecutive balanced budgets
- Over 148,000 jobs since we launched the BC Jobs Plan.
- For the first time since 1976, BC has the lowest unemployment rate in Canada. In the Cariboo,

unemployment is less than half what it was the worst of the '90s.

- 99% of BC's public sector has negotiated settlements.
- And we're on track to being able to eliminate our operating debt by 2020.

Yes, we borrow. But there's a difference between borrowing to pay for the groceries, or buying a house. And we only borrow to build.

Over the next three years, the Province and BC Hydro are investing \$20 billion in capital spending.

That includes big projects like Site C. But it's also hundreds of smaller projects that are no less important to the people who depend on them.

Like more than \$1.5 million to upgrade Correlieu Secondary School's A/C and electrical systems, and upgrade to biomass heating.

And almost \$6 million to upgrade Highway 97 just outside town.

There's more coming. Coralee has been working hard to secure more funding to support tourism in the Cariboo.

You asked me to touch on the rural dividend, LNG, and softwood.

RURAL DIVIDEND

Let me start with the rural dividend, the result of a lot of hard work from Donna Barnett and people like Coralee when she was on city council.

It boils down to fairness. Small, rural, resource dependent communities are fed up with sending all the money out of their communities...

And not seeing enough of it come back.

We have to make sure that communities who do the heavy lifting see more of the benefits.

So, we created the Rural Dividend so that smaller communities can diversify their economies...

see some more of wealth they generate stay closer to home...

and position them to start growing again.

The first round of applications closed on May 31st.

We received 180 applications, a great response for a first intake on a new program.

21 came from the Cariboo Development Region – that's 10 per cent of the applications received across BC.

They came from a broad cross-section of communities, non-profits and First Nations from the Cariboo.

Steve Thomson's ministry staff are reviewing applications and making decisions quickly, with announcements starting in July.

There's going to be a second intake for the program in October.

We anticipate that the response will be even stronger, as more and more people learn about the program.

SOFTWOOD

The second topic you asked me to discuss was softwood. And it's no surprise. Quesnel has always depended on forestry.

In the Second World War, BC was the largest manufacturer of airplane veneer in the British Empire – most of that was birch from Quesnel.

After the war, the North American transportation network expanded quickly...and the market for our timber followed those new roads and rail lines, and shifted south.

In just four years, the number of mills here went from 33 to 180.

Ever since then, we have depended on the US...

Not just to but our products...

But to pay a fair price.

Lately, that hasn't been the case.

We need to make sure that we get a softwood lumber deal with America that works for BC.

BC accounts for more than half of the softwood that Canada exports.

Our softwood lumber interests must be protected.

What that means is this: under no circumstances whatsoever will we accept an agreement that includes quotas.

I want you to know: we have been fighting for BC.

In my first conversation with Prime Minister Trudeau, I congratulated him – then I raised softwood.

In my first meeting with him, I raised softwood.

In my trade mission to Ottawa with 100 people, many from the forest industry, we talked about softwood.

When our Forests Minister, Steve Thomson met with his minister and his offices federally he has raised softwood.

Every single one of our MLAs and ministers has a firm instruction and they have carried it out: When we meet with any Member of Parliament, from the government or opposition, we raise softwood.

Because it's urgent not only to get the deal done – but to get the right deal done.

Because we have been so persistent, we have a public commitment between the Prime Minister and President Obama to get to a deal, and a timeline to get there.

That's progress. But we haven't got it across the finish line.

I want you to know that we're still working every day, not just to get a deal, but to get the right deal.

Whatever deal we get to, it will one that is good for BC.

LNG

You also asked me to touch on LNG.

Currently, there are approximately 20 potential LNG projects in British Columbia that have already invested more than \$20 billion on natural gas assets and infrastructure.

To answer the obvious question: yes, prices are low right now, and that has delayed our original timelines.

But we are optimistic. Because it's not about prices today.

As the Paris Climate Conference has made clear...the world is changing in two major ways:

First, there is a growing and inexorable shift in demand away from fuel sources like coal, and towards clean energy.

Second, as the middle class expands exponentially in China and India – demand for energy is increasing with it, and it will be met, one way or another.

LNG is the only transition fuel that can meet rising demand and still bring emissions down.

There is a challenge right now with low global prices. But it's not about what prices will be today – but 5, 10, or 50 years from now.

Ask the 8 businesses in Quesnel who registered for the LNG Buy BC Program. Or better yet, ask the up to 470 people who depend on them for work.

INVESTING IN PEOPLE

A growing economy is the only way to create jobs and opportunity. But it also gives us the ability to invest in people. I want to touch on two examples.

I hope you've heard about the Single Parent Employment Initiative. To help get single parents off the welfare treadmill, the Province pays for training, childcare, transportation, and keeps benefits coming until they find a job.

It's been running for about nine months, and it has transformed lives – 2,800 single parents have taken us up on the offer in just nine months. 30 of them are here in Quesnel.

I also want to touch on the record year we had in placing kids in care in permanent adoptive homes.

How many times have you told your kids: "Whatever happens, I will be there for you?" How many times did your own parents say that when you needed to hear it?

At any given time in BC, about a thousand kids are waiting to be adopted into a permanent home.

So we invested millions more to provide more supports and speed up the process.

What difference has that made? We set a record, placing 644 children in forever homes.

Last fiscal year, we placed one child in a forever home in Quesnel. This year – 7.

That may not seem like much. But ask those seven kids who, for the first time, know where they will be spending their next birthday.

CONCLUSION

We're going to continue on the path we've set out.

Because we believe in it.

We believe in growing the middle class, not making poverty a little easier.

We believe in investing in people.

We believe in protecting our resource industry, not trying to shut it down.

We believe the best way to ensure a better life for British Columbians is a bigger economy, not a bigger government.

We believe that to create jobs we need to have the ambition to get to yes.

The results are good so far. But we can't lose our focus.

We have a unique opportunity here. To write a new Canadian story.

A Canada led from BC.

- Closures due to facility condition or extreme enrolment decline are not included.

While the ongoing Rural Education Enhancement Fund will help keep schools open starting this coming school year, the Premier also tasked newly-appointed Parliamentary Secretary for Rural Education, Linda Larson, and Parliamentary Secretary for Rural Development, Donna Barnett to conduct a full study of rural education funding in the province to seek a long term solution.

The Rural Education Strategy will look at rural school district budgets and the role education and schools play in communities outside the Lower Mainland, Greater Victoria, and Kelowna. The strategy will aim to find solutions for the unique challenges facing rural school districts while recognizing the economic impact of single schools in small communities. Details of the review will be announced in the near future.

"For students, families, and rural areas, the local school is the centre of the community and the local economy. In my time as minister I've seen that our education funding model doesn't take all the unique rural factors into account," Bernier said. "My Ministry will work with the Parliamentary Secretaries to take a hard look at how we can make sure the unique community and economic role of rural schools is supported in how we fund school districts."
