Dear Yali,

Hope you are doing well. We look forward to welcoming Party Secretary HU to BC in 6 days. I am attaching the latest itinerary for you. It provides further updates on BC officials that have been confirmed to attend various events.

In communications between our Ministry of International Trade and DOFCOM, we remain concerned regarding the expectations for the rollout of various elements in the program\itinerary. Up to this point we have designed the itinerary, in close cooperation with Guangdong FAO, to ensure things will flow smoothly for the Party Secretary in what will be a very busy program. It would be appreciated if GD FAO could follow-up with DOFCOM to confirm the following:

May 8th Welcome Dinner

1. **Business participants:** List of 59 business participants to the dinner. We still have not received any names.

Colleagues of DOFCOM said they would be able to work out the list of 59 business participants by the evening today.

May 9th Forum:

2. **VIP Meeting:** We have expressed several time our concerns with having a "white house/diplomatic" format sit-down with over 20 participants at 0915 hrs, s.16
s.16 There will not be enough time for this format (only 10 minutes available). Our preference is to have the meeting on the 3rd floor, in the corridor; as per our call with you and DOFCOM on April 20th. Participants would be waiting in the corridor and would be introduced by each party as they exit the bilateral room and make their way to the forum.

The DOFCOM proposed that the meeting after the bi-lateral take place in a reserved room on Level 2, which is on the same floor as the conference. The participants will not be sitting down, and there will only be handshakes and brief talks. Please let us know if this is acceptable to you.

3. **Corporate signings:** We have voiced our concerns and explained on several occasions to DOFCOM that our Premier would not be able to witness signings involving other provinces. DOFCOM is insistent that the BC signings take place last and the our Premier witness the full group of signings. Furthermore, the proposed scenario from DOFCOM is different than what we have discussed and reflected in the itinerary. We believe it will be problematic doing the signings on stage with 3 groups rotating. This would require the banquet team from the convention Hall to move 10 tables from the corridor to the stage at the end of the opening ceremonies and would take approximately 25-30 minutes (confirmed during our last advance on site, Deputy Consul General Fan was present).

This is a complex issue on which there has been obvious disagreement for a while. I have relayed your message to DOFCOM, and they are still insistent that the signing take place with 4 groups in rotation (They said it will take less than 10 minutes to move the tables to the stage). The ideal senario from the perspective of Guangdong is that Premier Clark will stay on the stage with Party Secretary Hu to witness all the signings from the very begining through to the end. But now we understand it is very unlikely to happen. The alternative proposal from DOFCOM is that signings of non-BC provinces will take place first. Premier Clark will not come onto the stage to witness this part. When the BC signings begin, Premier Clark will join the Party Secretary to witness. The business conference will be one of the most high-profile events in Party Secretary Hu's visit to Canada, and also one of the most significant highlights in the BC-GD relationship. We are very keen to have Premier Clark's presence on this momentous occasion shared by BC and GD

4. **Workshops:** we have repeatedly asked for workshops participant lists and have received very little information to date.

So far as I know, DOFCOM has not the complete participant lists yet. I'm afraid we have to keep pushing for that.

Dear Yali,

Thank you for your email below. We appreciate the information regarding the participants for each event. Please find attached a copy of the latest itinerary (version 2.4), which reflects the latest information on BC participants. You will note that many still need to be confirmed and we will provide that as soon as possible. The following are items to which we would appreciate your reply.

1. Attached is a copy of the latest joint news release\statement. It would be appreciated if this could be translated into simplified Chinese by Guangdong and returned to us.
2. May 8th - Dinner: We had previously discussed having 3 head tables of 10 to accommodate up to 30 people. There is now discussion to possibly have one large head table, so that the 11 most senior officials from Guangdong\China side may sit at the same table. We would match with 11 from BC side for a total of 22 people.
3. May 9th - Economic and Trade Cooperation Conference: We understand there have been discussion between MIT and Consulate General/GDOC and how best to have all the business-to-business signings happen, which could number up to 30. Our suggestion is that all signings happen at their respective tables and then the representatives come up to the stage, one at a time, to have their photo taken with Party Secretary HU and the Premier. Further details are provided in the itinerary.
4. Canada Government Presence: In addition to Consul General Racheal Bedlington, we are extending an invitation to Ms. Pam Goldsmith-Jones, Parliamentary Secretary to the Minister of Foreign Affairs. We hope to hear soon from her office regarding her involvement.

Thank you for your email and update. We appreciate that many people are involved in this high-level visit and the many discussions are taking place to ensure a successful trip for Party Secretary HU to British Columbia.

We would like to propose that a telephone conference call take place Wednesday, April 20th (Pacific Standard Time) where our office, our Ministry of International Trade, Guangdong FAO, Guangdong DOC and the Consulate General of China can participate to review the itinerary and discuss outstanding issues. We would schedule the call for late in our day, but early Thursday morning for you.

In the interim, please find attached the latest version of the itinerary based upon information provided by your office and discussions that have taken place on our end. We would greatly appreciate receiving further information on the following:

May 8th

Y/ Room# at the Pan Pacific for the meeting with Chinese Community in Vancouver. If possible, a list of the community members that will participate.

Y/ Can you confirm that Party Secretary HU will come directly from Harbour Tour to the official Dinner? Will he require a room to freshen up, prior to the dinner?

May 9th

Y/ Bi-lateral meeting. Can you confirm which Guangdong\Chinese officials would participate in the Bi-lateral meeting?

Y/ Given the limited time, we are proposing that the 0915 meeting with senior officials and business leaders take place on the 3rd level foyer, just outside the location of the bi-lateral meeting. And then Party Secretary HU would continue to the Trade Cooperation Conference.

- Y/ Visit to Ballard Power. Can you advise which Guangdong officials would participate in the visit to Ballard? We are also concerned that the 30 minute travel time will be extremely tight to travel from downtown Vancouver to Ballard Power.
- Y/ Visit to UBC. Can you advise which Guangdong officials would participate in the visit to UBC? We are very concerned regarding the travel time allocated to travel from Ballard to UBC. We believe it will be closer to 45 minutes given traffic. We are currently working with UBC to determine the proposed program for the 30 minute visit.
- Y/ Private lunch and Private time. It would be our recommendation that the Party Secretary consider travelling straight from UBC to the Airport as returning to the Westin Bayshore hotel will be backtracking and he will have very little time at the hotel before needing to depart for the airport.
