BC Housing will evaluate project proposals submitted by local governments, non-profit societies and other potential partners.

Projects will be selected based on their ability to provide affordable housing and their readiness to proceed.

Are there limits to funding per project or community?

No, the amount of funding invested into projects will be determined on a project specific basis.

Who will operate these projects once they are completed?

The projects will be owned and operated by non-profit societies.

Will BC Housing provide ongoing operating costs to these projects?

Operating and support subsidies from BC Housing will not be provided. The projects must be self-sufficient where tenant revenues and/or other revenue sources are sufficient to fully fund the project's operating costs.

Where projects involve supports or services to residents, additional funding from other programs and/or commitments from other funders will be necessary to ensure projects are viable.

Can non-profit housing providers access this funding?

Private sector developers are encouraged to partner with non-profit societies.

All units funded must be affordable rental units and may be located within a larger development.

Will the Province work with municipalities to avoid delays in development approval processes?

Yes, local governments have a key role to play in supporting this initiative and strong two way partnerships with local governments will be required to deliver these units in a timely way.

Projects will be selected based on their ability to provide affordable housing and their readiness to proceed.

Are there limits to funding per project or community?

No, the amount of funding invested into projects will be determined on a project specific basis.

Who will operate these projects once they are completed?

The projects will be owned and operated by non-profit societies.

Will BC Housing provide ongoing operating costs to these projects?

Operating and support subsidies from BC Housing will not be provided. The projects must be self-sufficient where tenant revenues and/or other revenue sources are sufficient to fully fund the project's operating costs.

Where projects involve supports or services to residents, additional funding from other programs and/or commitments from other funders will be necessary to ensure projects are viable.

Can non-profit housing providers access this funding?

Yes, BC Housing will partner with non-profit societies who will own and operate the new affordable rental housing projects.

Can private sector developers apply for funding – what percentage of units in a building will need to be allocated to affordable rental units?

Private sector developers are encouraged to partner with non-profit societies.

All units funded must be affordable rental units and may be located within a larger development.

Will the Province work with municipalities to avoid delays in development approval processes?

Yes, local governments have a key role to play in supporting this initiative and strong two way partnerships with local governments will be required to deliver these units in a timely way.

When will you be announcing projects from the \$355 million you announced in February?

Successful proponents for the first round of funding from the \$355 million program are expected to be announced in October 2016.

B.C. makes largest housing investment ever in Province's history

BURNABY – The Government of B.C. is committing \$500 million to ensure more British Columbian families have access to affordable rental housing, the largest housing investment in a single year by any province in Canada.

A total of 2,900 rental units will be created, in partnership with non-profit societies, local governments, government agencies, community organizations and the private sector.

This is in addition to \$355 million announced earlier this year in February to create 2,000 additional new units of affordable rental housing throughout B.C., bringing the Province's total investment announced this year to \$855 million.

"This is another significant step towards helping more people find an affordable place to live," said Premier Christy Clark. "Thanks to our growing, diverse economy, we're able to make the largest affordable housing investment in one year by any province in Canadian history, and we will continue to work with community partners and all levels of government to keep putting British Columbians first."

A mix of new housing will be developed to meet the needs of a wide variety of people in communities across the province, including low-to moderate-income renters, seniors, youth, students, adults with developmental disabilities, Aboriginal people and women and children.

Funding for these projects will be provided from the government's newly-created Housing Priority Initiatives Special Account, and projects will include a combination of acquisition of existing units from the private market as well as new construction.

"We are taking meaningful steps to address housing affordability challenges in B.C.," said Rich Coleman, Minister of Natural Gas Development and Responsible for Housing. "The purchase of existing units from the private market helps provide an immediate housing solution while the construction of new housing will ensure that the developments are predesigned to meet the specific needs of individuals and families."

Funding allocations will be determined on a project specific basis. The Province has already identified several projects and announcements will be made upon approval in the coming months. All projects will be identified and approved by March 2017. Newly constructed housing will be completed over the next 24 to 36 months.

Today's announcement builds on the other housing affordability actions recently taken by the Province, including:

- Implementing a 15% additional property transfer tax that applies to foreign purchasers of residential real estate in Metro Vancouver;
- Strengthening consumer protection in B.C.'s real estate market through increased oversight and accountability of real estate licensees;
- Introducing a new luxury tax on properties that sell for more than \$2 million; and
- Introducing a Newly Built Homes exemption, which has helped nearly 5,500 families save an average of \$7,600 on their newly built homes.

The Province will continue to work on additional measures in the coming months to address housing affordability and supply challenges. These actions will align with our 6 Principles of Housing Affordability:

- 1. Ensuring the dream of home ownership remains within the reach of the middle class
- 2. Increasing housing supply
- 3. Smart transit expansion
- 4. Supporting first-time home buyers
- 5. Ensuring consumer protection
- 6. Increasing rental supply

"Thanks to our growing, diverse economy, we're able to make the largest affordable housing investment in one year by any province in Canadian history, and we will continue to work with community partners and all levels of government to keep putting British Columbians first."

A mix of new housing will be developed to meet the needs of a wide variety of people in communities across the province, including low-to moderate-income renters, seniors, youth, students, adults with developmental disabilities, Aboriginal people and women and children.

Funding for these projects will be provided from the government's newly-created Housing Priority Initiatives Special Account, and projects will include a combination of acquisition of existing units from the private market as well as new construction.

"We are taking meaningful steps to address housing affordability challenges in B.C.," said Rich Coleman, Minister of Natural Gas Development and Responsible for Housing. "The purchase of existing units from the private market helps provide an immediate housing solution while the construction of new housing will ensure that the developments are predesigned to meet the specific needs of individuals and families."

Funding allocations will be determined on a project specific basis. The Province has already identified several projects and announcements will be made upon approval in the coming months. All projects will be identified and approved by March 2017. Newly constructed housing will be completed over the next 24 to 36 months.

Today's announcement builds on the other housing affordability actions recently taken by the Province, including:

- Implementing a 15% additional property transfer tax that applies to foreign purchasers of residential real estate in Metro Vancouver;
- Strengthening consumer protection in B.C.'s real estate market through increased oversight and accountability of real estate licensees;
- Introducing a new luxury tax on properties that sell for more than \$2 million; and
- Introducing a Newly Built Homes exemption, which has helped nearly 5,500 families save an average of \$7,600 on their newly built homes.

The Province will continue to work on additional measures in the coming months to address housing affordability and supply challenges. These actions will align with our 6 Principles of Housing Affordability:

- 1. Ensuring the dream of home ownership remains within the reach of the middle class
- 2. Increasing housing supply
- 3. Smart transit expansion
- 4. Supporting first-time home buyers
- 5. Ensuring consumer protection
- 6. Increasing rental supply

What are you announcing?

2,900 new units of affordable rental housing will be created across the province.

Projects will include a combination of acquisition and new construction.

Is the \$500 million all new money? Is it being spent this year - how does it breakdown?

Yes, this is new money which is being funded from the Housing Priority Initiatives Special Account.

Of the \$500 million, \$300 million will be provided this fiscal year as capital grants into affordable rental housing across the province.

\$200 million will be used to meet BC Housing's construction financing requirement for the projects funded through this initiative.

How is this the largest housing investment in Canada? Didn't Quebec and Ontario make bigger announcements (Quebec \$1.2B / Ontario \$800M)?

Investments announced by Quebec and Ontario are being made over several years.

When will the projects be announced?

We have already identified several projects and announcements will be made upon approval in the coming months. All projects will be identified and approved by March 2017.

When will the new housing be ready?

Newly constructed housing will be completed over the next 24 – 36 months.

Properties we acquire from the private market will be ready as soon they can be made available for occupancy – this will depend on the condition of each building.

Where will the projects be located?

Projects will be distributed across the province and will be selected based on readiness to proceed and ability to provide affordable housing.

What types of projects are expected to be funded?

A mix of new housing will be developed to meet the needs of a wide variety of people, including:

- Low-to moderate-income renters
- Youth aging out of care
- Students
- Adults with developmental disabilities
- Seniors
- · Aboriginal people
- Women and children

Will the funding be based on population -- will Vancouver get more funding and units due to its population base?

No, the funding is not proportional based. Projects will be distributed across the province, and projects will be selected based on readiness to proceed and ability to provide affordable housing.

How will people apply for the new housing?

Individuals will be able to apply via BC Housing and will be assessed against eligibility requirements for various social housing programs.

How much will rent be?

Rents will be set below the CMHC average rents for the community where the housing is located.

How will the projects be selected? Is there specific criteria?

BC Housing will evaluate project proposals submitted by local governments, non-profit societies and other potential partners.

Projects will be selected based on their ability to provide affordable housing and their readiness to proceed.

Are there limits to funding per project or community?

No, the amount of funding invested into projects will be determined on a project specific basis.

Who will operate these projects once they are completed?

The projects will be owned and operated by non-profit societies.

Will BC Housing provide ongoing operating costs to these projects?

Operating and support subsidies from BC Housing will not be provided. The projects must be self-sufficient where tenant revenues and/or other revenue sources are sufficient to fully fund the project's operating costs.

Where projects involve supports or services to residents, additional funding from other programs and/or commitments from other funders will be necessary to ensure projects are viable.

Can non-profit housing providers access this funding?

Yes, BC Housing will partner with non-profit societies who will own and operate the new affordable rental housing projects.

Can private sector developers apply for funding – what percentage of units in a building will need to be allocated to affordable rental units?

Private sector developers are encouraged to partner with non-profit societies.

All units funded must be affordable rental units and may be located within a larger development.

Will the Province work with municipalities to avoid delays in development approval processes?

Yes, local governments have a key role to play in supporting this initiative and strong two way partnerships with local governments will be required to deliver these units in a timely way.

- What the Province can do is work with local governments to develop affordable housing.
- We can do that in cases where we have local governments that are willing to work with us to be part of the solution.
- That approach is working well in Vancouver, Langley, Nanaimo and other jurisdictions, where municipalities have stepped up with land so we can work together on affordable housing.
- In the case of Burnaby, the Province has been at the table ready to develop affordable housing there for a long time.
- BC's Residential Tenancy Act requires landlords to follow specific rules before issuing a notice to end tenancy for demolition of the rental unit.
- Landlords must have all the necessary municipal permits and approvals in place before they can issue a notice to tenants.
- When undertaking demolition of a rental unit, landlords must:
 - Have necessary permits before issuing a notice to end tenancy;
 - Give two months' notice; and
 - o Compensate the tenant with an extra payment of one month's rent.
- Municipalities control zoning and bylaws, and in the past have asked that developers provide replacement of rental units prior to granting zoning approval for new projects.
